Their creators have reserved their thrones in Hell; sadly, however, their creations will ultimately fade into oblivion.

Most repugnant amongst these mortal coins is that named Jesus coin; this abomination intends to spread the word of God and His mortal son. It is a plague of a creation that claims to absolve humans of their sins and save them from Hell. This is false. Once Satan has decided one's place in Hell, His influence is unbreakable. In addition, Satan welcomes all, regardless of faith or status, granted that they are vile of heart and wicked in nature.



# LEDGER FOR YOUR SINS

Forged in the fires of Hell, Satan Coin is the answer to the shortcomings of these other mortal currencies. To those who stand besides Him and offer their souls willingly in exchange for Satan Coin, Satan shall reward them with power and prestige in Hell.

## ERC-20 TOKEN STANDARD

Following the ERC-20 token standard on the Ethereum network, Satan has crafted this smart contract in exchange for the souls of wrongdoers and asinine sheep. Each transaction will be recorded in the blockchain, and so, every sin henceforth will be publicly documented for all of eternity.

## HIGHLY LIMITED SUPPLY

In accordance with the Mark of the Beast, a highly limited supply of exactly 666 Satan Coins shall be forged, and the value of each shall be exactly 0.0666 Ether. Each and every coin is indivisible, and each and every coin shall cause infinite pain and suffering – except to those that acquire the coins voluntarily.



## NINE CIRCLES OF FUNDING

As there are nine circles of Hell, there will be nine tiers of funding. Each of these circles of funding will last exactly six days. The 666 available tokens will be divided equally per round; 74 Satan Coins will be available in each circle of funding.

The circles will be named as follows: Limbo, Lust, Gluttony, Greed, Wrath, Heresy, Violence, Fraud, and Treachery. The first circle of funding will begin on October 31, 2017 – Halloween – and the last circle of funding will end on December 24, 2017 – in preparation for a Satanic Christmas.

## LOTTERY SYSTEM

For mere mortal coins, unsold coins are burned to maintain the value of the crowdfunded tokens. Satan Coin does not follow this practice. Since Satan Coins are perpetually scorching in the pyres of Hell, unallocated Satan Coins will be raffled to the greediest of buyers.

For each circle of funding, each Satan Coin will be marked with a number from 1 to 74. At the final instant of funding, a random number will be generated from 1 to the highest number of token purchased in that circle. The buyer with the corresponding token will receive the remainder of that circle's tokens.



Because of this, greedy buyers may increase their chances of winning more Satan Coins by purchasing larger quantities during each round.

## USES

The primary function of Satan Coin is for use in devious and sinister acts, and in exchange for cursed products and goods. Furthermore, those who purchase Satan Coin deliberately shall thrive in Hell as kings, while they watch other peasants suffer in eternal agony.

## ETERNAL DAMNATION

For fools that make the mistake of turning their backs on the Lord of the Underworld and His token, or even worse – pledge their allegiance to a cruel and deluded god by purchasing Jesus Coin, Satan Coin holders will damn them by sending off their excess coins as curses. In preparation of this, the final date of funding will occur on Christmas Eve, so that disciples of the Devil may damn their enemies the following day with cursed presents in the form of Satan Coins.

## UNIMAGINABLE MISFORTUNE

To the few intellectuals that exist on Earth, they understand that every currency ever crafted has no true intrinsic value. Satan Coin is no different from these other currencies.
