Family Membership is defined as:

1. A husband and/or wife and/or domestic partner, and all children residing in the same household who are under the age of twenty-six (26) and fully dependent on the head of household for their support and maintenance;
2. Unmarried family members who are serving in the Armed Forces of the United States;
3. Parents of either or both the husband and/or wife who reside with and are dependent for support, upon either the husband and/or wife; and
4. A Fresh Air Fund child or other charitable ward residing with the family.
5. Unmarried family members over the age of twenty-six (26) years who are considered helpless in that they are unable to pursue gainful employment sufficient to allow them to support themselves and who therefore remain fully dependent on the head of the household for their support and maintenance.

Family Membership does not include:

1. Siblings, cousins, or nieces and nephews of the adult members, regardless of residency;
2. Visiting relatives, regardless of length of stay;
3. A divorced spouse; or
4. For convenience, any of the above can be added to a family membership as a "babysitter" for the posted fee.

Non-Madison Resident Member have the same levels of membership set forth above (Family, Individual and Senior) with the same definitions, except as regarding residency; however, Non-Madison Resident memberships will be limited as follows:

1. Membership fees for non-Madison members will be at a premium, higher than fees charged to Madison residents, as determined by the Board of Trustees from year to year;
2. Non-Madison Resident membership shall be open to all non-residents on a first come-first served basis;
3. Previous year's memberships shall automatically renew if payment is received by April 15th of the current year. If payment is not received by April 15th, the membership application shall be handled on a first-come first-served basis with first time applicants; Non-Madison Resident members shall carry with them no voting rights in the Corporation;
4. Non-Madison Resident members shall have the rights of membership and shall be subject to the Rules and Regulations of the Corporation;
5. Non-Madison Individual Memberships are not allowed to bring other household members as their guests.

Care Providers/Babysitters can be added to a family membership subject to the following:

1. A babysitter (employee of the family, nanny, au pair, etc.) must be fifteen (15) years of age or older, and have as their primary duty the care and supervision of dependent children who are part of a family membership;
2. Babysitters may use the pool only when accompanying the children they supervise and not for their own use;
3. If a babysitter 18 or older is asked by an adult family member to take playmates of the children he/she is supervising to the pool, he/she may sign in those playmates as guests;
4. A signed permission form must be submitted with payment.

*Teen is defined as an individual 13 to 17 years old

*Individual Membership is defined as any person over the age of eighteen (18).
