Day Hagan Asset Management is a registered investment adviser. Registration with the United States Securities and Exchange Commission or any state securities authority does not imply a certain level of skill or training.

Item 2 Summary of Material Changes

Form ADV Part 2 requires registered investment advisers to amend their brochure when information becomes materially inaccurate. If there are any material changes to an adviser's disclosure brochure, the adviser is required to notify you and provide you with a description of the material changes.

Since our last Annual Updating Amendment dated February 16, 2016 we have made the following material changes:

We amended Item 5 and 10 to remove the language that disclosed that some persons providing investment advice on behalf of our firm were registered representatives with Harbor Financial Services, LLC, a securities broker-dealer, and a member of the Financial Industry Regulatory Authority and the Securities Investor Protection Corporation.

Additionally, we removed the language in Item 5 that disclosed that we may recommend that you purchase variable annuities. We do not presently recommend any variable annuities.

We also added a disclosure in Item 5 to note that Raymond James charges an additional fee for accounts in their Ambassador Program. That fee is in lieu of transaction charges per trade. For all accounts we have in the Raymond James Ambassador Program, Raymond James pays us a management fee rebate. This presents a conflict of interest in that we have a financial incentive to recommend the Ambassador Program to you. We conduct periodic testing of the accounts in the Ambassador program to ensure the appropriateness of the Program for clients at their current account asset level.

We also added a disclosure in Item 8 disclosing the risks of investing in stocks noting that, in very broad terms, the value of a stock depends on the financial health of the company issuing it. However, stock prices can be affected by many other factors including, but not limited to the class of stock (for example, preferred or common); the health of the market sector of the issuing company; and, the overall health of the economy. In general, larger, better established companies ("large cap") tend to be safer than smaller start-up companies ("small cap") are but the mere size of an issuer is not, by itself, an indicator of the safety of the investment.

We amended Item 10 to disclose that we employ an individual to act as a wholesaler to sell our mutual funds and oversee the outside wholesalers. The outside wholesalers are licensed with a broker-dealer and are not Day Hagan employees. The wholesaler we employ is dually registered as a registered representative with Northern Lights Distributors (NLD), which is also the distributor for our mutual funds. As an employee of Day Hagan, the inside wholesaler is subject to our supervision. NLD is not responsible for his supervision.

The Day Hagan Tactical Allocation Fund of ETFs is now known as the Day Hagan Tactical Allocation Fund and we have added a third mutual fund, the Day Hagan Hedged Strategy Fund whose primary objective is to achieve capital appreciation with low correlation to equity markets. The Hedged Strategy Fund seeks to achieve its investment objectives by buying and selling call and put options on the S&P 500 Index with expiration targets two years or less. The Index is an unmanaged index of 500 stocks that is market-capitalization weighted and is generally representative of the performance of larger companies in the U.S. The Fund may also buy and sell call and put options on other indexes.

Subsequent to our Annual Updating Amendment on March 15, 2017, we made the following additional changes:

We amended Item 8 by adding more specific descriptions of the following strategies used in managing separately managed accounts: (i) Day Hagan Global Tactical Allocation Investment Strategy; (ii) Day Hagan Put-Write Investment Strategy; (iii) Day Hagan Sector Rotation Investment Strategy; (v) Day Hagan Small-Cap Investment Strategy; and (vi) Day Hagan Logix Tactical Dividend Investment Strategy. We further amended Item 8 by consolidating and reordering risk factors clients should consider with respect to our investment strategies.

We amended Item 10 by adding a disclosure related to the creation of DH Logix, LLC dba Day Hagan Logix ("DH Logix"), a registered investment adviser that we have jointly formed and manage with Gries Financial LLC ("Gries Financial"). In addition, we have added disclosures concerning the conflicts of interests that may arise due to our affiliations with DH Logix and how we plan to manage those conflicts of interest in fulfilling our fiduciary duty to act in the best interest our clients.

Item 4 Advisory Business

We are a registered investment adviser based in Sarasota, Florida. Donald L. Hagan, LLC, organized under the laws of the State of Florida and doing business as Day Hagan Asset Management, has been providing investment advisory services since 2004. Donald L. Hagan and Arthur S. Day are our principal owners. Linda Brown is a minority owner. Currently, we offer the following investment advisory services:

- Portfolio Management Services
- Financial Planning/Consulting Services
- Selection of Third Party Advisers
- Sub-Advisory Services
- Pension Consulting Services
- Adviser to Mutual Funds

The following paragraphs describe our services and fees. Please refer to the description of each investment advisory service listed below for more information. As used in this brochure, the words "we", "our" and "us" refer to Day Hagan Asset Management and the words "you", "your" and "client" refer to you as either a client or prospective client of our firm. Also, you may see the term Associated Person throughout this Brochure. As used in this Brochure, our Associated Persons are our firm's officers, employees, and all individuals providing investment advice on behalf of our firm.

Portfolio Management Services

We offer discretionary and non-discretionary portfolio management services. Our investment advice is tailored to meet our clients' needs and investment objectives. If you retain our firm for portfolio management services, we will meet with you to determine your investment objectives, risk tolerance, and other relevant information at the beginning of our advisory relationship. We will use the information we gather to develop a strategy that enables our firm to give you continuous and focused investment advice and/or to make investments on your behalf. As part of our portfolio management services, we will customize an investment portfolio for you according to your risk tolerance and investing objectives. We may also invest your assets using a predefined strategy, or we may invest your assets according to one or more model portfolios developed by our firm. Once we construct an investment portfolio for you, or select a model portfolio, we will monitor your portfolio's performance on an ongoing basis, and will rebalance the portfolio as required by changes in market conditions and in your financial circumstances.

If you participate in our discretionary portfolio management services, we require you to grant our firm discretionary authority to manage your account. Discretionary authorization will allow us to determine the specific securities, and the amount of securities, to be purchased or sold for your account without your approval prior to each transaction. Discretionary authority is typically granted by the investment advisory agreement you sign with our firm and the appropriate trading authorization forms. You may limit our discretionary authority (for example, limiting the types of securities that can be purchased or sold for your account) by providing our firm with your restrictions and guidelines in writing. If you enter into non-discretionary arrangements with our firm, we must obtain your approval prior to executing any transactions on behalf of your account.

As part of our portfolio management services, we may use one or more sub-advisers to manage a portion of your account on a discretionary basis. Depending on the arrangements made with the sub-adviser, we may either use the sub-adviser's recommendations, in whole or in part, to manage a portion of your portfolio, with the trades being placed by Day Hagan personnel or the sub-adviser(s) may use one or more of their model portfolios to manage your account and place the trades

themselves. We will regularly monitor the performance of your accounts managed by sub-adviser(s) and may hire and fire any sub-adviser without your prior approval. We may pay a portion of our advisory fee to the sub-adviser(s) we use. (See the *Fees and Compensation* section below for more information).

Financial Planning/Consulting Services

We offer financial planning and/or consulting services which typically involve providing a variety of advisory services to clients regarding the management of their financial resources based upon an analysis of their individual needs. These services can range from broad, comprehensive, financial planning to consultative or single subject planning. The process typically begins with an initial consultation during which the various services provided by us are explained to you. If you wish to retain our services, we will enter into a financial planning/consulting agreement with you. You may elect to have us prepare a financial plan for a set fee and then manage your assets under one of the asset management programs described below. Alternatively, you may decide to engage us for financial planning/consulting services for a set fee and refrain from making a decision as to management services until a future time.

During or after the initial consultation, if you decide to engage us, we will collect pertinent information about your personal and financial circumstances and objectives. Priorities are established, and dialog between you and an Associated Person of our firm will take place in order to assess your financial position and objectives. As required, we will conduct follow-up interviews with you for the purpose of reviewing and/or collecting financial data. Once such information has been studied and analyzed, a written financial plan designed to achieve your expressed financial goals and objectives is produced and presented to you.

Some of our clients may only require advice on a single aspect of the management of their financial resources. For these clients, we offer financial plans and/or general consulting services in a format that addresses only those specific areas of interest or concern, depending on each client's unique circumstances.

Selection of Third Party Advisers

As part of the services we offer we can, based on your needs, recommend that you utilize the services of a Third Party Money Manager ("MM") to manage a portion of, or your entire, portfolio. All MMs that we recommend must be registered as investment advisers with either the Securities and Exchange Commission or with the appropriate state authority(ies). The programs that are available to you can include wrap fee programs sponsored by a MM. For a portion of our client base we utilize the Raymond James Ambassador Program through Raymond James Financial ("Raymond James"). Raymond James charges an additional fee for accounts in their Ambassador Program. That fee is in lieu of transaction charges per trade.

After gathering information about your financial situation and objectives, an Associated Person of our firm will make recommendations regarding the suitability of a MM or investment style based on, but not limited to, your financial needs, investment goals, tolerance for risk, and investment objectives. Upon selection of one or more MM(s), we will monitor the performance of the MM(s). The MM(s) will actively manage your portfolio and will assume discretionary investment authority over your account. We will assume discretionary authority to hire and fire MM(s) and/or reallocate your assets to other MM(s) where we deem such action appropriate.

Sub-Advisory Services

We offer sub-advisory services to unaffiliated third parties such as other advisers, financial firms, and investment managers (the "Primary Investment Adviser"). As part of these services, we may provide model portfolios, which the Primary Investment Adviser may utilize for its clients. We may directly place the trades for the Primary Investment Adviser's individual client accounts. The Primary Investment Adviser will be responsible for selecting the appropriate model for its clients.

Pension Consulting Services

We offer pension consulting services to employee benefit plans and their fiduciaries based upon the needs of the plan and the services requested by the plan sponsor or named fiduciary. In general, these services may include an existing plan review and analysis, plan-level advice regarding fund selection and investment options, education services to plan participants, investment performance monitoring, and/or ongoing consulting. These pension consulting services will generally be non-discretionary and advisory in nature. The ultimate decision to act on behalf of the plan shall remain with the plan sponsor or other named fiduciary.

We may also assist with participant enrollment meetings and provide investment-related educational seminars to plan participants on such topics as:

- Diversification
- Asset allocation
- Risk tolerance
- Time horizon

Our educational seminars may include other investment-related topics specific to the particular plan.

We may also provide additional types of pension consulting services to plans on an individually negotiated basis. All services, whether discussed above or customized for the plan based upon requirements from the plan fiduciaries (which may include additional plan-level or participant-level services) shall be detailed in a written agreement and be consistent with the parameters set forth in the plan documents.

Adviser to Mutual Funds

Our firm serves as the investment adviser to the Day Hagan Tactical Allocation Fund (the "Allocation Fund"), The Day Hagan Tactical Dividend Fund (the "Dividend Fund") and the Day Hagan Hedged Strategy Fund ("Hedged Strategy Fund"). Collectively these will be referred to as the "Mutual Funds". These Mutual Funds are a series of the Mutual Fund Series Trust ("Trust"), a registered investment company.

- The Allocation Fund's primary objective is to achieve long-term capital appreciation with current income as a secondary objective. The Allocation Fund seeks to achieve its investment objectives by investing in a portfolio of exchange traded funds ("ETFs") selected using our proprietary quantitative asset allocation models.
- The Dividend Fund's primary objective is to achieve long-term capital appreciation with current income as a secondary objective. The Dividend Fund seeks to achieve its investment objectives by investing in a portfolio of individual securities.
- The Hedged Strategy Fund's primary objective is to achieve capital appreciation with low correlation to equity markets. The Hedged Strategy Fund seeks to achieve its investment objectives by buying and selling call and put options on the S&P 500 Index with expiration targets two years or less. The Index is an unmanaged index of 500 stocks that is market-capitalization weighted and is generally representative of the performance of larger companies in the U.S. The Hedged Strategy Fund may also buy and sell call and put options on other

indexes.

We have entered into sub-advisory agreements pursuant to which Gries Financial serves as sub-adviser to the Dividend Fund and Pacini Hatfield Investments, LLC ("Pacini Hatfield") serves as sub-adviser to the Hedged Strategy Fund (each a "Sub-Adviser" and, collectively, the "Sub-Advisers"), in each case subject to our oversight.

We may recommend that you invest in these Mutual Funds. The compensation arrangements we have with these Mutual Funds present a conflict of interest because we may have a financial incentive to recommend that you invest in these Mutual Funds. While we believe that the compensation arrangements that we have with these Mutual Funds is competitive, such compensation may be higher than the compensation charged by other firms providing the same or similar services. You are under no obligation to purchase shares in any of these Mutual Funds.

Types of Investments

We primarily offer advice on mutual funds, ETFs and individual equities. Additionally, we may advise you on any type of investment that we deem appropriate. We may also provide advice on any type of investments held in your portfolio at the inception of our advisory relationship.

You may request that we refrain from investing in particular securities or certain types of securities. You must provide these restrictions to our firm in writing.

Assets Under Management

As of December 31, 2016, we provide continuous management services for \$369,608,000 in client assets on a discretionary basis, and \$2,207,564 in client assets on a non-discretionary basis.

Item 5 Fees and Compensation

Portfolio Management Services

The annual fee for portfolio management services is billed quarterly in advance based on the value of assets on the last day of the previous quarter. Fees will be assessed pro rata in the event the portfolio management agreement is executed at any time other than the first day of a calendar quarter. Our fee is based on a percentage of your assets under management and is negotiable. The annualized fee for portfolio management services ranges from 0.25% to 2.75% of assets under management and is based on the size, asset composition and complexity of your account as well as whether we use a sub-adviser. In recognition of the fact that we share our fee with sub-advisers when they are utilized, you will generally pay a higher fee when we use a sub-adviser. The fees and terms will be clearly set forth in the executed agreement for services.

Payment of our management fees will be made by the qualified custodian holding your funds and securities provided that you supply written authorization permitting the fees to be paid directly from your account. Our firm will not have access to your funds for payment of fees without your written consent. Further, the qualified custodian agrees to deliver a monthly (or at least a quarterly) account statement directly to you, showing all disbursements from your account. You are encouraged to review all account statements for accuracy. Our firm will receive an electronic duplicate copy of the statement that was delivered to you by your custodian.

Either party may terminate the portfolio management agreement by providing written or verbal notice to the other party.

The fees charged are calculated as described above, and are not charged on the basis of a share of capital gains upon, or capital appreciation of, the funds, or any portion of the funds of an advisory client (15 U.S.C. §80b-5(a)(1)).

Financial Planning/Consulting Services

For those clients wishing to engage us for financial planning services, fees will be based on the negotiable schedules set forth below and as agreed upon between the you and our firm.

- **Fixed Fees:** The fee for financial planning or consulting services ranges between \$500.00 and \$8,000.00 depending on the scope and complexity of the services requested. Fees are due and payable upon completion of the contracted service. Under no circumstances will we require prepayment of a fee more than six months in advance and in excess of \$1,200.00.

Factors that are considered when determining the cost of planning or consulting services, include but are not limited to:

1. the scope of the plan/consulting service. (For example, covering multiple aspects of your financial situation such as business succession, estate planning, retirement needs, education planning, and successor trusts, among others, may warrant a higher fee than a more simplistic plan or consultations that only covers a specific aspect of your financial needs).
 2. the complexity of your financial situation. (For example, trusts, estates, business ownership, tax brackets and other personal needs may warrant a higher fee).
- **Hourly Fees:** For those clients who request specific or very limited consulting related services, our fees start at \$250 an hour and increase depending on the complexity of your financial situation. These fees are calculated and payable at the completion of each session. Specific consulting services may be in the form of general advice given on retirement needs or education planning, among others. In these cases you would not be charged for a written financial plan but instead will only be billed for hourly consultation with an Associated Person of our firm. The hours required for these services will vary from client to client. In limited circumstances, the time/cost could potentially exceed the initial estimate. In such cases, we will notify you and we may request that you pay us an additional fee.

After a consultation has been conducted, the fee will not be refundable. We may, in our sole discretion, waive some or all of the financial planning fees if you choose to engage our firm for asset management services.

Either party may terminate the agreement by providing written or verbal notice to the other party. If you request termination verbally, we will send you a letter of confirmation evidencing the effective termination date of the planning process. Upon such termination, we will refund any unearned fees to you.

Selection of Third Party Advisers

Our firm may share in the fee paid by you to the MM. If you are referred to a MM you will receive full disclosure, including services rendered and fee schedules, at the time of the referral by delivery of a copy of the relevant MM's Form ADV Part 2 or equivalent disclosure document. In addition, if the investment program recommended to you is a wrap fee program, you will also receive an Appendix 1 or equivalent wrap fee brochure provided by the sponsor of the program. Our firm or the MM will provide to you all appropriate disclosure statements, including disclosure of solicitation fees paid to us and our Associated Persons.

Fees paid by you to the MM are established and payable in accordance with the Form ADV Part 2 or other equivalent disclosure document provided by each MM to whom you are referred and these fees may or may not be negotiable. Such compensation may differ depending upon the individual agreement our firm has with each MM. As such, a conflict of interest may arise where our firm or its Associated persons may have an incentive to recommend one MM over another MM with whom it has more favorable compensation arrangements or other advisory programs offered by MMs with which it has less or no compensation arrangements.

Raymond James charges an additional fee for accounts in their Ambassador Program. That fee is in lieu of transaction charges per trade. For all accounts we have in the Raymond James Ambassador Program, Raymond James pays us a management fee rebate. This presents a conflict of interest in that we have a financial incentive to recommend the Ambassador Program to you. We conduct periodic testing of the accounts in the Ambassador program to ensure the appropriateness of the Program for clients at their current account asset level.

You may be required to sign an agreement directly with the MM(s) selected. You, our firm or the MM, in accordance with the provisions of those agreements, may terminate the advisory relationship. If the MM is compensated in advance, you will typically receive a pro rata refund of any prepaid advisory fees upon termination of an advisory agreement.

Pension Consulting Services

Fee-paying arrangements will be determined on a case-by-case basis with each client. Our firm may either be compensated on a basis of assets under management, a fixed fee or a combination of fee arrangements based on the complexity of the plan and the agreement with the client. In any case, we will not have access to Client funds for payment of fees without your written consent. The terms regarding payment of fees, termination and refund will typically be found in the related sections above.

The fees charged are calculated as described above, and are not charged on the basis of a share of capital gains upon, or capital appreciation of, the funds, or any portion of the funds of an advisory client (15 U.S.C. §80b-5(a)(1)).

Either party may terminate the agreement by providing 30 day written notice to the other party.

Adviser to Mutual Funds

The Asset Allocation Fund and Dividend Fund are authorized to pay our firm a fee equal to 1.00%, based on the Mutual Funds' average daily net assets. The Hedged Strategy Fund is authorized to pay our firm a fee equal to 1.75%, based on the average daily net assets. We have contractually agreed to waive fees and/or reimburse expenses but only to the extent necessary to maintain total annual operating expenses (excluding brokerage costs, borrowing costs, such as (a) interest and (b) dividends on securities sold short, taxes, costs of investing in underlying funds, 12b-1 distribution fees and extraordinary expenses) at 1.60%, 2.35%, and 1.35% for Class A, Class C, and Class I, respectively through October 31, 2017 for the Allocation Fund and the Dividend Fund. For the Hedged Strategy Fund, we have agreed to waive fees and/or reimburse expenses but only to the extent necessary to maintain total annual operating expenses (excluding brokerage costs, borrowing costs, such as (a) interest and (b) dividends on securities sold short, taxes, costs of investing in underlying funds, 12b-1 distribution fees and extraordinary expenses) at 2.23%, 2.98%, and 1.98% for Class A, Class C, and Class I, respectively through October 31, 2018. Each waiver or reimbursement by us is subject to repayment by the Funds within the three fiscal years following the fiscal year in which that particular expense is incurred, if the Funds are able to make the repayment without exceeding the expense limitation in effect at the time of the waiver and the repayment is approved by the Board of Trustees. We pay a portion of our management fee received from the Dividend Fund and Hedged Strategy Fund to the Sub-Advisers of those Funds.

We directly compensate non-employee (outside) entities and one employee (inside) (i.e., "wholesalers") for marketing the Day Hagan mutual funds to other registered investment advisers and broker dealers. If you are an investor in our mutual funds, your investment adviser may have been solicited by a wholesaler. If you become an investor in our funds, the wholesaler that referred your investment adviser to our firm will receive compensation as a consequence of your fund purchase. You will not pay additional fees because of this compensation arrangement. The wholesaler has a financial incentive to recommend our mutual funds to your investment adviser. This creates a conflict of interest; however, you are not obligated to invest in our mutual funds.

Additional Fees and Expenses

As part of our investment advisory services to you, we may invest, or recommend that you invest, in mutual funds and exchange traded funds. The fees that you pay to our firm for investment advisory services are separate and distinct from the fees and expenses charged by mutual funds or exchange traded funds (described in each fund's prospectus) to their shareholders. These fees will generally include a management fee and other fund expenses. You will also incur transaction charges and/or brokerage fees when purchasing or selling securities. These charges and fees are typically imposed by the broker-dealer or custodian through which your account transactions are executed. We do not share in any portion of the brokerage fees/transaction charges imposed by the broker-dealer or custodian. To fully understand the total cost you will incur, you should review all fees charged by mutual funds, exchange traded funds, our firm, and others. For information on our brokerage practices, please refer to the *Brokerage Practices* section of this Brochure.

Compensation for the Sale of Securities or Other Investment Products

Some persons providing investment advice on behalf of our firm are licensed as independent insurance agents. These persons will earn commission-based compensation for selling insurance products, including insurance products they sell to you. Insurance commissions earned by these persons are separate and in addition to our advisory fees. This practice presents a conflict of interest because persons providing investment advice on behalf of our firm who are insurance agents have an incentive to recommend insurance products to you for the purpose of generating commissions rather than solely based on your needs. However, you are under no obligation, contractually or otherwise, to purchase insurance products through any person affiliated with our firm.

We employ an individual to act as a wholesaler to sell our mutual funds and oversee the outside wholesalers. The outside wholesalers are licensed with a broker-dealer and are not Day Hagan employees. The wholesaler we employ is dually registered as a registered representative with Foreside Fund Services, LLC (Foreside). As a registered representative of Foreside, the inside wholesaler will be entitled to receive a commission when he sells our mutual funds. This practice presents a conflict of interest because this individual has an incentive to recommend our mutual funds to you for the purpose of generating commissions rather than solely based on your needs. However, you are under no obligation, contractually or otherwise, to purchase mutual funds through any person affiliated with our firm.

Any material conflicts of interest between you and our firm, or our employees are disclosed in this Brochure. If at any time, additional material conflicts of interest develop, we will provide you with written notification of the material conflicts of interest or an updated Brochure.

Item 6 Performance-Based Fees and Side-By-Side Management

We do not accept performance-based fees or participate in side-by-side management. Performance-based fees are fees that are based on a share of capital gains or capital appreciation of a client's account. Side-by-side management refers to the practice of managing accounts that are charged performance-based fees while at the same time managing accounts that are not charged performance-based fees. Our fees are calculated as described in the *Fees and Compensation* section above, and are not charged on the basis of a share of capital gains upon, or capital appreciation of, the funds in your advisory account.

Item 7 Types of Clients

We offer investment advisory services to individuals, investment companies, pension and profit sharing plans, trusts, estates, charitable organizations, corporations, and other business entities.

In general, we require a minimum of \$500,000.00 to open and maintain an advisory account. At our discretion, we may waive this minimum account size. For example, we may waive the minimum if you appear to have significant potential for increasing your assets under our management. We may also combine account values for you and your minor children, joint accounts with your spouse, and other types of related accounts to meet the stated minimum.

Item 8 Methods of Analysis, Investment Strategies and Risk of Loss

We will use one or more of the following methods of analysis or investment strategies when providing investment advice to you:

- **Charting Analysis** - involves the gathering and processing of price and volume information for a particular security. This price and volume information is analyzed using mathematical equations. The resulting data is then applied to graphing charts, which is used to predict future price movements based on price patterns and trends.
- **Cyclical Analysis** - a type of technical analysis that involves evaluating recurring price patterns and trends.
- **Fundamental Analysis** - involves analyzing individual companies and their industry groups, such as a company's financial statements, details regarding the company's product line, the experience and expertise of the company's management, and the outlook for the company's industry. The resulting data is used to measure the true value of the company's stock compared to the current market value.
- **Qualitative Analysis** - involves the evaluation of factors, which cannot be precisely measured, such as experience and caliber of management style and investment philosophy.
- **Quantitative Analysis** - involves the evaluation of fund managers based on quantitative (measurable) factors such as performance.
- **Long Term Purchases** - securities purchased with the expectation that the value of those securities will grow over a relatively long period of time, generally greater than one year.
- **Option Writing** - selling, for the payment of a premium, options giving the right, but not the obligation, to buy or sell a particular security at a specified price before the expiration date of the option.
- **Short Term Purchases** - securities purchased with the expectation that they will be sold within a relatively short period of time, generally less than one year, to take advantage of the securities' short-term price fluctuations.

- **Technical Analysis** - involves studying past price patterns and trends in the financial markets to predict the direction of both the overall market and specific stocks.
- **Trading** - involves selling securities within 30 days of purchasing the same securities as an investment strategy when managing your account(s). Short-term trading is not a fundamental part of our overall investment strategy, but we may use this strategy occasionally when we determine that it is suitable given your stated investment objectives and tolerance for risk.

Our investment strategies and advice may vary depending upon each client's specific financial situation. As such, we determine investments and allocations based upon your predefined objectives, risk tolerance, time horizon, financial horizon, financial information, liquidity needs, and other various suitability factors. Your restrictions and guidelines may affect the composition of your portfolio.

Tax Considerations

Our strategies and investments may have unique and significant tax implications. However, unless we specifically agree otherwise, and in writing, tax efficiency is not our primary consideration in the management of your assets. Regardless of your account size or any other factors, we strongly recommend that you continuously consult with a tax professional regarding the investing of your assets.

Moreover, as a result of revised IRS regulations, custodians and broker-dealers will begin reporting the cost basis of equities acquired in client accounts on or after January 1, 2011. Your custodian will default to the FIFO (First-In First-Out) accounting method for calculating the cost basis of your investments. You are responsible for contacting your tax adviser to determine if this accounting method is the right choice for you. If your tax adviser believes another accounting method is more advantageous, please provide written notice to our firm immediately and we will alert your account custodian of your individually selected accounting method. Please note that decisions about cost basis accounting methods will need to be made before trades settle, as the cost basis method cannot be changed after settlement.

Investment Strategies

Day Hagan Global Tactical Allocation Investment Strategy (Non-Fund)

The Day Hagan Global Tactical Allocation Investment Strategy seeks to provide the flexibility necessary to seize opportunities in the marketplace in a rational, model-based, unemotional manner. The first and most important decision in carrying out the strategy is the allocation to stocks versus bonds. The allocation is further refined through exposure to U.S. Equity Styles and Classes, International Equities, Fixed Income Sectors, Precious Metals, Real Estate, Commodities and Currencies. The strategy utilizes a quantitative framework to define asset allocation that Donald L. Hagan, CFA (our co-founder and Chief Investment Strategist) developed in conjunction with Ned Davis Research. Our models mathematically evaluate business conditions, fundamentals, price trends, sentiment, economic trends and valuation to determine the most attractive asset classes. Our models interpret these ever-changing market conditions and generally adjust the portfolio each month with the goal of being overweighted in areas with the greatest possibility of success and underweighted in areas of weakness. The strategy is implemented primarily by utilizing ETFs.

We generally adhere to the following principles in implementing the strategy:

- Base decisions on an objective and model-based framework;
- Use time-tested and robust financial market indicators;
- Allocate based on a weight-of-the-evidence approach;
- Seek to stay on the right side of major trends by using trend-following indicators;

- Tactically adjust the portfolio to reflect prevailing financial conditions; and
- View cash as a defensive asset class.

Day Hagan Put-Write Investment Strategy (Non-Fund)

The Day Hagan Put-Write Investment Strategy seeks to generate current income while standing ready to acquire select securities if they fall below a specified price. It seeks to do this by selling put options (also known as "writing puts" or "put-writes") on individual stocks and ETFs. Selling a put obligates the investor to purchase the stock or ETF at a lower specified price (*i.e.*, the strike price), while concurrently generating income (*i.e.*, the premium) for the investor from the sale of the associated put option. Selling a cash-secured put involves selling a put and depositing the money necessary to purchase the underlying security with a custodian (*i.e.*, no leverage is used). Placing the cash in the custodian account ensures that funds are available to purchase the security should the put be exercised. Generally, the buyer of the put will exercise the option and the seller of the put will be required to purchase the underlying security if the security's price drops below the strike price before the option expires. If the security does not drop below the strike price by expiration, the premium will be retained by the option seller.

There are currently short-term options listed on more than 2,000 stocks and 650 ETFs. We utilize the Day Hagan Logix Tactical Dividend strategy's selection process and other analysis to identify the stocks and ETFs tracking industries currently rated as attractive for purchase. Once a security is identified as potentially attractive, analysis is performed on available put options in relation to the following factors: (i) level of premium; (ii) downside buffer, and (iii) time period until expiration. We generally seek put options with the following features: (i) at least a 6% annualized return; (ii) at least an 8% downside buffer between the current price and the strike price; and (iii) expire within 90 days. With regard to the overall portfolio, we seek to maintain a diversified portfolio of securities and enter into positions over an extended period of time (new portfolios may hold cash as new positions are established).

By utilizing our analytical process, the cash-secured put-write strategy can potentially generate current income through the receipt of option premiums and help us accumulate attractive securities at prices lower than those prevailing when the put options are sold.

Day Hagan Sector Rotation Investment Strategy (Non-Fund)

The Day Hagan Sector Rotation Investment Strategy seeks to allocate among eight U.S. equity, sector-specific, ETFs and cash or cash equivalents.

Generally, the allocation percentages are determined through a two-part process that includes defining the market as being in a bullish or bearish mode and then allocating to individual sectors based on a proprietary "Goodness Measure".

Defining the market as being in a bullish or bearish mode is determined by a quantitative process that evaluates the equity market trend using a series of proprietary technical indicators focused on the SPDR S&P 500 ETF Trust (symbol: SPY). When the market is determined to be in a bullish mode, it seeks to overweight equities and reduce the allocation to cash. When the model is in a bearish mode, it seeks to reduce equity exposure and increase the allocation to cash.

The proprietary Goodness Measure, which is used to determine which sectors to overweight and underweight, utilizes measures of rolling upside and downside capture, betas, gains, and drawdowns/drawups. A series of timeframes are evaluated, and sectors evidencing the highest relative scores are overweighted while the lowest relative scores are underweighted.

Day Hagan Small-Cap Stock Investment Strategy (Non-Fund)

The Day Hagan Small-Cap Stock Investment Strategy seeks to invest in a diversified portfolio of equities, with a focus on mid-cap and small-cap stocks.

Typically, small-cap stocks have equity market capitalizations under approximately \$500 million, mid-cap stocks have equity market capitalizations between approximately \$500 million and \$2 billion, and large-cap stocks have equity market capitalizations over \$2 billion. The strategy will invest primarily in a limited number of small- and mid-cap stocks. However, selected stocks may include large-cap as well. Selected stocks may also exhibit characteristics of growth or value, and applicable companies may have U.S. or international operations and revenue streams.

Generally, we seek to select the stocks of companies for the portfolio with one or more of the following attributes:

- Balance sheet strength and high debt coverage ratios, strong business models and competitive positions;
- Improving fundamental trends and attractive prospects for growth;
- Positive operating cash trends;
- Favorable ratings from third-party analysts; and
- Earnings expectations that are, based on our proprietary modeling, pessimistic relative to the company's potential.

Day Hagan Logix Tactical Dividend Investment Strategy (Non-Fund)

The Day Hagan Logix Tactical Dividend Strategy seeks to invest primarily in equity securities of undervalued, dividend-paying companies. To select securities, the Adviser:

- Screens the Russell 3000 for companies that generally have a 10-year history of uncut dividends, balance sheet sustainability, cash flow generation and fundamental soundness, typically resulting in approximately 400 securities;
- Classifies the candidates for investment into industry groups based on business lines and revenue sources;
- Further screens out Adviser-defined industry groups with four or fewer candidates, and industry groups whose candidates' composite dividend yield falls materially short of the high yield buy threshold determined by the Adviser for the industry group as a whole;
- Selects securities for investment and makes asset and position allocations based on a "weight-of-the-evidence" approach; and
- Makes tactical changes in the portfolio to reflect prevailing financial conditions within sectors and industry groups.

When the Adviser is unable to identify suitable buy candidates, or believes that patience or a defensive approach are more appropriate, then the Adviser will increase the Strategy's allocation to cash, cash equivalents and similar securities. While the Strategy may be invested in any type of security or other financial instrument determined to be appropriate by the Adviser, the Strategy will generally invest in common stocks, convertible debentures, preferred stocks, convertible preferred stocks, warrants, American Depositary Receipts (ADRs), real estate investment trusts (REITs), money market instruments, ETFs, and other investment companies investing in any of the foregoing, and similar investments.

Day Hagan Tactical Allocation Fund Investment Strategy

The Allocation Fund invests in a portfolio of ETFs selected using quantitative asset allocation models. We typically select ETFs that invest across a broad range of global asset classes including, but not limited to, U.S., emerging market and other international stocks, U.S. and international bonds, U.S. and international real estate, commodities and currencies.

Day Hagan Logix Tactical Dividend Fund Investment Strategy

The Dividend Fund seeks to achieve its investment objectives by investing primarily in the equity securities of dividend paying domestic companies that the Fund's Sub-Adviser, Gries Financial, believes to be under-valued based on its proprietary equity selection model. Under normal circumstances, at least 80% of the Fund's net assets plus the amount of borrowings for investment purposes, will be invested in the securities of dividend paying companies. While the Fund may invest in companies of any market capitalization without limitation, the Sub-Adviser expects that under normal market conditions its equity selection model will create a portfolio focused on large capitalization companies. The equity securities in which the Fund may invest include common stock and REITs.

Day Hagan Hedged Strategy Fund Investment Strategy

The Hedged Strategy Fund seeks to achieve its investment objectives by buying and selling call and put options on the S&P 500 Index with expiration targets two years or less. The Index is an unmanaged index of 500 stocks that is market-capitalization weighted and is generally representative of the performance of larger companies in the U.S. The Fund may also buy and sell call and put options on other indexes. Pacini Hatfield, the Fund's Sub-Adviser, employs an alternative investment strategy that generates income primarily by selling deep out-of-the-money put options. The Fund may also sell deep out-of-the-money call options. An "out of the money" option is a call option with a strike price that is higher than the market price of the underlying asset or put option with a strike price that is lower than the market price of the underlying asset.

Risk Factors

Investing in securities involves risk of loss that you should be prepared to bear. We do not guarantee the success of any investment decision, methodology, or strategy that we may use, or the success of our overall management. We invest client accounts in different types of securities and financial instruments, which are subject to risks. Therefore, using our advisory services involves various risks, including, but not limited to, the risk factors set forth below. While these risk factors should be reviewed carefully before engaging us for services, other risk factors ultimately may affect investment returns and performance in a manner and to a degree not now foreseen or not specifically identified in this Brochure (ADV Part 2) disclosure.

Acquired Fund Risk. Investing in securities issued by registered investment companies, such as ETFs or mutual funds, involves the paying of a portion of the operating costs of the investment companies. These costs include management, brokerage, shareholder servicing, and other operational expenses. Since these costs may involve the duplication of advisory fees and other expenses, you may indirectly pay higher operational costs than if you owned shares of the underlying investments of the investment company directly.

Cash or Cash Equivalents Risk. When holding cash or cash equivalents, there is the risk that the value of the cash account, including interest, will not keep pace with inflation, thus reducing purchasing power over time.

Commodity Risk. Investments which may be affected by commodity risks include equity investments in companies whose business relate to the value of commodities directly and indirectly, futures contracts tied to the price of particular commodities, and shares of investment pools that invest in commodity-related equities or futures contracts. Investments related to commodities may be more

volatile and less liquid than alternative investments. The value of investments related to commodities may be materially and quickly changed by government regulation, natural disasters, technological innovation, wars and terrorist attacks, and other events outside the control of our control.

Currency Risk. Changes in the exchange rates between foreign currencies and the U.S. dollar may negatively affect the value of investments in foreign securities. For example, a U.S. investor will receive fewer dollars if foreign securities denominated in a foreign currency are sold, mature, or are liquidated after the foreign currency has weakened relative to the U.S. dollar. Domestic securities whose issuers conduct a significant portion of their business in foreign currencies may also be negatively affected by changes in the exchange rates between those foreign currencies and the U.S. dollar may negatively affect the value of those domestic securities.

Derivatives Risk. Even a small investment in derivatives (which include options, futures and other transactions) may give rise to leverage risk (which can increase volatility and magnify a portfolio's potential for loss), and can have a significant impact on the portfolio's performance. Derivatives are also subject to credit risk (the counterparty may default) and liquidity risk (it may be difficult to save or otherwise exit the contract in a timely manner.)

Emerging Markets Risk. Investing in emerging markets may include exposure to economic structures and financial systems that are generally less diverse and mature, and to political and legal systems that can be expected to have less stability, than those of developed countries. The typically small size of the markets of securities of issuers located in emerging markets and the possibility of a low or nonexistent volume of trading in those securities may also result in a lack of liquidity and in heightened price volatility of those securities.

Equity Security Risk. Common and preferred stocks are susceptible to general stock market fluctuations and to volatile increases and decreases in value as market confidence in and perceptions of their issuers change. Warrants and rights may expire worthless if the price of a common stock is below the conversion price of the warrant or right. Convertible bonds may decline in value if the price of a common stock falls below the conversion price. Investor perceptions are based on various and unpredictable factors, including expectations regarding government, economic, monetary and fiscal policies; inflation and interest rates; economic expansion or contraction and global or regional political, economic and banking crises.

Foreign Exposure Risk. Risks associated with investments in foreign markets may include less liquidity, greater volatility, less developed or less efficient trading markets, lack of comprehensive company information, political instability and differing auditing and legal standards.

Hedging Risk. Hedging is a strategy in which a derivative is used to offset the risks associated with other holdings (e.g., purchasing an S&P futures contract to offset a substantial short equities position). There can be no assurance that the hedging strategy will reduce risk or that hedging transactions will be either available or cost effective.

Index Risk. If the derivative is linked to the performance of an index, it will be subject to the risks associates with changes in that index.

Inflation Risk. Increases in real interest rates can cause the price of debt securities to decrease. Interest payments on debt securities can be unpredictable.

Interest Rate Risk. Fixed income securities and other instruments may decline in value because of a general increase in interest rates. As nominal interest rates rise, the value of certain fixed income securities is likely to decrease. A nominal interest rate can be described as the sum of a real interest

rate and an expected inflation rate. Fixed income securities with longer durations tend to be more sensitive to changes in interest rates, usually making them more volatile than securities with shorter durations. The values of equity and other non-fixed income securities may also decline due to fluctuations in interest rates.

Leverage Risk. Using derivatives like commodity futures and options to increase a portfolio's combined long and short exposure creates leverage, which can magnify the potential for gain or loss and, therefore, amplify the effects of market volatility on the portfolio's value.

Limited History of Operations. The Day Hagan Hedged Strategy Fund has a limited history of operations as a mutual fund for investors to evaluate.

Management Risk. The portfolio manager's judgements about the attractiveness, value and potential appreciation of particular investments may prove to be incorrect and there is no guarantee that the portfolio manager's judgement will produce the desired results.

Market Risk. The value of securities may decline due to daily fluctuations in the securities markets. Performance of securities will vary daily, based on many factors that affect the stock market, including changes in interest rates, national and international economic conditions, and general equity market conditions. In a declining stock market, stock prices for all companies may decline, regardless of the long-term prospects of particular companies.

New Sub-Adviser Risk. The Sub-Adviser for the Day Hagan Hedged Strategy Fund, Pacini Hatfield, has limited experience managing a mutual fund. Mutual funds and their advisers are subject to restrictions and limitations imposed by the Investment Company Act of 1940, as amended, and the Internal Revenue Code that do not apply to the adviser's management of other types of individual and institutional accounts. As a result, investors do not have a long-term track record of managing a mutual fund from which to judge the Sub-Adviser and the Sub-Adviser may not achieve the intended result in managing the fund.

Non-Diversification Risk. A relatively high percentage of the assets in a portfolio may be invested in the securities of a limited number of companies that could be in the same or related economic sectors. Accordingly, your portfolio may be more susceptible to any single economic, technological or regulatory occurrence than the portfolio of a diversified portfolio.

Options Risk. There are risks associated with the sale and purchase of call and put options. The seller (writer) of a put option tends to lose money if the value of the reference index or security falls below the strike price. The seller (writer) of a call option tends to lose money if the value of the reference index or security rises above the strike price. The buyer of a put or call option risks losing the entire premium invested in the option if the value of the reference index or security is such that the option is not exercised before it expires.

Real Estate Risk. Real estate risk entails a wide variety of risks, including, but not limited to, changes in taxation, regulations and economic and political factors that negatively impact the real estate market and the direct ownership of real estate. Turnover Risk. The investment processes and tools we utilize may lead to higher portfolio turnover. Higher turnover may result in higher transactional, brokerage, and tax costs. Higher costs may negatively affect portfolio returns.

Recommendation of Particular Types of Securities

As disclosed under the *Advisory Business* section in this Brochure, we primarily recommend investing in individual equities, mutual funds and exchange traded funds. You should be advised of the following risks when investing in these types of securities:

Stocks: There are numerous ways of measuring the risk of equity securities (also known simply as "equities" or "stock"). In very broad terms, the value of a stock depends on the financial health of the company issuing it. However, stock prices can be affected by many other factors including, but not limited to the class of stock (for example, preferred or common); the health of the market sector of the issuing company; and, the overall health of the economy. In general, larger, better established companies ("large cap") tend to be safer than smaller start-up companies ("small cap") are but the mere size of an issuer is not, by itself, an indicator of the safety of the investment.

Mutual Funds and Exchange Traded Funds: Mutual funds and exchange traded funds are professionally managed collective investment systems that pool money from many investors and invest in stocks, bonds, short-term money market instruments, other mutual funds, other securities or any combination thereof. The fund will have a manager that trades the fund's investments in accordance with the fund's investment objective. While mutual funds and ETFs generally provide diversification, risks can be significantly increased if the fund is concentrated in a particular sector of the market, primarily invests in small cap or speculative companies, uses leverage (i.e., borrows money) to a significant degree, or concentrates in a particular type of security (i.e., equities) rather than balancing the fund with different types of securities. Exchange traded funds differ from mutual funds since they can be bought and sold throughout the day like stock and their price can fluctuate throughout the day. The returns on mutual funds and ETFs can be reduced by the costs associated in managing the funds. Also, while some mutual funds are "no load" and charge no fee to buy into, or sell out of, the fund, other types of mutual funds do charge such fees which can also reduce returns. Mutual funds can also be "closed end" or "open end". So-called "open end" mutual funds continue to allow in new investors indefinitely which can dilute other investors' interests.

Item 10 Other Financial Industry Activities and Affiliations

Some persons providing investment advice on behalf of our firm are also licensed as insurance agents. These persons will earn commission-based compensation for selling insurance products, including insurance products they sell to you. Insurance commissions earned by these persons are separate from our advisory fees. Please see the *Fees and Compensation* section in this Brochure for more information on the compensation received by insurance agents who are affiliated with our firm.

While these individuals endeavor at all times to put the interest of our clients first as part of our firm's fiduciary duty, you should be aware that the receipt of additional compensation itself creates a conflict of interest, and may affect the judgment of these individuals when making recommendations.

Our firm serves as the investment adviser to the Day Hagan Tactical Allocation Fund (the "Allocation Fund"), The Day Hagan Tactical Dividend Fund (the "Dividend Fund") and the Day Hagan Hedged Strategy Fund ("Hedged Strategy Fund"). Collectively these will be referred to as the "Mutual Funds". These Mutual Funds are a series of the Mutual Fund Series Trust ("Trust"), a registered investment company.

- The Allocation Fund's primary objective is to achieve long-term capital appreciation with current income as a secondary objective. The Allocation Fund seeks to achieve its investment objectives by investing in a portfolio of ETFs selected using our proprietary quantitative asset allocation models.
- The Dividend Fund's primary objective is to achieve long-term capital appreciation with current income as a secondary objective. The Dividend Fund seeks to achieve its investment objectives by investing in a portfolio of individual securities.
- The Hedged Strategy Fund's primary objective is to achieve capital appreciation with low correlation to equity markets. The Hedged Strategy Fund seeks to achieve its investment objectives by buying and selling call and put options on the S&P 500 Index with expiration targets two years or less. The Index is an unmanaged index of 500 stocks that is market-capitalization weighted and is generally representative of the performance of larger companies in the U.S. The Hedged Strategy Fund may also buy and sell call and put options on other indexes.

The Allocation Fund and Dividend Fund are authorized to pay our firm a fee equal to 1.00%, based on the Mutual Funds' average daily net assets. The Hedged Strategy Fund is authorized to pay our firm a fee equal to 1.75%, based on the average daily net assets. We have contractually agreed to waive fees and/or reimburse expenses but only to the extent necessary to maintain total annual operating expenses (excluding brokerage costs, borrowing costs, such as (a) interest and (b) dividends on securities sold short, taxes, costs of investing in underlying funds, 12b-1 distribution fees and extraordinary expenses) at 1.60%, 2.35%, and 1.35% for Class A, Class C, and Class I, respectively through October 31, 2017 for the Allocation Fund and the Dividend Fund. For the Hedged Strategy Fund, we have agreed to waive fees and/or reimburse expenses but only to the extent necessary to maintain total annual operating expenses (excluding brokerage costs, borrowing costs, such as (a) interest and (b) dividends on securities sold short, taxes, costs of investing in underlying funds, 12b-1 distribution fees and extraordinary expenses) at 2.23%, 2.98%, and 1.98% for Class A, Class C, and

Class I, respectively through October 31, 2018. Each waiver or reimbursement by us is subject to repayment by the Funds within the three fiscal years following the fiscal year in which that particular expense is incurred, if the Funds are able to make the repayment without exceeding the expense limitation in effect at the time of the waiver and the repayment is approved by the Board of Trustees. We pay a portion of our management fee received from the Dividend Fund and Hedged Strategy Fund to the Sub-Advisers of those Funds.

We may recommend that you invest in these Mutual Funds. The compensation arrangements we have with these Mutual Funds present a conflict of interest because we may have a financial incentive to recommend that you invest in these Mutual Funds. While we believe that the compensation arrangements that we have with these Mutual Funds is competitive, such compensation may be higher than the compensation charged by other firms providing the same or similar services. You are under no obligation to purchase shares in any of these Mutual Funds.

We employ an individual to act as a wholesaler to sell our mutual funds and oversee the outside wholesalers. The outside wholesalers are licensed with a broker-dealer and are not Day Hagan employees. The wholesaler we employ is dually registered as a registered representative with Foreside, which is also the distributor for our mutual funds. As an employee of Day Hagan, the inside wholesaler is subject to our supervision.

We have jointly formed and manage, along with Gries Financial, DH Logix LLC dba Day Hagan Logix ("DH Logix"), an SEC-registered investment adviser. DH Logix offers portfolio management services as investment adviser or sub-adviser to individuals, institutions, businesses of all sizes, registered funds and others. Our managers and portfolio managers, along with managers and portfolio managers of Gries Financial, serve as the managers and portfolio managers of DH Logix, and DH Logix may act as sub-adviser with respect to Day Hagan client relationships. You should be aware that receipt of additional compensation or other non-monetary benefits by us or our managers or portfolio managers from the activities of DH Logix, if awarded, would create an incentive for us to recommend the investment advisory services of DH Logix. Where DH Logix is engaged as a sub-adviser for Day Hagan clients, there generally will be no separate fee charged for Day Hagan's services. However, if there is a separate charge for those services, you should consider this conflict among other factors before engaging DH Logix for services.

We may recommend that you use a Third Party Money Manager ("MM") based on your needs and suitability. We may receive compensation from the MM for recommending that you use their services. These compensation arrangements present a conflict of interest because we have a financial incentive to recommend the services of the third party adviser. You are not obligated, contractually or otherwise, to use the services of any MM we recommend.

Item 11 Code of Ethics, Participation or Interest in Client Transactions and Personal Trading

We strive to comply with applicable laws and regulations governing our practices. Therefore, our Code of Ethics includes guidelines for professional standards of conduct for our Associated Persons. Our goal is to protect your interests at all times and to demonstrate our commitment to our fiduciary duties of honesty, good faith, and fair dealing with you. All of our Associated Persons are expected to adhere strictly to these guidelines. Our Code of Ethics also requires that certain persons associated with our firm submit reports of their personal account holdings and transactions to a qualified representative of

our firm who will review these reports on a periodic basis. Persons associated with our firm are also required to report any violations of our Code of Ethics. Additionally, we maintain and enforce written policies reasonably designed to prevent the misuse or dissemination of material, non-public information about you or your account holdings by persons associated with our firm.

Our Code of Ethics is available to you upon request. You may obtain a copy of our Code of Ethics by contacting us at the telephone number found on the cover page of this brochure.

Participation or Interest in Client Transactions

As noted above we serve as the investment adviser to the Allocation Fund, the Dividend Fund, and the Hedged Strategy Fund, all of which are series of the Mutual Fund Series Trust ("Trust"), a registered investment company. Persons associated with our firm may have significant investments in these Funds. If you are an investor in any of these Funds, please refer to the Funds' offering documents for detailed disclosures regarding these Funds. Additionally, individuals associated with our firm may buy or sell - for their personal account(s) - investment products identical to those purchased by these Funds. This practice may create a conflict of interest because we have the ability to trade ahead of these Funds and potentially receive more favorable prices than these Funds will receive. To mitigate this conflict of interest, it is our policy that neither our Associated Persons nor we shall have priority over these Funds in the purchase or sale of securities.

Personal Trading Practices

Our firm or persons associated with our firm may buy or sell the same securities that we recommend to you or securities in which you are already invested. A conflict of interest exists in such cases because we have the ability to trade ahead of you and potentially receive more favorable prices than you will receive. To mitigate this conflict of interest, it is our policy that neither our Associated Persons nor we shall have priority over your account in the purchase or sale of securities.

Item 12 Brokerage Practices

We recommend the brokerage and custodial services of Raymond James Financial Services, a securities broker-dealer and a member of the Financial Industry Regulatory Authority and the Securities Investor Protection Corporation. We believe that Raymond James Financial Services provides quality execution services for you at competitive prices. Price is not the sole factor we consider in evaluating best execution. We also consider the quality of the brokerage services provided by Raymond James Financial Services, including the value of research provided, the firm's reputation, execution capabilities, commission rates, and responsiveness to our clients and our firm. In recognition of the value of research services and additional brokerage products and services Raymond James Financial Services provides, you may pay higher commissions and/or trading costs than those that may be available elsewhere.

Research and Other Soft Dollar Benefits

In selecting or recommending a broker-dealer, we will consider the value of research and additional brokerage products and services a broker-dealer has provided or will provide to our clients and our firm. Receipt of these additional brokerage products and services are considered to have been paid for with "soft dollars." Because such services could be considered to provide a benefit to our firm, we may have a conflict of interest in directing your brokerage business. We could receive benefits by selecting a particular broker-dealer to execute your transactions, and the transaction compensation charged by that broker-dealer might not be the lowest compensation we might otherwise be able to negotiate.

Products and services that we may receive from broker-dealers may consist of research data and analysis, financial publications, recommendations, or other information about particular companies and industries (through research reports and otherwise), and other products or services (e.g., software and

data bases) that provide lawful and appropriate assistance to our firm in the performance of our investment decision-making responsibilities. Consistent with applicable rules, brokerage products and services consist primarily of computer services and software that permit our firm to effect securities transactions and perform functions incidental to transaction execution. We use such products and services in our general investment decision making, not just for those accounts for which commissions may be considered to have been used to pay for the products or services.

Before placing orders with a particular broker-dealer, we determine that the commissions to be paid are reasonable in relation to the value of all the brokerage and research products and services provided by that broker-dealer. In some cases, the commissions charged by a particular broker for a particular transaction or set of transactions may be greater than the amounts charged by another broker-dealer that did not provide research services or products.

We do not exclude a broker-dealer from receiving business simply because the broker-dealer does not provide our firm with soft dollar research products and services. However, we may not be willing to pay the same commission to such broker-dealer as we would have paid had the broker-dealer provided such products and services.

The products and services we receive from broker-dealers will generally be used in servicing all of our clients' accounts. Our use of these products and services will not be limited to the accounts that paid commissions to the broker-dealer for such products and services. In addition, we may not allocate soft dollar benefits to your accounts proportionately to the soft dollar credits the accounts generate. As part of our fiduciary duties to you, we endeavor at all times to put your interests first. You should be aware that the receipt of economic benefits by our firm is considered to create a conflict of interest.

We routinely recommend that you direct our firm to execute transactions through Raymond James Financial Services. As such, while we believe Raymond James Financial provides execution services that are competitive with other firms, we may not always be able to achieve the most favorable execution of your transactions and you may pay higher brokerage commissions than you might otherwise pay through another broker-dealer that offers the same types of services. Not all advisers require their clients to direct brokerage.

Brokerage for Client Referrals

We do not receive client referrals from broker-dealers in exchange for cash or other compensation, such as brokerage services or research.

Directed Brokerage

In limited circumstances, and at our discretion, some clients may instruct our firm to use one or more particular brokers for the transactions in their accounts. If you choose to direct our firm to use a particular broker, you should understand that this might prevent our firm from aggregating trades with other client accounts. This practice may also prevent our firm from obtaining favorable net price and execution. Thus, when directing brokerage business, you should consider whether the commission expenses, execution, clearance, and settlement capabilities that you will obtain through your broker are adequately favorable in comparison to those that we would otherwise obtain for you.

Block Trades

We combine multiple orders for shares of the same securities purchased for discretionary accounts; however, we do not combine orders for non-discretionary accounts. Accordingly, non-discretionary accounts may pay different costs than discretionary accounts pay. If you enter into non-discretionary arrangements with our firm, we may not be able to buy and sell the same quantities of securities for you and you may pay higher commissions, fees, and/or transaction costs than clients who enter into discretionary arrangements with our firm.

Item 13 Review of Accounts

Donald Hagan, Managing Member, or other Associated Persons of our firm monitor your accounts on a continuous basis and will conduct account reviews at least annually and upon your request to ensure that the advisory services provided to you and/or the portfolio mix are consistent with your stated investment needs and objectives. Additional reviews may be conducted based on various circumstances, including, but not limited to:

- contributions and withdrawals,
- year-end tax planning,
- market moving events,
- security specific events, and/or,
- changes in your risk/return objectives.

The nature and frequency of reports provided by our firm are based on your specific needs. In addition, you will receive trade confirmations and monthly or quarterly statements from your account custodian(s).

Item 14 Client Referrals and Other Compensation

We do not receive any compensation from any third party in connection with providing investment advice to you .

Please refer to the *Brokerage Practices* section above for disclosures on research and other benefits we may receive resulting from our relationship with Raymond James Financial Services.

We directly compensate non-employee (outside) entities and one employee (inside) (i.e., "wholesalers") for marketing the Day Hagan mutual funds to other registered investment advisers and broker dealers. If you are an investor in our mutual funds, your investment adviser may have been solicited by a wholesaler. If you become an investor in our funds, the wholesaler that referred your investment adviser to our firm will receive compensation as a consequence of your fund purchase. You will not pay additional fees because of this compensation arrangement. The wholesaler has a financial incentive to recommend our mutual funds to your investment adviser. This creates a conflict of interest; however, you are not obligated to invest in our mutual funds.

Additionally, these same individuals are also compensated for referring our strategies to other investment advisers and/or their clients. In order to receive a referral fee from our firm, these individuals must comply with the requirements of the jurisdictions in which they operate. If you use one or more of our strategies after being referred thereto by one of these individuals, the individual that referred you will receive a one-time fixed referral fee. Referral fees paid to such individuals are contingent upon your using one or more of our strategies. Therefore, these individuals have a financial incentive to recommend our strategies to you which creates a conflict of interest. However, you are not obligated to use any of our strategies.

Item 15 Custody

We directly debit your account(s) for the payment of our advisory fees. This ability to deduct our advisory fees from your accounts causes our firm to exercise limited custody over your funds or securities. We do not have physical custody of any of your funds and/or securities. Your funds and securities will be held with a bank, broker-dealer, or other independent, qualified custodian. You will receive account statements from the independent, qualified custodian(s) holding your funds and securities at least quarterly. The account statements from your custodian(s) will indicate the amount of our advisory fees deducted from your account(s) each billing period. You should carefully review account statements for accuracy.

If you have a question regarding your account statement or if you did not receive a statement from your custodian, please contact us at the telephone number listed on the cover page of this brochure.

Item 16 Investment Discretion

Before we can buy or sell securities on your behalf, you must first sign our discretionary Investment Advisory Agreement and the appropriate trading authorization forms.

You may grant our firm discretion over the selection and amount of securities to be purchased or sold for your account(s) without obtaining your consent or approval prior to each transaction. You may specify investment objectives, guidelines, and/or impose certain conditions or investment parameters for your account(s). For example, you may specify that the investment in any particular stock or industry should not exceed specified percentages of the value of the portfolio and/or restrictions or prohibitions of transactions in the securities of a specific industry or security. Please refer to the *Advisory Business* section in this Brochure for more information on our discretionary management services.

If you enter into non-discretionary arrangements with our firm, we will obtain your approval prior to the execution of any transactions for your account(s). You have an unrestricted right to decline to implement any advice provided by our firm on a non-discretionary basis.

Item 17 Voting Client Securities

Generally, we will not take any action or render any advice with respect to voting of proxies solicited by, or with respect to, the issuers of securities in which client's assets may be invested; However, we will vote proxies for the Mutual Funds based on our reasonable judgment that our vote will be most likely to produce a favorable financial result for the Mutual Funds and their shareholders.

Our firm and the Trust each have adopted proxy voting policies and procedures reasonably designed to ensure that proxies are voted in shareholders' best interests. As a brief summary, the Trust's policy delegates responsibility regarding proxy voting to our firm who, in turn, votes the Mutual Funds' proxies in accordance with its proxy voting policy, subject to the provisions of the Trust's policy regarding conflicts of interests.

Our proxy voting policy requires us to vote proxies received in a manner consistent with the best interests of the Mutual Funds and their shareholders. Our policy underscores our firm's concern that all proxy voting decisions be made in the best interests of the Mutual Fund's shareholders. Our policy dictates that we vote such proxies in a manner that will further the economic value of each investment for the expected holding period. Each vote cast by our firm on behalf of the Mutual Funds is done on a case-by-case basis, taking into account all relevant factors.

We keep certain records required by applicable law in connection with our proxy voting activities. You may obtain information on how we voted proxies and/or obtain a full copy of our proxy voting policies and procedures by making a written or oral request to our firm.

Item 18 Financial Information

We are not required to provide a balance sheet or other financial information to our clients because we do not require the prepayment of fees in excess of \$500 and six months or more in advance; we do not take custody of client funds or securities; and, we do not have a financial condition that is reasonably likely to impair our ability to meet our commitments to you. Moreover, we have never been the subject of a bankruptcy petition.

Item 19 Requirements for State-Registered Advisers

We are a federally registered investment adviser; therefore, we are not required to respond to this item.

Item 20 Additional Information

Your Privacy

We view protecting your private information as a top priority. Pursuant to applicable privacy requirements, we have instituted policies and procedures to ensure that we keep your personal information private and secure.

We do not disclose any nonpublic personal information about you to any nonaffiliated third parties, except as permitted by law. In the course of servicing your account, we may share some information with our service providers, such as transfer agents, custodians, broker-dealers, accountants, consultants, and attorneys.

We restrict internal access to nonpublic personal information about you to employees, who need that information in order to provide products or services to you. We maintain physical and procedural safeguards that comply with regulatory standards to guard your nonpublic personal information and to ensure our integrity and confidentiality. We will never sell information about you or your accounts to anyone. We do not share your information unless it is required to process a transaction, at your request, or required by law.

You will receive a copy of our privacy notice prior to or at the time you sign an advisory agreement with our firm. Thereafter, we will deliver a copy of the current privacy policy notice to you on an annual basis. Please contact us at the telephone number listed on the cover page of this brochure, if you have any questions regarding this policy.

Trade Errors

In the event a trading error occurs in your account, our policy is to restore your account to the position it should have been in had the trading error not occurred. Depending on the circumstances, corrective actions may include canceling the trade, adjusting an allocation, and/or reimbursing the account. If a trade error results in a profit, you do not keep the profit.
