

**Rules for Signature Gathering:**

- Use blue or black ink (black ink is preferred – check with your county clerk)
- A copy of the petition language must be attached to the top of signature sheet (check with your county clerk if the petition can be printed double-sided).
- Signers must be registered to vote and use their voting address on the petition
- Signers must write legibly (and use information filled out on the voter registration card)
- Use physical mailing address – No PO Boxes will be accepted
- Include the year in the date section
- DO NOT write in the “Official Use Only Legislative District” section
- Signature collectors cannot write in the section for signatures (correcting, lining out, adding dates, etc) – only the petition signers can write in this section
- All signers on a sheet must be registered in the same county – signatures will not be valid if they are on the wrong county sheet
