Wristbands: Anyone at the venue must have an access wristband provided by Glacier Cycling LLC to access the event. Failure to do so will result in removal from the venue. Wristbands are available in advance or at the venue gates to access the venue. Wristbands last the duration of the event. We are not responsible for lost or stolen wristbands.

Camping: There is no RV or camping at Rancho San Rafael Regional Park.

Space Reservation: Reservations are first come first serve priority. You must fit within your reserved footprint. Any overage will result in additional fees.

Expo only: Test rides, product sampling/displaying/selling in the team area is strictly prohibited. This can only be done in the expo area.

Cancellation: 50% refund if cancelled less than 30 days prior to January 8th, 2018.

Refuse/Damage: All vendors & teams will be responsible for trash clean up in their reserved area. Damage to the area reserved by you will be charged accordingly and liable for associated expenses.

Local Permits: All vendors and teams agree to comply with all local health and fire codes.

Expo Move In/Out: All vendors and teams must be moved in by Monday January 8th. All vendors and teams must be moved out by Monday January 15th at 5:00pm.
