# <u>Instructions For Completing the Application For Boat Storage on Town Property</u>

- Please complete all sections of the application including your current email.
- Complete one application for each vessel.
- Refer to the attached sheets, <u>Locations &, Space Restriction 2021 & Map of</u>

  <u>Boat Storage Locations</u> with instructions and a map for determining boat size and the locations available to store your vessel.
- Spaces at each location are available on a first-come first serve basis. If your requested location is full we will email you with suggestions for alternatives.
- Only two permits per location, per applicant will be granted.
- Once your application is completed and you have read and understand the terms of the Town Code, please mail the application to the Town Clerk's Office at the address shown on the application along with your check for the cost of the permit.
- If you purchased a two-year permit in 2020, we are offering you a 50% credit. You should list you permit(s) and deduct \$7.50 for each vessel permitted from your payment.

# TOWN CODE CHAPTER 40-5(c) SUMMARY (https://ecode360.com/7729168#7729168)

- All boats must display a valid Town Boat Storage Permit. (See permit placement below.)
- All boats must be removed each year by December 1, and not returned until after March 31.
- All boats must be safely secured. (Tied to rack, securely anchored by a stake or heavy block.)
- All Boats assigned to racks must be on the rack and properly secured.
- All boats must have owner's name and contact phone number visibly displayed. (Use contrasting paint, a durable label, or a broad black, permanent marker.)
- NO PRIOR NOTICE IS REQUIRED TO ANY OWNER IN VIOLATION OF THE ABOVE, AND CONSEQUENTLY, THE BOAT MAY BE IMPOUNDED WITHOUT NOTICE.

## <u>PERMIT PLACEMENT – PERMIT SHOULD BE ADHERED TO:</u>

- For Vessels with a transom: (dinghies, rowboats, sailboats, etc.) starboard side of transom, just below gunwale, adjacent to the HIN.
- For Vessels without a transom: (kayaks, most canoes, etc.) starboard side of hull, near the bow, as close to the gunwale as possible.
- For Boards: (surfboards, windsurfers, paddleboards, etc.): starboard side of top deck rear corner.

### PROTECT OUR WETLANDS AND BEACHES

No Boat Storage is allowed at Reel Point, Shell Beach or any sensitive wetlands or dunes. Boat Storage is allowed only on the designated locations listed on the attached sheet

### **Boat Size Definitions for Allotted Storage Spaces**

Small = <u>Annual Fee: \$50.</u>00. Kayak, Canoe, Paddle Board, Dinghy Under 9', Skiff Under 10', Single Hull intended for No more than 2 people.

Medium = Annual Fee \$75. Sunfish, Laser, Opti, any type of sail craft for 2 people 1 mast 1 hull. Large = Annual Fee \$150. Multihull no longer than 18', no wider than 8', one mast. Hobie Cats 18 and 16 NOTE: Vessels may be stored on and moved by a hand powered dolly. No parking or storage of boats On over-the-road road trailers allowed on town property.

Key To Storage Notes: Please Refer to the attached map to determine your preferred location.

- 1. Where racks are provided, kayaks, canoes, paddleboards, etc. should be stored on the rack. in a size-appropriate space, (we prefer to have smaller and lighter boats and boards on the top slots) and secured by a rope/painter or cable.
- 2. On Wades Beach East, **Medium sized boats only.** The designated area there is clearly marked. Boats encroaching on private property or in the dune areas are subject to impound.
- 3. Wades Beach West storage area is clearly marked. For medium and large boat storage only.

  No encroaching on dunes or in the beach grass. Boats must well secured to a ground post or heavy block.
- 4. Boats must be stored along the road side, not on the beach grass.
- 5. Boats used for mooring access (a dinghy or yacht tender) get a seasonal discounted rate of \$25.00. You must have a Mooring, permitted in your name, in proximity to the requested boat storage area.
- 6. To access Congdon Creek from the preserve, use the boat ramp, do not traverse the spartina on the shoreline.
- 7. The boat storage rack at the far western end the South Ferry Hills landing is privately owned. Your vessel should be stored on the rack nearest the eastern end of the landing.
