# WELCOME TO TSA 2023

It is a great pleasure to be welcoming delegates to Plymouth for the TSA's 21<sup>st</sup> annual conference. We have a fantastic conference in store. This year's meeting features panels from a wide range of disciplines, including history, politics and international relations, and literary and cultural studies. As well as three keynote lectures, we have a plenary roundtable session on **Transatlantic Memorialisation and Heritage** and an early career workshop on **Impact and Engagement**. We are also delighted to be hosting a special conference theme on **Revisiting the Black Atlantic**.

Our theme on the Black Atlantic is represented in the keynote lecture from Michelle Wright. The city is also home to popular tourist attractions, including the National Marine Aquarium, gin distilleries and much more.

Continuing the strong social element of TSA, a wine reception will take place on the opening evening of the conference at the Box Museum, where you will be free to explore the galleries. The conference will close with a formal dinner at the Custom House.

The annual conference will see the award of a number of prizes, including the TSA-Cambridge University book prize and the DC Watt prize. As with previous conferences, the TSA has happily offered a number of travel grants to early career scholars to aid their attendance at the conference.

The TSA AGM will take place during the conference, as well as the annual meeting of the TSA management committee. Please come along to the AGM to hear about recent developments in TSA and plans for future ventures.

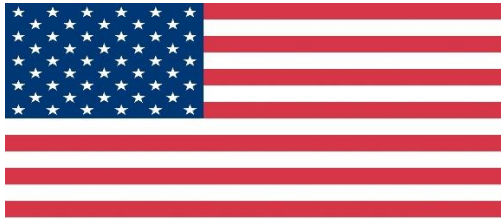
