PERSONAL DATA

Handling of customer and partner information

You can visit our website without providing any personal information. We only record data that is not personally related, such as IP address, reference page, etc. for statistical purposes. This information is only used to improve our range, and we are not able to directly link this information to you. Personal data is only stored if you voluntarily submit your information on customer registration or subscribe to newsletters. By registering and/or ordering you agree that Samuraj Kommunikation AB stores and uses information about your mission orders and the contact details you provide. The data is stored internally and used to fulfill our commitments towards you and better satisfy your needs as a customer and provide you with better service. The data is stored and used for information and marketing purposes. You may, of course, have the opportunity to contact us at any time to see the personal information we store. The information is only stored for as long as it must be by applicable laws unless you have approved the continued use of the data. In case you subscribe to our newsletter, your e-mail address will be used for this purpose until you decide to unsubscribe.

Forwarding of Personal Information

Relevant personal information may be provided to transport companies or the like if this is necessary for the delivery of goods. For handling of payments, relevant personal information is provided to our partners who handle incoming and outgoing invoices. All transfers of personal information are made through very secure data connections. Your personal information is not disclosed to anyone other than those mentioned above. Information is never disclosed to third parties for marketing purposes.

Data Security

We protect our website and other systems using technical and organizational arrangements against loss, damage, access, modification or dissemination of your data by unauthorized persons.

Cookies

We use our own as well as third-party cookies for statistical purposes on the site. The use of "cookies" is a generally established way of improving user-friendliness on the Internet. Our site uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google may also transfer this information to third parties if required by law, or in cases where a third party processes the report on behalf of Google. Google will not link your IP address with other data held by Google. You can deny the use of cookies by selecting specific settings on your browser, but please note that if you do this, you may not be able to fully use the site's functionality. By using this website, you consent to Google processing your personal information in the manner and for the purposes described above.

This site also uses Google AdWords and Facebook remarketing services to advertise on third party websites (including Google) to previous visitors to our site. This may mean that we announce past visitors who have not completed a task on our site, for example, using the contact form to make a request.
