Eligibility

Artists living within 250 miles of Kent, Ohio. Original work eligible for this exhibition includes two dimensional work and sculpture created within the last two years and not previously shown at Group Ten Gallery. Two dimensional work includes: painting, drawing, collage and mixed media. Work must be suitably framed and wired to hang. **No sawtooth hangers.**
Size limit: 48" maximum length or width, including frame. 3D work can be freestanding, base mounted or wall hung.
Size and weight limit: 2' W x 2' L x 6' H - 100 lbs. max. The gallery can provide a limited number of free-standing bases. All artwork selected for the exhibit must remain in the gallery for the duration of the exhibit. All artwork must be for sale.

Not Eligible

Photographs and gicleé prints will not be accepted.

Entry Procedures

All work submitted for the exhibition must be hand delivered to Group Ten Gallery at 201 E. Erie Street, Kent, Ohio 44240. The gallery will not accept mailed or shipped entries.

Awards

There will be over \$2,000 in prize money awarded to winning entries.

Entry Fee

There is a \$40 non-refundable entry fee for up to two entries. Group Ten Gallery will retain a 35% commission on all sales of work during the exhibition. The entry fee must be paid upon delivery of entries to the gallery.

Reproduction

Group Ten Gallery reserves the right to photograph any work in the exhibition for publicity purposes.
