### **Foreword**

It has become a cliché that 2020 was a special year. Of course, for a juvenile institution like the PRCP, every year is still special. Yet, the challenges of its third year of existence, namely the challenges of engaging in work under the permanent Damocles' sword of Covid-19, were more than special; however, since everybody reading these lines has been most probably in the same boat, there is no need to belabor the obvious.

It is heartening that PRCP scholars continued the distinguished normalcy which developed during the first two years: to go after their planned research work and to present its results in widely recognized peer-reviewed journals and – after concluding major projects – highly visible books. These achievements concern all three major fields of research that PRCP is addressing, non-proliferation of weapons of mass destruction, frozen conflicts, and global power shifts. Here are some highlights:

In the non-proliferation field, the international project "Nuclear Taboo 3.0," launched in 2019, has already come to fruition, as the first-class journal International Studies Review has accepted for publication a compilation of

articles coordinated by this project. PRCP's "Frozen Conflict Dataset" has been published by the *Journal of Peace Research*, the leading journal of the academic peace research community. In the power shift field, the work on the world information interconnectedness index has attracted a prestigious PRIMUS grant to continue development.



### **Foreword**

In addition, the PRCP Experimental Lab (founded in 2019) has conducted its first survey experiments – on the use of military force – and placed the results in International Interactions, a journal known for its very high methodological standards. Maybe the number one achievement targeting the broader public was the publication in the Czech language of Nina Spitalnikova's unique study based on interviews with refugees from North Korea that turned into a bestseller which will be translated into a couple of other languages soon.

All this happened during a period of major organizational and personal transformation. In the light of such achievements, it is not surprising that PCRP passed with distinction a complex and serious institutional evaluation on the occasion of the completion of its second operational year. On the basis of this assessment, continued funding has been approved.

Academic work is not for lone wolves. An academic institution is a kind of organism brimming with communication among its parts, which gives life to the whole. Coronavirus – and this is truly special in this special year – has made fulfilling this basic requirement a technical adventure. It bespeaks the degree of integration, mutual empathy, and communicative competence within the PRCP that we managed to keep the degree of internal communication at the required and desired level without any stressful effort and to fasten the bonds that keep us together. This achievement – maybe the most important one in 2020 – is as much rewarding with regard to the past as it is promising for the future.

## FROZEN CONFLICTS DATASET

#### THREE YEARS OF HARD WORK

We singled out frozen conflicts as a category of conflicts that is neither spatially nor temporally specific. To facilitate a more holistic and rigorous study of this phenomenon, we have developed

The Frozen Conflict Dataset (FCD).

The dataset was prepared by Kamil Klosek, Vojtěch Bahenský, Michal Smetana, and Jan Ludvík as part of our research program on frozen conflicts. It was published in the **Journal of Peace Research**, in the article *Frozen conflicts in world politics: A new dataset*.

We identified 42 cases of frozen conflicts in the period from 1946 to 2011. Of those, 25 are 'traditional' interstate conflicts, whereas 17 are conflicts between a state and a de facto state.




