## Boarding Contract

- ❖ This is a contract between Georgia Dog Gym, LLC and the pet owner.
- ❖ Georgia Dog Gym, LLC agrees to exercise due and reasonable care, and to keep the kennel premises sanitary and properly enclosed.
- ❖ The pet(s) is(are) to be fed properly and regularly, and to be housed in clean and safe quarters.
- ❖ All pets are boarded or are otherwise handled, transported, or cared for by Georgia Dog Gym, LLC's staff without liability on the Kennel's part for loss or damage, from disease, theft, fire, death, escape, injury, or harm to person, other dog(s) or cat(s) or property by said dog(s) or cat(s), or for other unavoidable causes, due diligence and care having been exercised.
- ❖ Owner agrees to pay kennel \$\_\_\_\_\_ for \_\_\_\_\_ [# of pets] pet(s) per night for boarding service.
- ❖ Owner agrees to pay kennel \$25.00 for one-way transportation service should the service be requested or necessary.
- ❖ All charges incurred by owner shall be payable upon pickup of the pet(s).
- ❖ Owner further agrees that pet(s) shall not be returned to the care of the Owner until all charges are paid in full to the kennel.
- ❖ Georgia Dog Gym, LLC shall have, and is hereby granted, a lien on the pet(s) for any and all unpaid charges resulting from boarding pet(s) at the kennel.
- ❖ If the pet becomes ill or if the state of the animal's health requires professional attention, Georgia Dog Gym, LLC, in its sole discretion, may engage the services of a veterinarian of its choosing, or administer medicine, or give other requisite attention to the animal, and the expenses thereof shall be paid by owner. This includes expenses for transporting the pet if necessary.
- ❖ Owner understands that they can not pick up their pets between the hours of 1:00 pm on Saturday to 5pm on Sunday. Owner understands that Sunday pickup hours are limited to 5pm to 7pm and that there will be no exceptions to this rule.

### **Play Groups for Dogs**

- ❖ Owner understands and accepts sole responsibility for any harm caused by Owner's dog(s) while attending Georgia Dog Gym, LLC's Playgroups.
- ❖ Owner further understands and agrees that in admitting Owner's dog(s) to the playgroup, Georgia Dog Gym, LLC has relied upon Owner's representation that the dog(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
- ❖ It is further understood that Georgia Dog Gym, LLC will not be liable for any problems that develop provided reasonable care and precautions are followed, and Owner hereby releases them of any liability of any kind whatsoever arising from Owner's dog(s) attendance and participation at the Georgia Dog Gym, LLC Playgroups.
- ❖ Owner agrees that any problem that develops with Owner's dog(s) will be treated as deemed best by staff of Georgia Dog Gym, LLC, in their sole discretion, and Owner assumes full financial responsibility for any and all expenses involved.

It is understood by Georgia Dog Gym, LLC and the Owner that all provisions of this contract shall be binding upon both parties thereunto for this visit and for all subsequent visits. This contract contains the entire agreement between the parties.
