STATEMENT OF AFFILIATION AND CHRISTIAN PURPOSE

The purpose of Christ Academy (also referred to as CA) is first and foremost that God may be glorified in all things through His Son, Jesus Christ. To accomplish our mission and purpose in an educational setting, we will provide a Christ-centered education for the children of this area without distinction to race or national origin. Our aim is to provide an education:

- That is in accord with the Word of God, the Old and New Testament, which we believe to be the inspired, infallible, and inerrant rule of faith and practice;
- That is characterized by academic excellence, spiritual depth and moral integrity;
- That will prepare students for godly participation in society;
- That trains students in the knowledge of and obedience to the Word of God and promotes loyalty to God and country. The goal of the school is to lead students to a voluntary commitment of their life to the Lordship of Christ and to develop their God- given abilities to their fullest potential.

The Christian guidance and teaching offered by Christ Academy shall conform to the Holy Bible and shall be respectfully offered in a sensitive and age-appropriate manner. At the School, final authority in all matters of the faith resides in Holy Scripture with the following basic principles:

- All scripture is given by the inspiration of God that the man of God may be complete, thoroughly equipped for every good work. (2 Timothy 3:16-17)
- There is one God, the creator of heaven and earth and of all that is seen and unseen. God created all things in six days and rested on the seventh day. (Genesis 1)
- There is one person of the Father, another of the Son, and another of the Holy Spirit; but, the Godhead of the Father, Son and Holy Spirit is all one, the glory equal, and the majesty co-eternal.
- Jesus Christ was conceived by the Holy Spirit, born of the Virgin Mary and lived a sinless life. He was fully God and fully man and he was crucified for our sins. Christ did truly rise on the third day and took again His body and ascended into heaven where He now sits at the right hand of the Father until He returns to judge all men at the last day.
- The Holy Spirit is God and given to us from the Father to be our counselor and our guide. (John 12:25)
- All man is born with sin and falls short of the glory of God and deserves eternal judgment. (Romans 3:23)
- Jesus is the Way, the Truth and the Life and no one can come to the Father except through Him and the free gift of salvation that He provided with His death on the cross. (John 14:6, 1 John 5:11-12)
- God established the covenant of marriage between and man and a woman exclusively.
- Homosexuality, as shown by the Bible, is a sin against God and is counter to the teachings of the Bible. (Genesis 1:27. Genesis 2:18-25)

LIFESTYLE STATEMENT

Christ Academy is a religious, nonprofit organization representing Jesus Christ throughout the local community. Christ Academy requires its employees to be Christians, living their lives as Christian role models (Rom. 10:9–10, 1 Tim. 4:12, Luke 6:40). Employees will conduct themselves in a way that will not raise questions regarding their Christian testimonies. A Christian lifestyle should reflect the biblical perspective of integrity, appropriate personal and family relationships, business conduct, and moral behavior. An employee is expected to demonstrate a teachable spirit, an ability to share love for others, a

willingness to live contentedly under authority, and a commitment to follow the Matthew 18 principle when an issue arises with fellow employees or management.
