Pride in Defence: The Australian Military and LGBTI Service since 1945

Oral History NSW Committee member, Shirleene Robinson, has authored along with Noah Riseman this new book, available through Melbourne University Press <u>here</u>.

Since the Second World War the Australian military has undergone remarkable transformations in the way it has treated lesbian, gay, bisexual, transgender and intersex service members: it has shifted from persecuting, hunting and discharging LGBTI members to embracing them as valued members who enhance the Force's capabilities LGBTI people have served in the Australian military since its very beginnings, yet Australian Defence Force histories have been very slow to recognise this. *Pride in Defence* confronts that silence. It charts the changing policies and practices of the ADF, illuminating the experiences of LGBTI members in what was often a hostile institution.

SBS Radio and Uluru Dialogue

SBS has made the Uluru Statement from the Heart available in over 60 languages to continue the national dialogue with Culturally and Linguistically Diverse communities in their own languages. In May 2017, Aboriginal and Torres Strait Islander delegates came together at the First Nations National Constitutional Convention near Uluru and adopted the Uluru Statement from the Heart. The Statement

provides a roadmap for recognising First Nations in Australia's Constitution, proposing structural reform on three fronts; Voice, Treaty and Truth. Listen to them <u>here</u>.

The Built Form can Reflect the Community

From RAHS latest newsletter: An interview of architect Tao Gofers by Bruce Baskerville. Recorded in 2017, this wide-ranging interview gives room for the enigmatic Gofers to express his thoughts on design philosophy, architectural details and his famous <u>Sirius Building</u>.

Gofers gives insights into the technical details of his architecture, details not afforded by printed media. His solution to the noise problems created by the Harbour Bridge traffic and the Milson's Point trainline is a particular highlight given that recorded at 106db, the traffic noise is strong enough to make steel vibrate. Increasing the height of the building and sloping the building away from the bridge to bounce the sound, Gofers found a modern solution for a modern problem.
