Our vision is to be the premier mental health service agency in Galveston County and a recognized leader in promoting quality of life through community collaboration and building connections.


FSC Believes


- Every child is filled with tremendous promise.

- Every child, adult, and family should have opportunities to be happy and healthy.


Improving Mental Health

From September 1, 2021 to August 31, 2022, FSC provided compassionate care with over **14,750** sessions/service units to over **1,700** individuals through seven program areas designed to meet the needs of children, individuals, couples, and families.

Increasing Access to Hope & Healing




