For use in commercial seed treatment facilities with closed transfer including mixing, loading, calibrating and closed treatment equipment. No open transfer of SEED TREATMENT EXTRA. All seed treated with this product must be conspicuously colored at the time of treatment.

### **NOTICE TO USER**

This pest control product is to be used only in accordance with the directions on the label. It is an offence under the Pest Control Products Act to use this product in a way that is inconsistent with the directions on the label. The user assumes the risk to persons or property that arises from any such use of this product.

### **FIRST AID**

IF POISONING IS SUSPECTED, IMMEDIATELY contact a physician or a poison control centre. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

IF SWALLOWED, call a poison control centre or doctor IMMEDIATELY for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF IN EYES, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING, take off contaminated clothing, Rinse skin IMMEDIATELY with plenty of water for 15-20 minutes. Call poison control centre or doctor for treatment advice.

IF INHALED, move person to fresh air. If person is not breathing, call 911 or ambulance, then give artificial respiration, preferable mouth to mouth, if possible. Call poison control centre or doctor for further treatment advice.

### **TOXOLOGICAL INFORMATION**

NOTE TO PHYSICIAN: There is no specific antidote for this product if ingested. If ingested administer medicinal charcoal in a large quantity of water. Treat symptomatically.

### **PRECAUTIONS**

1. Keep out of the reach of children. Harmful to humans and domestic animals.
2. Harmful if swallowed, inhaled or absorbed through skin. Do not get in eyes. Avoid prolonged contact with skin. Avoid inhalation of vapours, spray mist or treated seed dust. Wash hands and face after handling.
3. Avoid contamination of feed and foodstuffs.

4. Do not apply in a way that this product will contact working or other persons, either directly or through drift. Only handlers (mixers, loaders and applicators) wearing applicable personal protective equipment may be in the area during application.
5. Treat seed in a well ventilated area. All workers (treater, cleaner, repair, maintenance, bagger, stacker, forklift operators and others) must wear: coveralls over long sleeve shirt, long pants and chemical resistant gloves. For good hygiene practice, it is also recommended to wear a NIOSH/MSHA approved dust mask during all job activities. Wear a suitable dust mask when transferring treated seed.
6. Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product. Do not reuse them. Wear freshly laundered clothes daily. Do not wear contaminated footwear. Wash clothing in detergent and hot water before reuse. Store and wash all protective clothing separately from household laundry.

#### **ENVIRONMENTAL HAZARDS**

1. This product is toxic to fish and aquatic invertebrates. Do not apply this product directly to water, or to areas where surface water is present.
2. Seed treatment active ingredient number 1 is toxic to bees. Bees can be exposed to product residues in flowers, leaves, pollen and/or nectar resulting from seed treatment applications. Dust generated during planting or treated seed may be harmful to bees and other pollinators.
3. Treated seed is toxic to birds and wild animals
4. Any spilled or exposed seed must be incorporated into the soil or otherwise cleaned up from surfaces.

#### **USE RESTRICTIONS**

1. Treated seed must not be used for food, feed or oil processing.
2. Store away from food and feed.
3. For seed treated with Seed Treatment Extra, do not graze or feed livestock on treated areas for 45 days after planting.
4. Do not plant any other crop other than soybeans within 45 days to fields in which treated seeds were planted.
5. All bags containing treated seed for sale or use in Canada must be labelled or tagged with applicable product information.

#### **DECONTAMINATION AND DISPOSAL**

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory authority.

Contact the manufacturer and provincial regulatory authority in the case of a spill and for cleanup of spills.

## **CONTAINER DISPOSAL**

For recyclable containers: Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer for the location of the nearest collection site. Before taking the container to a collection site ensure that it is empty, triple rinsed and unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

For returnable containers: Do not reuse the container for any other purpose. For disposal, the empty container may be returned to the point of purchase (local distributor/dealer).

## **GENERAL INFORMATION**

Seed Treatment Extra is a seed treatment insecticide and fungicide for use on soybeans. Seed Treatment Extra controls select chewing and sucking insects through contact and systemic activity. Seed Treatment Extra controls select seed and soil borne diseases of soybeans. Thorough seed coverage will offer the best protection of the seed from damage and disease. In addition, this formulation contains a coloring agent with will color the treated seed.

## **DIRECTIONS FOR USE**

Do not use to container aquatic pests.

Do not contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of waste.

For use in closed application systems. No open transfer of product is permitted.

Mixing Instructions: Ensure product is thoroughly mixed prior to application. Apply Seed Treatment Extra utilizing a closed system seed treating equipment. Uneven or incomplete seed coverage may not provide the desired level of insect and disease control. Follow the manufacturer application instructions for the seed treatment equipment being used. Allow the seed to dry before bagging or storing into bulk containers.

## **USE RATES**

For control of listed chewing and sucking pests, as well as seed borne and soil borne diseases of soybeans apply 200 ml of Seed Treatment Extra per 100 kg of seed.
