PAYMENT INFORMATION

Payment for your Standard, Patriot, and Junior Pointe Passes may be made in full at the time of Pointe Pass issuance, or you may pay fifty percent (50%) down with the remainder paid through monthly installments as outlined below. A service charge is applied for installment payment plans as reflected in the monthly payment. Payment is due the 1st of each month starting the second month of membership. A credit card will be kept on file for recurring monthly installments. Payments 30 days late will be assessed a \$10 Late fee and privileges suspended until payment is current.

HOUSE CHARGES & BILLING

- House account privileges can be used for Cart Fee's, In House Dining, Bar & Proshop.
- Catered Events & Room Rental Bookings are to be paid in accordance with Banquet contracts and are not eligible for House Account Billing.
- All house charges are due by the 1st of each month and considered past due on the last day of that month. Any amount 60 days past due will result in loss of Golf and Pointe Pass privileges.
