We, the undersigned, demand Immigration and Customs Enforcement (ICE) and the Stewart Detention Center take the following steps in response to the urgent problems we have collectively identified:

- 1. Fix the plumbing so that all have reliable access to hot water throughout the facility. Everyone should be able to shower with hot water. For sanitary purposes, the kitchen should have hot water too. Additionally, the broken toilets should be repaired; SDC staff have previously ignored repair requests.
- 2. Address the mold conditions found throughout the detention center. Mold growing around the facility has led to serious eye conditions.
- 3. Provide better healthcare and greater access to medical care. Cases of medical neglect and abuse have recently been reported. Individuals also have difficulty scheduling medical appointments.
- 4. Implement safe food standards and healthier food options. We currently have no option other than to eat hazardous food, including leftovers that are several weeks old and food that is rotten, moldy, and causing food poisoning. The food must also be improved to include vegetables, fruits, and proteins. The current diet is inadequate, and dangerous, especially to those of us who are diabetic or have high cholesterol.
- 5. Address issues with the law library amenities. The law library is an essential area, but we are currently denied bathroom and water access in the library.
- 6. With the current number of daily count times and lockdowns, the detention center is operating like a high security facility. Less lockdown time is needed so that we have less time stuck in our cells.
- 7. Implement greater employee accountability. Right now, employees routinely refuse to perform their duties, such as neglecting to assist with case copies and printing requests.
- 8. Remedy financial concerns. Mr. Pal reports missing \$50 from his account for several weeks without explanation.
