1) Church Planting: The focus of New Covenant Foundation is to reach people for Jesus Christ. The Church Planting Initiative supports local church planters. Instead of bringing in foreign missionaries, NCM believes that the most effective way to spread Christ's love is to enable people in their own country to minister to their own people.

2) Community Health Education: The focus is on the "preventative" not "curative" process.
