

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to zefenergy.com, ZEF Energy mobile phone applications and ZEF Energy Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to ZEF Energy Inc. include zefenergy.com, ZEF Energy mobile phone applications and ZEF. The zefenergy.com is a ev charger information and sales site. By using any ZEF website or mobile phone applications, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, ZEF may collect personally identifiable information, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

### **Sharing Information with Third Parties**

ZEF does not sell, rent or lease its customer lists to third parties.

In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. ### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by ZEF. ### **Use of Cookies**
