

No Staff - No Problem



RCW 53.12.010

"The powers of the port district shall be exercised through a port commission consisting of three or, when permitted by this title, five members"

BUT:

- Responsibilities are mandatory
- Exercising powers are voluntary

Mandatory Commission Responsibilities

Mandatory – "Must Do" Responsibilities

- Appoint a president and secretary of the commission and adopt rules for governing its business (RCW 53.12.245)
 - Revise commission districts with each decennial census (RCW 29A.76.010)
- ☐ Adopt polices for personal service contracts (RCW 53.19.090)
- ☐ Adopt an annual budget (Chapter 53.35 RCW)
- ☐ Set the annual tax levy (Chapter 53.36 RCW)
- ☐ Approve the bills (RCW 42.24.080)
 - ☐ County treasurer pay the warrants (RCW 53.36.010)

- ☐ Follow the Open Public Meetings Act (Chapter 42.30 RCW)
 - □ Annually set the time and place for meetings (RCW 42.30.070)
 - □ Attend Open Public Meeting Act training (RCW 42.30.205)
- ☐ Follow the Public Records Act (Chapter 42.56 RCW)
 - ☐ Adopt guidance for the public (RCW 42.56.040)

Exercising Powers- Six Alternatives

Alternative No. 1: Divide the Work - Assign Commissioner "Areas of Responsibility"

- Assign, by written resolution, specific areas of individual commissioner responsibility
 - Administrative duties
 - ☐ Auditor and administrative (paying the bills)
 - ☐ Consider specialized software (for example, BIAS Software Spokane)
 - □ Public records officer
 - Other duties
 - ☐ If paid, make sure there is an adequate audit trail
 - ☐ Do the commissioners really have the skills required?

- ☐ Compensation for commissioners (RCW 53.12.260)
 - ■\$114 per day "in performance of other official services or duties on behalf of the district. The total per diem compensation of a port commissioner shall not exceed \$10,944 in a year," or
 - ☐ A port commission may set compensation to be paid to commissioners
 - □ Pay Industrial Insurance premiums for each commissioner (RCW 51.08.185)

Alternative No. 2: Part-time Employees, Contracts for Services and/or Volunteers

- ☐ Part-time or "on-call" employee
 - ☐ Part-time manager
 - □ Labor (other than a public work) may be accomplished by "contract or day labor" (RCW 53.08.120)
 - ☐ Pay Industrial Insurance premiums
- Contracts for service
 - ☐ Personal services contracts not an employee (Chapter 53.19 RCW)
 - □ Independent contractor statutory test of control

- ☐ Establish a volunteer program
 - ☐ Follow the Department of Labor "safe harbor" regulations
 - ☐ Per diem stipend allowed up to 20% of normal costs
 - ☐ Pay Industrial Insurance premiums

Alternative No. 3: Pooled Resources – Other Local Governments

- ☐ The Interlocal Cooperation Act (Chapter 39.34 RCW)
 - ☐ Agreements with other governments on almost any subject
 - □ County, fire district, water district, town or tribe
- Topics
 - ☐ Office space for records
 - Meeting space
 - Manager
 - On-call employees
 - Equipment

Alternative No. 4: Agreements with other Ports

- ☐ The Interlocal Cooperation Act (Chapter 39.34 RCW)
- Shared and common resources small port to small port
 - ☐ Common meeting space
 - ☐ Meetings are allowed outside the port district (RCW 42.30.070)
 - □ Common office space
 - ☐ Common computer system
 - ☐ Common web-page
 - Common auditor
 - □ Common public records officer
- Small port to large port
 - ☐ Same but on a per function basis
 - ☐ Most ports will share their expertise and documents

Alternative No. 5: Full Operation Agreement

- ☐ The Interlocal Cooperation Act (Chapter 39.34 RCW)
 - □ Lead agency agreement with another government (port, fire district, or town)
 - ☐ One government undertakes all functions "the lead agency"
 - ☐ The other government's commission meets to set budget, set levy, collect taxes and pay total over to the "lead agency"
 - ☐ The agreement provides the detail
 - New entity agreement
 - ☐ Governments form a corporation or limited liability company
