Excellence in EMS

Program Overview

The Central Michigan University (CMU) College of Medicine EMS Fellowship is an American College of Graduate Medical Education (ACGME) accredited training program administered through the Saginaw-Tuscola Medical Control Authority.

This program is a one-year post-graduate curriculum designed to provide education and expertise in pre-hospital emergency medical systems and develop the clinical skills necessary to function as an EMS Physician.

- The Fellow will serve as an Assistant Medical Director with the STMCA and as an advisor to Mobile Medical Response, Inc.
- The Fellow will also be in charge of the Tuscola County Division of the STMCA which provides an opportunity to develop and cultivate an EMS sub-system in a manageable and productive environment.

The CMU College of Medicine EMS Fellowship provides a unique opportunity to participate in the day-to-day operations of a high performance EMS system. The Fellow is required to set aside at least two days per week to participate in on-scene and direct medical oversight. Additionally, a significant amount of time is spent working closely with the EMS Fellowship Program Director who is board certified in both EM and EMS and serves as the Medical Director of the EMS system. This provides unrestricted access to all EMS events occurring within the system. Upon completion, the Fellow will have developed both a practical and academic understanding of EMS. He or she will also have amassed extensive clinical experience due to a heavy emphasis on scene response, on-scene medical direction, and direct patient care in the field.
