5-0-30 with HydraSmart G may be applied to a wide variety of turf grasses & newly seeded turf areas. For best results apply to dry turf and water in after spreading.

**FOR General Turf Application: Apply 3.3 - 5 lbs per 1000 sq ft.**

Store in a cool, dry place, do not contaminate water by storage or disposal. For best results, apply to dry turf and water in thoroughly.
