Directions For Use. Apply only as directed.

The proper application rate depends on your soil pH and soil test level of calcium.

Sports & Recreational turf, Residential lawns: 18-0-3 may be applied to a wide variety of turf grasses & newly seeded turf areas. For best results water in thoroughly after spraying. Apply to dry turf.

For turf application: Coverage 9 000 sq ft. Apply 5 lbs per 1000 sq ft or 217.8 lbs per acre. To assure complete and even coverage apply at half rates in two directions.

18-0-3 if used as directed will provide 0.9 lb of nitrogen, 0.2 lbs of potassium and 1.0lb of calcium per 1000 sq ft with each application. It is ideal for all turf types.
