### 1. Definitions

- (c) act in good faith at all times in relation to the Discloser Confidential Information; and
- (d) not use any of the Discloser Confidential Information for any purpose other than a specified purpose by the Discloser.

The rights of the parties to terminate, rescind, or agree any amendment, waiver, variation or settlement under or relating to this Agreement are not subject to the consent of any third party.
- 5.5 Nothing in this Agreement shall exclude or limit any liability of a party for fraud or fraudulent misrepresentation, or any other liability of a party that may not be excluded or limited under applicable law.
- 5.6 This Agreement shall be governed by and construed in accordance Myanmar law.
- 5.7 The courts of Myanmar shall have exclusive jurisdiction to adjudicate any dispute arising under or in connection with this Agreement.
