





#### We have evidence that social work makes an impact



Example: The VA's Social Work Patient Aligned Care Team (PACT) Staffing Program found that integrating social workers into primary care teams at VA reduced emergency room visits and hospital admissions

In addition, the study gave 3 recommendations to policy makers:

- 1. Social workers have unique contributions to addressing patients' social needs
- 2. Social workers provide measurable value in reducing preventable urgent care use
- 3. Investing in social workers on primary care teams increases patients' access to social work services

### Policy inequities reduce access to social work services

- Lack of direct payment structure for care coordination and case management
  - Chronic Care Management and other physician-led billing codes not sufficient
- Restrictive definition in Social Security Act limits how Medicare can reimburse social work services
- Incident-to billing considerations
- Inequities in reimbursement rates by Medicare
  - Social workers get paid at 75% of the physician fee schedule while other allied health professions receive 85% reimbursement rate



### Broader challenges and opportunities

- Narrow view of social workers by the public and by healthcare stakeholders
- Erosion of health social work departments
- Workforce shortages and challenges across the board
- Increasing opportunities for expanding social work's impact within health and healthcare given focus on equity and value

## Campaign for Social Work's Value in Improving our Nation's Health

- Coming out of pandemic, Coalition recognized need for a more coordinated strategy, additional infrastructure, and momentum to address policy and practice gaps
- Sought and received funding from New York Community Trust's initiative Strengthening the Field of Social Work: Building the Capacity and Stature of the Field

### **Current Policy Efforts**

#### Legislation

- Improving Access to Mental Health Act
- Improving Access to Advance Care Planning Act
- Working with a congressional office on legislation that will help improve access to social work services

#### Regulation

- Letter to CMS to request Innovations Center study social work roles and contributions in demonstration projects
- Comments to CMS re: Physician Fee Schedule
- Working with HRSA to clarify social work workforce data and address projections of over-supply
