Prohibits manufacturing/ possessing/ transferring many semiautomatic firearms; criminal penalties; exceptions require firearm registration, restrict use

Result of "Yes" Vote: "Yes" vote prohibits manufacturing/ possessing/ transferring many semiautomatic firearms. Imposes criminal penalties. Currently owned/ later inherited firearms must be registered/ disposed of; restricts use. Exceptions.

Result of "No" Vote: "No" vote retains current law allowing manufacture, importation, possession, use, purchase, sale, transfer of semiautomatic firearms except by certain individuals; doesn't require registration of firearms.

Summary: Current law requires background check by seller for firearm purchases, bars possession by certain individuals, no registration requirement. Measure prohibits manufacture, importation, possession, use, purchase, sale, transfer of many semiautomatic firearms (including some handguns, rifles, shotguns) 180 days after measure effective; imposes criminal penalties. Measure identifies covered firearms by design feature/model name. Dealers must remove covered firearms from state or dispose them. Owners must register each currently owned or later inherited firearm with State Police, or remove them from Oregon, surrender to police, transfer to gun dealer, render inoperable. Police maintain permanent registry. Registered firearm use limited to property owned, immediately controlled by registered owner, specified locations; must be locked and unloaded during transport. Exempts public employees, law enforcement, armed forces. Other provisions.
