NCCEP Dues Structure

As an association, NCCEP will be comprised of institutional members to advance the shared goals of our college access, readiness, and success community. While additional membership categories will be added in the future, for our current GEAR UP programs, the dues structure is differentiated by the type and number of GEAR UP grants awarded to an institution. Annual membership dues will be administered on a rolling basis.

Partnership GEAR UP Grantees

The annual membership dues for a Partnership GEAR UP Grantee—typically the fiscal agent—will be the lesser of \$3,500 or 1% of their annual federal GEAR UP award.

For each additional GEAR UP grant beyond the first, a \$500 supplement will be added to the annual dues.

State GEAR UP Grantees

The annual membership dues for a State GEAR UP Grantee—typically the fiscal agent—will be the lesser of \$3,500 or 1% of their annual federal GEAR UP award.

For each additional GEAR UP grant beyond the first, a \$500 supplement will be added to the annual dues.

NCCEP Membership Dues Are an Allowable GEAR UP Expense

Annual membership dues to NCCEP are an allowable GEAR UP expense under Section 200.454 of the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, which states that the “costs of the non-Federal entity’s membership in business, technical, and professional organizations are allowable.” Although NCCEP does engage in lobbying as part of our broader organizational portfolio, we annually disclose our lobbying activities to remain in compliance with Internal Revenue Service thresholds related to not-for-profit organizations. In no circumstance will membership dues sourced from GEAR UP funds be used to support lobbying or other federally prohibited activities.
