Parish Supply

When engaging a priest for parish supply, the duties involved must be clearly stated i.e., number of daily and weekend Masses; travel between multiple Mass locations if applicable; expectations regarding baptisms, funerals, and visitation. It is important that both parties understand and agree to the specific elements of supply and that the priest providing services is justly compensated.

Live-in Parish Supply

(Includes meals, accommodation, transport/car allowance etc) \$600 per week

Non Live-in Parish Supply (no provision for meals, accommodation etc.) \$809 per week

Transport cost beyond city limits

by arrangement (inspection of logbook may be required)

Car allowance \$0.86 per km

The above stipends are guidelines and may be negotiated. We find it is best to complete negotiation before services commence. It is recommended that where a community or individual religious seeking such services has some doubt, the guiding principle should be generosity towards the member providing services.
