

# PRIVACY NOTICE

FACTS	WHAT DOES CONNECTIONS CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?
Why?	<p>Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand Connections's Privacy Policy.</p> <p>At Connections, you can be confident that your financial privacy is our top priority. This notice describes the privacy policy and practices followed by Connections. This notice explains what types of member information we collect and under what circumstances we may share it.</p>
What?	<p>The types of personal information we collect and share depends on the products or services you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>Name, address, Social Security number, and income</li> <li>Account balances and transaction history</li> <li>Credit history and credit scores</li> </ul> <p>When you are <i>no longer</i> our member, we will not share your information except as permitted or required by law as described in this notice.</p>
How?	All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their member's personal information; the reasons Connections chooses to share; and whether you can limit this sharing.

<b>For our everyday business purposes-</b> Such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus.	Yes	No
<b>For our marketing purposes-</b> To offer our products and services to you.	Yes	No
<b>For joint marketing with other financial companies.</b>	Yes	No
<b>For our affiliates' everyday business purposes-</b> information about your transactions and experiences.	No	We don't share

<b>For nonaffiliates to market to you</b>	No	We don't share

What We do	
<b>How does Connections protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How does Connections collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>Open an account or apply for a loan</li> <li>Apply for any Credit Union service</li> <li>Visit our website, provide us information on any online application or transaction, or information you send to us by email.</li> <li>Use your credit or debit card or pay your bills</li> <li>Make deposits to or withdrawals from your accounts.</li> </ul> <p>We also collect your personal information from others, including credit bureaus or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law only gives you the right to limit information sharing as follows:</p> <ul style="list-style-type: none"> <li>Sharing for affiliates' everyday business purposes- information about your creditworthiness</li> <li>Affiliates from using your information to market to you</li> <li>Sharing for nonaffiliates to market to you</li> </ul> <p>However, we do not have any affiliates with whom we share any information</p>

Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li>Connections has no affiliates</li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li>Connections does not share with nonaffiliates so they can market to you except for our joint marketing arrangements.</li> </ul>
<b>Joint Marketing</b>	A formal agreement between Connections and a nonaffiliated financial company where we jointly market financial products or services to you. <ul style="list-style-type: none"> <li>Our joint marketing partners include financial services and insurance companies</li> </ul>
