### LIABILITY RELEASE:

In addition, myself or my child or children may come in contact with water, plants, trees, insects, bees, squirrels, geese, and other materials expected to be encountered outdoors. Furthermore, Outdoor Classroom is a sponsored event by the above-mentioned School/Agency. The Agency's staff are responsible for the children participating in this event during the entire period. The Tulsa Garden Center Staff and Volunteers serve as facilitators.

As my child's or children's Parent/Guardian or myself as a school authorized participant, I understand, as the authorizing authority, that the Outdoor Classroom involves physical activities which gives rise to the risk of bodily injury or property damage. In consideration of the opportunity to participate in this program, I hereby release and agree to hold harmless Tulsa Garden Center Inc., their respective agents, contractors, employees, officers, directors, and members from any and all liability, demands, suits, actions, claims, or judgments of thereto, for any injury, damage, illness which myself and/or my child/children may sustain during or as a result of their participation in the event. I recognize the risks of injury inherent in connection with physical activities. I acknowledge that this release is being relied on by the above persons in permitting me and/or my child/children to participate, and that this release shall be binding on me, my heirs, assigns, and personal representatives.

In reference to COVID-19, I am aware of the potential spread of COVID-19 that could result in severe illness and potential death.
