and Rules are subject to change from time to time in the sole discretion of SSC. I hereby acknowledge receipt of the Policies and Rules, and I hereby agree to comply therewith if accepted for membership. I assume all responsibility for the actions and behavior of my family members, guests, invitees or any other person who enjoys rights and privileges pursuant to this Agreement and agree to be personally responsible for causing all such persons to comply with the Policies and Rules, as the same may be amended and/or revised from time to time. I acknowledge that any violation of the Policies and Rules by any person exercising the rights and/or privileges of my membership may in the sole discretion of SSC, result in remedial or other enforcement action by SSC as provided therein.

In consideration of membership, I agree to all risks associated with the use of the club facilities and agree to release SSC from and indemnify SSC against any and all claims, whether or not based on the acts or omissions of SSC, arising out of or in any way connected with the use of the club facilities by myself, my family, and my guests.. In consideration of membership, I also hereby appoint SSC as my attorney-in-fact to effectuate the redemption, cancellation, or transfer of my membership in accordance with the provisions of the Policies and Rules upon cessation of my membership by death, resignation, termination, expulsion, or under other provisions of the Policies and Rules.

I, as a condition of membership, and each of my guests, as a condition of invitation to the premises of the Club, assume sole responsibility for my and his or her personal property. I acknowledge and understand that SSC and the operator of the club facilities shall not be responsible for any loss or damage to any private property used or stored on the premises of the Club, whether in lockers or elsewhere. I also acknowledge and understand that I shall be liable for any property damage and/or personal injury at the Club, or at any activity or function operated, organized, arranged or sponsored by the Club, caused by me, any of my guests, or any of my family members. If I arrange or sponsor any activity or function on the premises of the Club, I shall be responsible for any property damage and/or personal injury even if such damage or injury was not caused by me. I agree that the cost of any such damage may be charged to my club account in the discretion of SSC.
