Dear Governor Abbott, Lieutenant Governor Patrick, Speaker Phelan, and Honorable Members of the Texas Legislature:

Our organizations represent a broad range of employers, physicians and health care providers, county officials, social service entities, and policy advocates and experts. We come together here to ask you to support increased health coverage for Texans. We specifically support a coverage initiative that is bipartisan, funded through available federal dollars, structured to be neutral for the state's budget, and designed to meet Texas' specific needs, values, and circumstances.

We write to you with urgency, with only a few weeks left in the legislative session, because we believe this issue can no longer wait. The passage of the American Recovery Plan Act (ARPA) means billions more dollars are available to Texas right now for expanded health coverage. According to recently released estimates from the Centers for Medicare and Medicaid Services, Texas will be eligible for \$3.9 billion more over two years, in addition to the increase in federal matching funds available through the remainder of the public health emergency. These dollars are in addition to ongoing enhanced federal matching dollars that provide a 9-to-1 return for Texans.

It is imperative that the Texas legislature and leadership act now to capture this additional funding. Texans cannot wait. Many continue to reel from the ongoing health, economic, and social impacts of the COVID-19 pandemic. Extending coverage to them will clearly demonstrate Texas' commitment to economic freedom and security. Access to coverage keeps hard-working people healthy and on the job; it supports entrepreneurs' efforts to start new businesses; and it protects Texans from serious financial challenges — compared to the national average, Texans are more likely than other Americans to have medical debt in collections (23% compared to 15%).

Accessing federal funds now will bring billions of vital dollars into the state budget and economy.

A range of projections by Texas researchers shows that the state can implement a budget-neutral coverage option or even save money by increasing coverage. Moreover, as pointed out in the recent letter from the Metro 8 Chambers of Commerce — the eight largest chambers of commerce in the state, representing regions with more than 20 million Texans combined — increased coverage would reduce uncompensated health care costs for local governments.

To remain competitive in the global economy, Texas simply cannot afford to rank dead last in both the number and percentage of people without health coverage. More than 1-in-5 Texans lack health insurance today, creating a huge drag on our economy and our health system. According to the [National Academy of Sciences, Engineering and Medicine](#), “It is both mistaken and dangerous to assume the persistence of a sizable uninsured population ... harms only those who are uninsured.” All Texans pay the price.

Greater health coverage also represents a lifeline for Texas’ rural communities, which have uninsured rates that far exceed urban areas. This undermines the financial stability of rural hospitals, physicians, and providers. Since 2013, at least two dozen Texas hospitals have closed in part because of high uncompensated care costs.

And access to health care coverage would help tens of thousands of essential workers who have helped get Texas through the pandemic, but whose jobs often do not come with health insurance. Further, a variety of public surveys point to widespread, bipartisan support for increased federally funded health coverage.

Texans deserve better health and access to health care — which requires health coverage. Thirty-eight other states have already expanded health care coverage. We urge you to work with other state leaders and lawmakers and our organizations this year to pass a Texas-specific solution that will insure as many Texans as possible, bring federal dollars back to Texas, bolster rural and urban economies, protect the financial viability of rural and urban health care safety-net systems, and put money into the state budget.

Thank you for your service and timely consideration on this important issue. With your leadership, we feel confident Texas can adopt a plan in short order that is rooted in Texas’ values, sustains Texas’ economic vitality, and promotes prosperity and good health among all Texans.
