#### I. ENROLLMENT

The undersigned parent(s)/guardian(s) hereby enroll the student named above for the 2019/2020 school year in the Wisconsin Institute for Torah Study.

### II. TUITION

A required non-refundable registration fee of \$800 is due with the submission of the Enrollment Contract. A \$700 check for Activities can be postdated to August 8, 2020.

A tuition adjustment of 10% will be made for additional brothers on full tuition. If one son is in the Bais Medrash, the 10% will be applied to the lower of the tuitions. The adjustment does not apply to fees. If **full** tuition, room and board is paid in full prior to August 1, 2020, a 3% adjustment will be applied.

# **III. PAYMENT ARRANGEMENTS**

If not paid in full prior to August 1, 2019 payment for tuition, room and board, may be paid in monthly, quarterly, or semi-annual **postdated checks.** A check in the amount of \$300.00 to cover the Building Fund should be postdated to be cashed on January 9, 2021. Family Assessment can be broken down into three checks of \$600 each. One check should be dated November 6, 2020, a second check should be postdated to be cashed on February 15, 2021 and a third check should be postdated to be cashed on June 12, 2021.

The "Give or Get" Family Assessment can be fulfilled by participating in the sale of raffle tickets, banquet ads or donations. If your obligation is fulfilled, your post-dated check will be returned to you.

*NOTE:* Priority registration will be provided to those families who have all payments or post-dated checks in the office no later than Tuesday, August 7, 2020. Additionally, dormitory assignments will only be provided on registration day once all payments and paperwork have been submitted.

Payments can be dated for either the 15th or the 30th of the month. The payments must begin in August 2020.

I (we) hereby agree to pay the tuition, room and board as follows:

### (CHOOSE ONE)

- [] In ten (10) monthly installments of \$\_\_\_\_\_ beginning August 15th or 30th 2020, through May 2021.
- [] In four (4) quarterly installments of \$\_\_\_\_\_\_ dated on the 15th or the 30th of August, 2020 October 2020 January 2021 and March 2021.
- [] In two (2) semi-annual installments of \$\_\_\_\_\_ dated on the 15th or 30th of August 2020 and January 2021.
- [] In one (1) advance annual payment of \$\_\_\_\_\_ dated before August 1, 2020 (reflects 3% adjustment.) (Full non-assisted tuition only.)

Building Fund postdated check is payable on January 9, 2021. Family Assessment postdated checks are payable on November 6, 2020, February 15, 2021 and June 12, 2021 (\$600 each).

### **IV. DAMAGE CLAUSE**

Any damage to Yeshiva property including the dormitory or school furniture, or to the building itself, incurred through improper use by a student is the full responsibility of the students' parents. Given the expense and difficulty of repairing damaged items, we reserve the right to replace the damaged items rather than repair them. These must be paid within 30 days of the billing statement.

## V. PERSONAL EFFECTS

WITS shall not be responsible for any students' personal effects, regardless of negligence. It is recommended that you have sufficient homeowner's or renter's insurance.

#### VI. FUND RAISING

Tuition alone cannot meet the budgetary requirements of any Yeshiva. While the administration of the Yeshiva accepts the responsibility to raise the necessary funds, it is understood that each parent will participate in supplementary fund raising activities:

### **Fund Raising Drives**

The Yeshiva attempts to raise funds in as many cities as possible. Parents are expected to assist the Rabbi's through organizing Parlor Meetings, introducing the Rabbis to potential contributors and foundations, and similar endeavors. Parents will be called upon occasionally during the year to actively participate in fundraising by contacting friends, relatives and local businesses.

### **VII. GRADUATION FEE FOR SENIORS**

All Seniors must pay a Graduation fee of \$75.00. The fee is due by May 1, 2021.

### **VIII. REFUNDS**

Each of the undersigned parent(s)/guardian(s) agrees to pay, in full, all charges for the entire school year provided by this Agreement whether or not the student is withdrawn by the parent(s)/guardian(s) of the student, or withdraws, is dismissed or is absent for any cause whatsoever during the year. The undersigned agrees that NO REFUND OF ANY TUITION OR OTHER FEES OR CHARGES WILL BE MADE FOR ANY WITHDRAWAL, DISMISSAL OR ABSENCE DURING THAT YEAR.

# **IX. ADMISSION AND RETENTION**

Retention of the student during any academic year, and reenrollment of a student for any subsequent academic year, will remain conditional upon timely performance by the student consistent with the academic and disciplinary standards of the Wisconsin Institute for Torah Study. Without termination of the obligation of the undersigned parent(s)/guardian(s) to pay the tuition as set forth above, the Wisconsin Institute for Torah Study can refuse to allow a student to attend school in the event that the undersigned fail to comply with the tuition, and/or other payment obligations as set forth in this Agreement. **TRANSCRIPTS AND GRADES WILL NOT BE ISSUED UNTIL ALL OBLIGATIONS ARE MET AS SET FORTH IN THIS AGREEMENT.** 

# X. ENTIRE AGREEMENT

This Agreement constitutes the entire Agreement and understanding between the parties, and supersedes all prior agreements, understanding and representations, whether written or oral. It shall not be modified, amended, altered or changed, nor shall any provision hereof be waived, except by written agreement signed by all of the parties to this Agreement. The undersigned parent(s)/guardian(s) hereby acknowledge that they have read and fully understand the terms and conditions set forth in this Agreement. Students will not receive admission cards without submission of this agreement.

### XI. BINDING OBLIGATION

This is a binding and irrevocable obligation to pay to the Wisconsin Institute for Torah Study the agreed tuition, and is binding upon the undersigned, their heirs, representatives and assigns the Wisconsin Institute for Torah Study. It is the position of The Wisconsin Institute for Torah Study that sending your child to the school constitutes acceptance of the terms and conditions of this contract.
