A required non-refundable registration fee of \$450 is due with the submission of this Enrollment Contract. The remaining fees of \$150 are due on August 16, 2021.

A 10% tuition adjustment will be made for additional brothers on full tuition. If full tuition, room and board is paid in full prior to August 1, 2021, a 3% adjustment will be applied.

Payment for tuition, room and board, if not paid in full prior to August 1, 2021 may be paid in monthly, quarterly, or semi-annual **postdated checks.** The "Give or Get" Family Assessment is fulfilled through the submission of a \$1,500 check postdated to June 15, 2022. This assessment may be raised throughout the year through sales of banquet ads and raffles or donations. If you choose to fulfill your obligation through these fund raising projects, your post-dated check will be returned to you. If postdated checks are not in our office by August 16, 2021, the student will not receive his dormitory assignment.

III. PAYMENT ARRANGEMENTS

Payments may be dated either the 15th or the 30th of the month. The payments must begin in August 2021.

I (we) hereby agree to pay the tuition, room and board as follows:

- In one (1) advance annual payment of \$_____ dated before August 15, 2021 (reflects 3% adjustment.) (Full non-assisted tuition only.)

IV. BREAKAGE

Any damage to Yeshiva property including the dormitory or school furniture, or to the building itself, incurred through improper use by a student will be the full responsibility of the students' parents. Given the expense and difficulty of repairing damaged items, we reserve the right to replace the damaged items rather than repair them. These must be paid within 30 days of the billing statement.

V. FUND RAISING

Tuition alone cannot meet the budgetary requirements of any Yeshiva. While the administration of the Yeshiva accepts the responsibility to raise the necessary funds, it is understood that each parent will participate in supplementary fund raising activities:

Fund Raising Drives

The Yeshiva attempts to raise funds in as many cities as possible. Parents are expected to assist the Rabbis through organizing Parlor Meetings, introducing the Rabbis to potential contributors and foundations, and similar endeavors. Parents will be called upon occasionally during the year to actively participate in fund raising by contacting friends, relatives and local businesses.

VI. **REFUNDS**

Each of the undersigned parent(s)/guardian(s) agrees to pay, in full, all charges for the entire school year provided by this Agreement whether or not the student is withdrawn by the parent(s)/guardian(s) of the student, or withdraws, is dismissed or is absent for any cause whatsoever during the year. The undersigned agrees that NO REFUND OF ANY TUITION OR ANY OTHER FEES OR CHARGES WILL BE MADE FOR ANY WITHDRAWAL, DISMISSAL OR ABSENCE DURING THAT YEAR.

VII. ADMISSION AND RETENTION

Retention of the student during any academic year, and reenrollment of a student for any subsequent academic year, will remain conditional upon timely performance by the student consistent with the academic and disciplinary standards of the Wisconsin Institute for Torah Study. Without termination of the obligation of the undersigned parent(s)/guardian(s) to pay the tuition as set forth above, the Wisconsin Institute for Torah Study can refuse to allow a student to attend school in the event that the undersigned fail to comply with the tuition, and/or other payment obligations as set forth in this Agreement. **TRANSCRIPTS AND GRADES WILL NOT BE ISSUED UNTIL ALL OBLIGATIONS ARE MET AS SET FORTH IN THIS AGREEMENT.**

VIII. ENTIRE AGREEMENT

This Agreement constitutes the entire Agreement and understanding between the parties, and supersedes all prior agreements, understanding and representations, whether written or oral. It shall not be modified, amended, altered or changed, nor shall any provision hereof be waived, except by written agreement signed by all of the parties to this Agreement. The undersigned parent(s)/guardian(s) hereby acknowledge that they have read and fully understand the terms and conditions set forth in this Agreement. Students will not receive admission cards without submission of this agreement.

IX. THIS IS A BINDING OBLIGATION

This is a binding and irrevocable obligation to pay to the Wisconsin Institute for Torah Study the agreed tuition, and is binding upon the undersigned, their heirs, representatives and assigns the Wisconsin Institute for Torah Study. It is the position of The Wisconsin Institute for Torah Study that sending your child to the school constitutes acceptance of the terms and conditions of this contract.
