CONTRACT TERMS

BOOKING/DEPOSIT: To secure a date and schedule services for makeup [and hair if applicable], a signed contract is required as well as a \$75 deposit on the date of signing. This will be applied to your total amount due on day of final payment. Deposit can be paid by cash, check (written to Ashley Bromirski) or Zelle pay to SmashArt@Gmail.com (through your trusted banking app or the Zelle pay app if your bank doesn't currently offer Zelle). Visit www.zellepay.com for more information.

CANCELATION POLICY: Cancellation of contract must be made in written format via email at least 30 days prior to your reserved date or you will be responsible for the amount of services agreed upon in this contract. Email: SmashArt@Gmail.com

CONSULTATION: Pre-wedding consultations are required for all brides to book with Radiant Beauty Makeup by Ashley (unless agreed upon prior or if circumstances do not allow). The consultation fee is a non-refundable \$100 that is due on the date of consultation. The consultation is not included in your booking minimum. Consultations are held in our home studio at 6413 Kit Creek Rd. Morrisville, NC 27560 in *Kitt's Creek Subdision*. Street parking is located in front (on the right, if facing home) due to road narrowing directly in front of home.

DELAYS: A late fee of \$25 will be charged for every half hour of delay when a client is late for a scheduled service, the allotted booking time exceeds original agreement or if client changes time of booking last minute and stylists are already on location to perform services. This will be billed to the client on the date of the wedding.

INABILITY TO PERFORM: In the event that the contracted Makeup Artist and/or Hair Stylist is unable to perform the services agreed upon due to an emergency, illness or unexpected occurrence, a trusted substitute makeup artist and/or hair stylist will be assigned and informed of the contracted and discussed arrangements. If for whatever reason a replacement is also unavailable, a full refund on deposit and/or final payment will be refunded in full (does not include consultation fee).

LIABILITY: All brushes, hair and makeup products are kept sanitary. Makeup products used are hypoallergenic. Any skin conditions or sensitivities should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. This includes any latex allergies as most lash glues contain latex. Client(s) agree to release the makeup artist <u>Ashley Bromirski</u> and hair stylist _______, if applicable

from liability for any skin complications due to allergic reactions. Extreme sensitive clients may prefer to use their own skincare and/or cosmetics to prevent complications.

MINIMUM SERVICE FEE: All weddings booked for Saturdays require a \$300 minimum service fee to book. Friday and Sunday weddings are negotiable however a minimum of \$150 will be required.

PAYMENT: Makeup Services are to be paid in full three weeks prior to the wedding date. An invoice will be provided and payment can be made in the form of cash, Zelle pay (sent through your bank to SmashArt@Gmail.com) or check made out to: Ashley Bromirski. Note: No refund will be given for members of the wedding party who cancel/miss their appointment on the day of the wedding. I also understand that I am responsible for balances from any members of my party who fail to provide payment. If time allows, anyone not listed on initial bridal agreement may be accommodated for makeup and/or hair. Payment due at time of services by cash, check or credit (for small convenience fee). A la carte services and products not previously agreed upon may also be added if time and supplies allow at an additional rate as listed in pricing PDF.

PRODUCTS/TOUCH UPS: The bride and bridal party are responsible for their own touch up products on the wedding day, including, but not limited to: lipstick, lip gloss, powder, blush, blotting sheets, etc. Individual Touch up kits will be provided to paying clients and include: 1 pre-loaded translucent powder sponge, 2 blotting papers, Q-tips and individually wrapped breath mint). Bride has the option of purchasing lipstick and/or gloss agreed upon at consultation which makeup artist will bring on wedding day (price depends on lipstick and/or gloss selected at consultation). Makeup Artist can be scheduled to remain on location for bride and bridal party touchups at a non-refundable rate of \$50/hour due at time of final payment. Exact timing and location must be agreed upon prior to wedding day. If available, additional hours can be added on wedding day, payment due at time of service.

SERVICE LOCATION AND REQUIREMENTS: Location of services(s) for the day-of-event will be at the discretion of the client however there are certain requirements the makeup artist needs for accommodation. A "set up" work area needs to be made available for both the makeup artist and hair stylist at said location. Ample lighting, preferably by means of natural light (such as a window) or lamps is necessary for services to be performed properly. Please have counters cleared prior to arrival in designated areas. Hair Stylist will need a low back chair (can be requested prior with hotel upon initial reservations if not already in room) and access to electrical outlets. Hair stylist will bring extension cord as well. If possible, it's best to have hair stylists and makeup artists in separate areas due to aerosol sprays in air during makeup application.

TIMING: The Bride will be allotted 45 minutes for makeup (time for hair determined prior with chosen stylist at consultation). The bridal party will be allotted 30 minutes for makeup. Attendants who miss their original appointment will be taken after all other services have been completed if stylists are still on site, and may incur delay fees if services are outside original booking times. Cushion time will be added for set up/break down, final touch ups and incidentals.

TRAVEL FEE: A travel fee will be charged to most locations outside the Morrisville area. Travel fees are determined based on location of venue.
