Space Agreement ~ Tamkaliks ~ 2018

1. Concession space is for all or part of the three day event. All spaces are 10' deep x 20' long, unless otherwise noted.
2. All electrical service is on a first-come-first serve basis to those who have paid their vendor fee and consists of one 110-volt outlet for each vendor. You must bring at least 300' feet of electrical cord if you are requesting electrical service. Electricity is not available until Friday, July 20th^t.
3. **Electrical service is only provided for your Concession Booth; it will not be provided for personal use in RV's, running person air-conditioners, or personal camp, etc.**
4. The concessionaire agrees to defend at its own cost and to hold harmless the Tamkaliks Committee, its members, and agents from all liability and damages resulting from the operations of your space and agrees to respect this agreement on the Tamkaliks Celebration grounds in Wallowa, Oregon.
5. The concessionaire is responsible for obtaining and paying for all state and local permits and licenses pertaining to their operation at this event. Food handler permits are required for all workers and state vendor permits (if your state requires). We honor Tribal food handler permits. Permits must be current and valid the days of the event.
6. The Tamkaliks Celebration Committee reserve the right to prohibit the display or sale of any and all items it deems inappropriate to the celebration theme. There are to be no weapons of any kind (guns, knives, throwing stars, etc.) sold to minors. This also includes toy replicas.
7. All vendors should respect the Washat Service. NO music (flutes, drums, stereos, etc.) should be played during the Sunday morning service from the start of the service until service officially closes.
8. The Tamkaliks Committee reserves the right to refuse anyone the right to sell goods if they don't meet with our traditional celebration theme.
9. Pet owners must keep their pets on a leash at all times and clean up after them.
10. No refund will be given after July 17th, 2018.
11. If an emergency arises after sending in your application, and you are unable to attend, please contact us so we do not hold a space for your booth.
12. The Tamkaliks Committee reserves the right to refuse anyone the right to sell goods if the above agreement is broken.
13. **Food vendors** need to have their application in by July 9th to be guaranteed a space.
