What Passed?

House Bill 237 passed

This measure appropriates \$860,000 to the State Department of Health (DOH) Family Health Services Division to establish and oversee peer-to-peer support programs. This funding is for two FTE positions and for purchase or service contracts with peer-to-peer based groups and addiction and child welfare peer support programs. The measure also includes the integration of infant and early childhood mental health.

House Bill 692 passed

HB692 expands eligibility to the Preschool Open Doors (POD) program to children as young as the age of two. It also repeals the requirement that POD providers be accredited.

House Bill 1194 passed

HB1194 defines the practice of midwifery, makes permanent the laws surrounding the practice, and mandates both licensure and accreditation.

HR133 was adopted

This resolution was introduced with the support of the State Office of Wellness & Resilience (OWR) to develop a report to address the developmental needs of children born during the pandemic.

HR139 was adopted

This resolution came to be at the behest of State Representative Jeanné Kapela and urges the State Department of Education, DOH, and other stakeholders to develop a plan to pursue funding for and participate in the Centers for Disease Control and Prevention's public surveillance of autism prevalence.

What Made it to the End?

House Bill 549

This measure would have established an Early Learning Apprenticeship Grant Program that would have been administered by the University of Hawai'i. The program would have provided financial support for early learning service providers to participate in state- or federally approved early learning apprenticeship programs.

The bill made it all the way to conference committee where legislators ultimately deferred the measure, citing uncertainty surrounding the federal government and funding.

Other Wins for Our Youngest Keiki

EOEL Funding

Included in the Executive Office on Early Learning's budget request was an ask for \$5.027M and 58 positions in FY26 along with \$8.236M and 108 positions in FY27. These will support 50 new classrooms across the state over the course of the biennium.

Senate Bill 1300

Our policy agenda included several bills relating to universal free school meals. While those measures did not advance, stakeholders coalesced around SB1300 which expands eligibility for free school meals over the next two years. In the coming school year, all students currently in the reduced-price category will be eligible for free school meals. In the 2026-2027 school year, all children from households with income below 300 percent of the Federal Poverty Level will be eligible as well.
