Archives Program: We collect, process, and make historical archival materials available to researchers. 2017 was a dynamic period of growth for the society's archives - growth in numbers of patrons, collections and personnel. A total of 353 researchers consulted the archives in 2017, a dramatic increase over the previous year.

Museum Program: Six years after its opening, the GLBT History Museum in San Francisco remains a key setting for the GLBT Historical Society to share our past with LGBTQ and non-LGBTQ publics and to advocate the preservation of queer history and culture. Visitors and media from around the world continue to make the museum a significant cultural destination in the city. The museum experienced a close to 25 percent increase in visitors in 2017, welcoming a total of nearly 26,000 people.
