By signing this agreement, you (the member) are agreeing to abide by all policies, procedures, rules, and regulations specified in this agreement. By signing this agreement, you (the parent/guardian) are agreeing to ensure the enforcement of the policies, procedures, rules, and regulations specified in this agreement and agree that your student is permitted to attend the State Leadership Conference with his/her local FCCLA chapter.

If the policies, procedures, rules, and regulations specified in this agreement are not followed and the chapter advisor does not act, Texas FCCLA staff will instruct the chapter advisor to contact the parent/guardian. If the chapter advisor does not address the situation in an appropriate or timely manner, Texas FCCLA will contact the chapter's school superintendent or his/her designee. Failure to uphold the included policies, procedures, rules, and regulations specified in this agreement will result in the individual attendee(s) being sent home from the conference at their expense.

This form, completed by the member and the parent/guardian, must be signed, and returned to the chapter advisor prior to the State Leadership Conference. The chapter advisor must keep each attending member's complete agreement in his/her possession throughout the State Leadership Conference and have each complete agreement available, upon request, for Texas FCCLA staff to review.

Policies, Procedures, Rules, and Regulations

Dress Code:

All attendees must abide by the <u>published dress code</u>. Attendees who are not in dress code
will not be permitted to attend conference activities. Ask your chapter advisor for additional

COVID-19:

- All attendees are required to wear a facial covering at all locations/times while participating in the State Leadership Conference.
 - o If at least 6 feet of distance can be maintained between the participant and other attendees, facial coverings will be optional during Competitive Events and while presenting on stage.
- All attendees will be required to maintain at least 6 feet of distance between them and other
 persons (not from their local chapter) throughout the State Leadership Conference. Local
 school administrators in consultation with the chapter advisor must regulate the social
 distancing requirements for individual chapters attending the State Leadership Conference.
- All attendees will practice good personal hygiene (hand washing and respiratory etiquette).
- There will be no crowding, camping, or "hanging out" permitted in the State Leadership Conference venues.
- STAR and Proficiency Event competitors will not be permitted to wait outside of their competition location more than 30 minutes prior to their scheduled competition time.
- When entering/exiting general sessions and/or workshops chapters must maintain at least 6 feet of distance between their members and members from other chapters.
- Awards will not be passed to participants on stage. Texas FCCLA will ship all earned awards and materials to chapters at the conclusion of the State Leadership Conference.

COVID-19 Safety Information

While participating in events held or sponsored by the Texas Association Family, Career and Community Leaders of America (Texas FCCLA) "social distancing" must be practiced and face coverings worn at all times (exceptions listed above) to reduce the risks of exposure to COVID-19. Because COVID-19 is extremely contagious and is spread mainly from person-to-person contact, Texas FCCLA has put in place preventative measures to reduce the spread of COVID-19. However, Texas FCCLA cannot guarantee that its participants, volunteers, partners, or others in attendance will not become infected with COVID-19.

In light of the ongoing spread of COVID-19, individuals who fall within either of the categories below should not engage in Texas FCCLA events and/or other face to face activities. By

attending a Texas FCCLA event, you certify that you do not fall into either of the following categories:

- 1. Individuals who currently or within the past fourteen (14) days have experienced any symptoms associated with COVID-19, which include fever, cough, and shortness of breath among <u>others</u>;
- 2. Individuals who believe that they may have been exposed (close contact) to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.

Duty to Self-Monitor

Participants, attendees and volunteers agree to self-monitor for signs and symptoms of COVID-19 (symptoms typically include fever, cough, and shortness of breath) and, contact Texas FCCLA at fccla@texasfccla.org if he/she experiences symptoms of COVID-19 during the activity or within 14 days after participating or volunteering with Texas FCCLA.

Liability Waiver and Release of Claims

I acknowledge that I derive personal satisfaction and a benefit by virtue of my participation with Texas FCCLA, and I willingly engage in Texas FCCLA events and/or other activities.

I HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE ANY AND ALL LIABILITY, CLAIMS, AND DEMANDS OF WHATEVER KIND OR NATURE AGAINST THE TEXAS ASSOCIATION FAMILY, CAREER, AND COMMUNITY LEADERS OF AMERICA AND ITS AFFILIATED PARTNERS AND SPONSORS, INCLUDING IN EACH CASE, WITHOUT LIMITATION, THEIR DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS, AND AGENTS (THE "RELEASED PARTIES"), EITHER IN LAW OR IN EQUITY, TO THE FULLEST EXTENT PERMISSIBLE BY LAW, INCLUDING BUT NOT LIMITED TO DAMAGES OR LOSSES CAUSED BY THE NEGLIGENCE, FAULT OR CONDUCT OF ANY KIND ON THE PART OF THE RELEASED PARTIES, INCLUDING BUT NOT LIMITED TO DEATH, BODILY INJURY, ILLNESS, ECONOMIC LOSS OR OUT OF POCKET EXPENSES, OR LOSS OR DAMAGE TO PROPERTY, WHICH I, MY HEIRS, ASSIGNEES, NEXT OF KIN AND/OR LEGALLY APPOINTED OR DESIGNATED REPRESENTATIVES, MAY HAVE OR WHICH MAY HEREINAFTER ACCRUE ON MY BEHALF, WHICH ARISE OR MAY HEREAFTER ARISE FROM MY PARTICIPATION.

ASSUMPTION OF THE RISK. I acknowledge and understand the following:

- 1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist.
- 2. I knowingly and freely assume all such risks related to illness and infectious diseases, such as COVID-19, even if arising from the negligence or fault of the Released Parties; and

3. I hereby knowingly assume the risk of injury, harm and loss associated with the Activity, including any injury, harm and loss caused by the negligence, fault or conduct of any kind on the part of the Released Parties.

I DO HEREBY RELEASE AND FOREVER DISCHARGE THE RELEASED PARTIES FROM ANY CLAIM WHATSOEVER WHICH ARISES OR MAY HEREAFTER ARISE ON ACCOUNT OF ANY FIRST AID, TREATMENT, OR SERVICE RENDERED IN CONNECTION WITH MY PARTICIPATION IN THE ACTIVITY.

As a participant, volunteer, or attendee, You recognize that your participation, involvement and/or attendance at any Texas Association Family, Career and Community Leaders of America event or activity ("Activity") is voluntary and may result in personal injury (including death) and/or property damage. By attending, observing or participating in the Activity, You acknowledge and assume all risks and dangers associated with your participation and/or attendance at the Activity, and You agree that: (a) the Texas Association Family, Career, and Community Leaders of America.
