TO THE HONORABLE JUSTICES OF THE COURT OF APPEALS:

Comes now Frediz De La Cruz-De La Cruz, Relator, and pursuant to Rule 52.1 of the Texas Rules of Appellate Procedure, files this *Petition for Writ of Mandamus* to compel Respondent, Kinney County Judge Tully Shahan, to vacate his order purporting to relieve duly appointed judges and his order precluding those judges' control over their own dockets, and would show this Court the following:

STATEMENT OF THE CASE

Relator was arrested without a warrant on October 27, 2021 for the class C misdemeanor offense of criminal trespass, enhanced (due to the disaster declaration) to a class B misdemeanor. Tex. Penal Code §§12.50 & 30.05. Relator is one of hundreds of persons who were arrested for criminal trespass as part of the Governor's "Operation Lone Star." This operation has resulted in a large number of arrests and criminal trespass cases that overwhelmed Kinney County's courts.

In light of the large number of cases, Honorable Judge Stephen Ables, the presiding judge of the Sixth administrative judicial region, appointed three additional judges to handle these cases, which they have been doing. However, on December 8, 2021, Kinney County Judge Tully Shahan abruptly ordered the termination of these appointed judges. Respondent informed them that "their services will no longer be

needed.” (Appendix, County Judge Shahan’s Order). He also ordered that his court coordinator “shall have sole authority in setting any and all court dates and docketed hearings for all cases under the jurisdiction of Kinney County.” (Appendix, County Judge Shahan’s Order). Relator has spent 56 days in jail as of December 22, 2021 with no bond hearing.

STATEMENT OF JURISDICTION

This Court has jurisdiction to issue a writ of mandamus in this cause under Article V §6 of the Texas Constitution, Article 4.03 of the Code of Criminal Procedure, and Section 22.221(b)(1) of the Government Code.

ISSUE PRESENTED

May a county judge *sua sponte* fire judges appointed by the presiding district judge of the administrative judicial region and preclude those judges from control over their own dockets?

ARGUMENT

Due to the same disaster that inspired Operation Lone Star, the presiding judge of the Sixth administrative region, former district judge Honorable Judge Stephen Ables, appointed three judges in accordance with the Court Administration Act, codified in chapter 74 of the Government Code. Judge Ables appointed judges Hon.

Vivian Torres, Hon. Genie J. Wright, and Hon. Kitty Schild. Upon appointment, these judges not only undertook to fulfill their constitutional obligations as members of the judicial branch of government, but also sought to “diligently discharge the administrative responsibilities of the office” and “rule on a case within 90 days after the case is taken under advisement[.]” Tex. Gov’t Code §74.059. These are precisely the duties these judges seek to perform.

Kinney County Judge Shahan has no authority at all regarding the judges’ performance of their duties or the terms of their appointments. He has no authority to remove them or control their dockets under the Court Administration Act. Tex. Gov’t Code ch. 74. His orders should be vacated promptly as a clear violation of the Act.

Relator remains incarcerated in the Texas Department of Criminal Justice Segovia Unit for an alleged criminal trespass. (Appendix, Probable Cause Affidavit). Relator is entitled to bond. There is no setting on his case. Respondent’s illegal removal of three duly appointed judges serves only to delay his release, prevent what is otherwise a routine bond approval process which ordinarily takes place within hours of arrest, and preclude any progress on his case. Respondent’s action is a clear abuse of discretion because Respondent lacks any authority to remove other appointed judges acting to do their jobs and fulfilling their own oaths.

Relator is entitled to a writ of mandamus if he has a clear right to relief and no adequate remedy at law. *Ex parte Chi*, 256 S.W.3d 702, 703-704 (Tex.Crim.App. 2008). “A clear right to relief is shown when the facts and circumstances dictate but one rational decision under unequivocal, well-settled (i.e., from extant statutory, constitutional, or case law sources), and clearly controlling legal principles.” *In re State ex rel. Weeks*, 391 S.W.3d 117, 122 (Tex.Crim.App. 2013)(citations omitted). Having usurped the role of presiding judge Stephen Ables, Respondent is dispensing orders well beyond his authority as Kinney County Judge. *State ex rel. Curry v. Gray*, 726 S.W.2d 125, 128 (Tex.Crim.App. 1987)(orig. proceeding). There is no remedy at all for Relator, who is forced to endure continued detention in prison unit due to Respondent’s innovative action. Respondent has none of the authority he asserts in his letter. Relator therefore has a clear right to relief, but no remedy except for a mandamus action in this Court. Accordingly, Relator seeks relief from this Court.

PRAYER

WHEREFORE, Relator prays this Court grant this petition and issue a writ of mandamus ordering Respondent to vacate his orders.

Re: Termination of Judicial Assignments and notification of upcoming hearings under Operation Lone Star.


Dear Members of the Judicial Administration under Operation Lone Star:

AFFIDAVIT and COMPLAINT FOR WARRANT OF ARREST AND DETENTION
IN THE NAME AND BY THE AUTHORITY OF THE STATE OF TEXAS

The Undersigned Affiant, who after being duly sworn by me, on oath makes the following statement:

I, **Trooper II ORLANDO DE LUNA #15053**, have good reason to believe and do believe that **DE LA CRUZ DE LA CRUZ, FREDIZ H/M DOB 05/23/1975 TB, DL/ID#** on or about the **27 th day of October, 2021** in **KINNEY** County, Texas, did then and there commit the offense of:

CRIMINAL TRESPASS - DISASTER AREA (TXPC 30.05(a))
Misdemeanor - Class A

My belief of the foregoing statement is based upon **personal knowledge**, who personally observed such offense:

On October 27th, 2021, at approximately 11:16 PM, I, Trooper Orlando De Luna Jr was assigned to the Operation Lone Star Strike Team in Kinney County. I was notified by Texas Department of Public Safety Sergeant, Ryan Glenn to assist Texas DPS SRT (Special Response Team) and Texas DPS TMU (Tactical Marine Unit) in locating 8 trespassers that had triggered DPS Drawbridge Camera THP Conoly CRK 1 (29.24888, -100.44987) at approximately 9:18 PM on the Conoly Ranch, in Kinney County. The owner of the property is William Conoly and he has a signed criminal trespass affidavit on file authorizing the Texas Department of Public Safety to arrest any/all persons located on the property without the owner's consent. I responded to the Conoly Ranch with both Texas DPS SRT and Texas DPS TMU and located a total of 8 undocumented male migrants at approximately: 29.2468400, -100.4152200. This location was agricultural land and has barbed-wire fence surrounding the entire property. The nearest boundary (29.24129, -100.40678) to the property was more than a 100-feet from where the defendant was located and from where the defendant triggered the DPS drawbridge camera. Upon questioning the defendant about the property and the owner, the defendant stated he did not have permission to be on the Conoly Ranch. Furthermore, the defendant committed the offense of Criminal Trespass during a period in which the Texas Governor has declared a disaster for Kinney County, Texas.

This offense was committed against the peace and dignity of the state of Texas.
