Trump has ordered ICE to raid our communities and round up our undocumented neighbors.

Trump "delayed" the raids to get Congress to give ICE and CBP another round of funding, and since Congress—including our own Representative, Speaker Pelosi—capitulated, the raids are back on.

Moreover, Trump has committed the US Government to a policy of "deterrence". "Deterrence" is a policy of making *coming to the United States* such a horrifying, traumatic ordeal that staying in one's own poverty-stricken, gang-ravaged country is preferable. Many presidents have attempted it, but Trump is all-in.

This is not what the United States should be!

We should be a country of freedom, of opportunity, of hope,

not a country
of trauma,
of torture,
of terror.

What you can do:


- Call Congress. Demand not one more dollar for ICE and CBP—and demand that they end reprogramming that DHS uses to fund ICE and CBP behind Congress's back.
- Show up to events like these.
- If you're religious, pray for the people in the camps.
- Give money to RAICES (bail and legal aid for immigrants in Texas),
 Pangea Legal (legal aid for immigrants in CA), MALDEF (legal aid and advocacy), or CIYJA (organizing immigrant youth).
- Know your rights in the case of an ICE raid! Ask them to slip a warrant under the door; **don't open the door unless** it's a court warrant signed by a judge (not an "administrative warrant", which is bogus).
- Add Rapid Response Network numbers (next page) to your phone's contacts. If you personally witness an ICE raid, let your local hotline know.

- DO NOT OPEN THE DOOR if an immigration agent is knocking on the door.
- DO NOT ANSWER ANY QUESTIONS from an immigration agent if they try to talk to you. You have the right to remain silent.
- DO NOT SIGN ANYTHING without first speaking to a lawyer. You have the right to speak with a lawyer.
- If you are outside of your home, ask the agent if you are free to leave and if they say yes, leave calmly.

- NO ABRA LA PUERTA si un agente de inmigración está tocando la puerta.
- NO CONTESTE NINGUNA
 PREGUNTA de un agente de inmigración si el trata de hablar con usted. Usted tiene el derecho de mantenerse callado.

- Si usted está afuera de su casa, pregunte al agente si es libre para irse y si dice que sí, váyase con tranquilidad.
