Alliance for Immigrant Survivors Public Charge Toolkit

Introduction

The Alliance for Immigrant Survivors (AIS) is a network of advocates and allies dedicated to defending and advocating for policies that ensure immigrant survivors of domestic violence, sexual assault, trafficking, and other gender-based abuses have access to life-saving protections that all survivors of violence deserve. Also known as the National Task Force to End Sexual & Domestic Violence (NTF) Immigration Subcommittee, we are active members of the NTF looking to invite other advocates to join with us to serve as a united voice that centers immigrant survivors.

On October 10, the Department of Homeland Security (DHS) posted a proposed "public charge" regulation (a Notice of Proposed Rulemaking) in the federal register, asking the public to submit comments by December 10, 2018, before it becomes final. The extreme proposal would mark a significant and harmful departure from a longstanding policy in which the government has recognized that work supports like health care, nutrition, and housing assistance help immigrant families thrive and remain safe and productive. These essential programs that allow individuals to provide for basic needs will now count against the individual in deciding whether she is likely to become a public charge and is therefore ineligible for a green card.

AIS is concerned about how these dangerous changes will impact immigrant communities, particularly certain immigrant survivors of gender-based violence and their families, including children, who use public assistance programs to escape and overcome abuse. In fact, publication of the proposed rule has unfortunately already deterred survivors who are exempted from it from accessing critical services. AIS is supporting the <u>Protecting Immigrant Families</u> (PIF) campaign which has the infrastructure and capacity to respond to the rule change with collective force. AIS will utilize PIF resources while modifying the messaging to center immigrant survivors and their families and share widely with the NTF and other stakeholders to help strengthen our impact. *This toolkit is meant to be an internal guide for advocates, please don't post or share on social media.*

AIS Topline Messages

If finalized, this regulation would be a significant and harmful departure from the current policy

Values: family, safety, safe/strong communities, wellbeing, resiliency, child welfare

Topline Messages:

- Everyone in our communities should be able to live without fear of domestic violence and sexual assault.
 - Access to health care, housing, food assistance, and other supports play a pivotal role in helping victims escape and overcome domestic violence and sexual assault.
- The use of cash assistance is already used against certain survivors applying for a green card. The harmful rule would further undermine efforts by victims of domestic violence and sexual assault to secure essential services that enable them to escape from or overcome abuse.
 - Without sufficient resources, victims are either compelled back into an abusive relationship, or face destitution and homelessness.
 - The impacts on victims and their children have long term implications for the health and safety of our communities at large.
- Some immigrant survivors are exempted from the public charge rule, including those who apply for a green card under the Violence Against Women Act and Trafficking Victims Protection Act. However, there are many survivors of domestic violence and sexual assault, along with their families, who seek immigration status under other categories who will be impacted.
 - The proposed rule does not penalize adults for use of benefits by their children, however, even U.S. born victims and victims who already have legal status are concerned that their own or their children's use of services to escape and recover from abuse will disadvantage their immigrating family members.
- All families need food, medical care, housing, and other basic services to thrive and contribute to their communities and our country.
 - This rule would jeopardize vital food, housing, medical, and other basic assistance for families, keeping victims trapped in harmful situations.
 - Due to concerns about the impact of the public charge rule on themselves and their families, many immigrant victims are starting to avoid obtaining critical benefits such as food stamps and children's health insurance.
 - We'll see the costs of dropping critical benefits in long-term health consequences from unmitigated injury and trauma that will impact survivors, their families, and the broader community.
- We believe in communities that support safety and resiliency for survivors of domestic violence and sexual assault. When families thrive, so do our communities and our country.
 - The public charge rule serves to punish survivors for the abuse they've experienced.
 Forcing survivors to choose between either seeking services to help overcome abuse, or foregoing services in order to secure lawful status, re-victimizes survivors and their children, prevents recovery, and prolongs ongoing trauma.

• We can't build stronger communities when our government purposely puts the health and wellbeing of immigrant families at risk, including immigrant survivors of genderbased violence.

Particularly when minimum wage work already places families well below the poverty level, safety-net benefits help survivors afford the basics, such as food, housing, and healthcare, and helps them rebuild their lives after violence.
