NYC voter guides will now have sign language option

Deaf New Yorkers will now have the opportunity to view voter guides in American Sign Language, according to Mayor Bill de Blasio, as the city government tries to lower barriers deaf residents may face while trying to vote.

"A strong democracy requires an engaged constituency," said de Blasio in a statement. "We want all New Yorkers to stand up, get involved and vote for the issues they care about most. The new voter guides in American Sign Language will allow more people to do just that."

There are over 200,000 New Yorkers who are deaf or hard-of-hearing, according to a statement from the Mayor's Office.

Long Island man faces up to 126 years for supplying heroin used in two fatal ODs

A Long Island man who allegedly distributed heroin and other narcotics in Queens is the first drug dealer in Queens charged with a homicide for overdose-related deaths, prosecutors say

Justin Lum, 30, allegedly supplied heroin that eventually led to the death of his 28-year-old girlfriend, Patricia Collado, as well as his 24-year-old friend, Calvin Brown. Before being arrested, Lum allegedly told an acquaintance that he could not be prosecuted because of the "Good Samaritan law. I can't get in trouble."

"Even though fatal overdoses have been on the decline in Queens County this past year, every loss of life causes undue pain and heartache particularly when the death could have been prevented," Acting Queens District Attorney John Ryan said in a statement.

Lum was arraigned before Justice Kenneth Holder and charged with 3 counts of second-degree manslaughter and multiple counts of third- and fifth-degree criminal sale of a controlled substance. Holder remanded Lum and ordered him to return to Court on Dec. 11, 2019. If convicted, he faces between 26 to 126 years in prison.

The deadly overdoses began in April 2017, when Lum allegedly gave Collado, his girlfriend, heroin while the two were at a movie theater in College Point. The two got high snorting heroin off of a cell phone, then left the theater and used more heroin inside of a car. Collado quickly passed out, so Lum pulled over at 56th Avenue and Main Street where first responders gave her Naloxone and rushed her to the hospital.

After Collado was discharged from the hospital, she and Lum went to the defendant's grandfather's house in Flushing, where they snorted more heroin. Collado went into cardiac arrest, but instead of calling 911, Lum attempted to "stabilize her" and stated in sum and substance that he "didn't want to call the ambulance again." As Collado foamed at the mouth, Lum allegedly consumed more drugs before going to sleep. Lum awoke shortly before 8 a.m. to find Collado beside him unconscious and foaming at the mouth. By the time emergency medical technicians arrived Collado was dead.

An autopsy performed on her remains concluded she died from acute intoxication due to the combined effects of fentanyl, heroin and

In March 2018, less than a year after Col-

lado's death, Lum allegedly supplied heroin to Brown, his friend, who lived in Bayside. Brown consumed the drugs at Lum's house and immediately had a medical emergency. Lum called 911 and gave Brown CPR until first responders arrived.

Brown survived the near-fatal overdose, but after he was discharged he returned to Lum's home and allegedly got more heroin from the defendant, who stated in sum and substance that the victim needed it so much that he gave it to him to get him to go home.

The next day, Brown was found dead by his mother in their Queens' home. He was in his bedroom, seated in a chair with his head slumped onto a desk.

An autopsy performed on the victim's body showed the cause of death was acute intoxication from the combined effects of heroin, alprazolam, diazepam and phenobarbital.

"Heroin, unfortunately, has made a deadly comeback in Queens Countyand throughout New York City and our nation as a whole," Ryan added. "Overdose deaths have far outpaced homicides in the last few years ... The dealers who profit from distributing these drugs bear responsibility when their clients die. This defendant thought he was safe from prosecution. He was dead wrong."

Harvey Weinstein loses bid to move trial from New York City

Harvey Weinstein has lost a longshot bid to move his sexual assault trial out of New York City, as a state court rejected Thursday the movie mogul's concerns that he wouldn't get a fair trial in the world's media capital.

A five-judge panel of the state Supreme Court's Appellate Division issued the decision after reviewing written submissions from Weinstein's lawyers and prosecutors. The panel didn't give a reason for the ruling, limiting its input on the matter to three short sentences.

Weinstein's lawyers, who suggested in court papers that the trial be moved east to the Long Island suburbs or 150 miles north to Albany, didn't immediately comment. Prosecutors declined comment.

Weinstein, 67, is due to stand trial in Manhattan in January on charges he raped a woman in a hotel room in 2013 and performed a forcible sex act on a different woman in 2006.

He has pleaded not guilty and is free on \$1 million bail. He maintains any sexual activity was consensual and his lawyer, Donna Rotunno, has said she thinks "the case itself is weak."

Motions to change the location of a trial are rarely granted, but Weinstein's lawyers argued it should have been in his case given a "circus-like atmosphere" and "hysteria" fueled by news reports and social media posts.

In court papers, they noted that their client's name was mentioned online on the *New York Post*'s gossip column Page Six more than 11,000 times.

"It is safe to say that New York City is the least likely place on earth where Mr. Weinstein could receive a fair trial, where jurors could hear evidence, deliberate and render a verdict in an atmosphere free of intimidation from pressure to deliver a result that the politicians, the activists, the celebrities and the media demand," the lawyers wrote.

Assistant District Attorney Harriett Galvin countered that Weinstein and his legal and publicity teams were fueling some of the media attention surrounding his case.

"From the beginning, the defendant's lawyers have contributed to the media cov-

erage they now complain about by making extrajudicial statements about the case, portraying the defendant as a scapegoat who has been targeted by the 'Me Too' movement, this employing the well-worn strategy of trying his case outside the court-room." Galvin wrote in court papers.

Weinstein's lawyers filed the change of venue motion in August, just weeks before his trial was scheduled to get underway. At the time, prosecutors said the request was a "transparent attempt to delay the proceedings."

But the trial was delayed anyway after prosecutors had Weinstein arraigned on a new indictment so that they could bolster their case with testimony from actress Anabella Sciorra, who has accused him of a 1993 rape.

Sciorra, known for a role on "The Sopranos," isn't one of the women whose allegations led to criminal charges against Weinstein, but prosecutors have said that her testimony is vital to supporting charges alleging he's a sexual predator who committed sex crimes against multiple women.

The Associated Press generally does not name people who say they are victims of sexual assault, but Sciorra went public with her story in a story in *The New York-er* in October 2017.

States say OxyContin maker Purdue should not pay bonuses

OxyContin maker Purdue Pharma should be prohibited from giving \$38 million in employee payouts as it goes through bankruptcy, attorneys general from 24 states, including New York, said in a court filing Thursday.

Purdue has said it needs to make bonus payments to keep employees and maintain operations at a time of high turnover, which also is requiring the company to provide severance packages for employees heading to the exits.

A government bankruptcy trustee objected to the request last week, and the bankruptcy judge has scheduled an upcoming hearing on the issue. Purdue filed for bankruptcy protection last month as it tries to settle 2,600 lawsuits against it over the toll of the nation's opioid crisis.

Members of the billionaire Sackler family, which owns Purdue, also are trying to use the bankruptcy process to halt the roughly two dozen lawsuits they face in state courts.

"As Purdue Pharma argues in court that they cannot afford to pay creditors what they owe, the company wants to hand out \$38 million in bonuses to their top executives," said New York State Attorney General Letitia James. "The company needs to be held to account, not be allowed to recklessly spend what they claim are limited funds. Our broad coalition of attorneys general is taking action today to stop this waste from proceeding."

In a statement, North Carolina Attorney General Josh Stein also blasted the idea of the company paying bonuses.

"Multi-billionaires who are giving millions in bonuses to their employees are the opposite of bankrupt," he said. "The Sacklers have extracted billions out of Purdue for their own financial profit and thrown what remains of the company into bankruptcy. Now their company wants to give millions of dollars from what's left of Purdue to Purdue executives. That's outrageous."

Thursday's filings on the bonus question come a day before the deadline on a key matter in the bankruptcy proceedings: Whether states can continue their lawsuits against members of the Sackler family.

The company has said the family members may not be willing or able to contribute the \$3 billion to \$4.5 billion they have pledged if they must face the separate state lawsuits. Including the Sackler money, the company has said the settlement offer could eventually be worth up to \$12 billion.

While attorneys general in about half the states have signed on to settlement terms, two dozen others have not and said they will push back against the tentative deal.

California Attorney General Xavier Becerra on Thursday amended that state's lawsuit against Purdue to include eight additional members of the Sackler family. The state had already sued Richard Sackler, a former company president who was a major promoter of OxyContin sales.

Nearly all the states objecting to the settlement terms have sued Sackler family members.

Pennsylvania made its own filing objecting to the bonuses on Thursday. The District of Columbia and 23 other states filed jointly. They are California, Colorado, Connecticut, Delaware, Hawaii, Idaho, Illinois, Iowa, Maine, Maryland, Massachusetts, Minnesota, Nevada, New Hampshire, New Jersey, New York, North Carolina, Oregon, Rhode Island, Vermont, Virginia, Washington and Wisconsin.

Battle for Trump's tax returns pits feds against state

Manhattan's top prosecutor pushed back against the U.S. Justice Department on Thursday in a legal battle over President Donald Trump's tax returns, saying local efforts to investigate the president's finances should be "free from federal interference."

A day after federal prosecutors asked for a delay, District Attorney Cyrus Vance Jr. filed court papers saying the Justice Department is supporting Trump's efforts to run out the clock on certain statutes of limitation that could affect a state grand jury investigation.

The move comes amid a deepening standoff in Washington after a government whistleblower alleged "inappropriate efforts to influence" the mandatory IRS audit program that's looking into Trump's tax returns and those of the vice president.

The chairperson of the House Ways & Means Committee, Rep. Richard Neal, D-Mass., said the panel on July 29 received "an unsolicited communication from a Federal employee setting forth credible allegations of 'evidence of possible misconduct'—specifically, potential 'inappropriate efforts to influence' the mandatory audit program."

The whistleblower claim comes amid the House's impeachment inquiry into Trump after another government whistleblower complained about the president's actions

toward Ukraine.

In an Aug. 8 letter to Treasury Secretary Steven Mnuchin, Neal sought documents and communications regarding specific employees at the department and the Internal Revenue Service. In a court filing, it was disclosed that Mnuchin missed the deadline to begin producing the documents.

Trump's tax returns have been a well-kept secret. He broke with U.S. political tradition as the first president in decades not to give voters a look at his financial situation. Democrats sued for their release.

Vance and Trump have been fighting over a subpoena issued this summer for Trump's tax returns as part of a criminal inquiry into the hush-money payments made to two women who claimed to have had affairs with the president.

The grand jury also subpoenaed the Trump Organization for records related to payments that former Trump lawyer Michael Cohen helped arrange to the porn actress Stormy Daniels and model Karen McDougal during the 2016 presidential campaign.

Trump has denied any sexual relationship with either woman, and said any payments were personal matters, not campaign expenses

The Justice Department on Wednesday asked a judge to delay enforcement of the subpoena for Trump's tax returns temporar-

ily so the court can consider the president's argument that he can't be investigated while in office.

The Republican president has said Vance's investigation is unconstitutional and part of an effort by elected Democrats to harass him.

Attorneys for Vance counter that Trump's immunity should not interrupt a probe that includes the actions of individuals and businesses other than Trump.

"Also of concern is the State's sovereign right to enforce its criminal laws free from federal interference," they wrote in a court filing Thursday.

They added that it was "audacious" for the Justice Department to seek a delay, considering they conducted a similar investigation last year "into some of the very same transactions and actors."

That investigation resulted in Cohen pleading guilty to federal charges that the hush-money payments amounted to illegal campaign contributions. Federal prosecutors did not charge Trump or anyone else involved in either arranging the payoffs or reimbursing Cohen through Trump's company.

The Justice Department and U.S. Attorney's Office in Manhattan declined to comment on Vance's filing.

Mining powers modern life, but can leave scarred lands and polluted waters behind

Modern society relies on metals like copper, gold and nickel for uses ranging from medicine to electronics. Most of these elements are rare in Earth's crust, so mining them requires displacing vast volumes of dirt and rock. Hard rock mining — so called because it refers to excavating hard minerals, not softer materials like coal or tar sands — generated \$600 billion in revenues worldwide in 2017.

The Trump administration has revived several controversial mining proposals that previously were blocked or stalemated. They include the Pebble Mine at the headwaters of Alaska's Bristol Bay and leasing around Minnesota's Boundary Waters Canoe Area Wilderness. It also approved a large copper mine in southern Arizona, which was subsequently blocked by a federal court ruling.

I study human-altered landscapes, including areas impacted by mines. Mining operations are major water pollution sources and can cause problems that persist for generations. Their global footprints also directly reshape significant portions of Earth's topography, leaving indelible evidence of human presence.

Digging deep and wide

In most locations, concentrations of copper, gold and other elements are too low to be extracted profitably. But in some spots they occur in seams of mineable, high-concentration minerals called ores. The economically viable concentration of a mineral depends largely on its market price. Gold ore can be viable at concentrations as low as 0.0001 percent, while copper becomes uneconomic below 0.5 percent.

To reach these deposits underground, miners tunnel, dig open pits or scrape through the Earth's surface. The choice of technique depends on factors including how consolidated the ore is, the geologic setting and the depth of the ore.

Deep mines disturb the smallest amount of surface land but are inherently more dangerous for miners. Far below the Earth's surface, crews constantly risk encountering toxic gas fumes or stale air with no life-giving oxygen. Other dangers include earthquakes and equipment failures. In 2010, 33 Chilean miners spent over two months trapped underground in a copper-gold mine after a ramp collapsed, but ultimately were rescued.

Growing international emphasis on mine safety and changes in technology and ore quality have prompted a shift from deep mining to pit mines or surface mines, which access ores from the open air. Pit mines can be up to three-quarters of a mile deep, but typically cover less than 20 square miles. In contrast, surface mines typically extend less than 1,000 feet into the Earth's crust but can extend over hundreds of square miles.

Acidic waters


Accessing ore typically involves blowing apart bedrock, removing it from the shaft or pit and storing waste materials nearby after extracting the ore. In these heaps of loose rock, known as spoil piles, previously buried raw minerals are exposed to air or water. Sulfur-rich compounds in the rock react with oxygen and water, producing sulfuric acid, which can lower the pH of nearby streams to levels comparable to lemon juice or vinegar.


At its worst this process, known as acid mine drainage, can kill most native aquatic life. If acid drainage reaches groundwater, it may persist for decades or centuries and start a cascade of other impacts that impair water quality throughout local river networks.

When acid mine drainage lowers a stream's pH, other metals can also start to melt out of minerals in spoil piles, mine shafts or adjacent soils, leaching into soil and groundwater that intersects these areas. This creates waters with increased levels of cadmium, copper, lead and other heavy metals, which are harmful to aquatic insects, fish and human health.

These effects can be transported far downstream and last for generations. Old and abandoned mines around the world have harmed water quality long after mining has ceased. Their

impacts can come as long-term slow leakage, or as sudden discharges like the 2015 Gold King spill near Silverton, Colorado, which released three million gallons of mine wastewater and debris into the Animas River.

According to the U.S. Government Accountability Office, there are at least 161,000 abandoned hard rock mining sites in the U.S. West and Alaska. Of these, at least 33,000 have contaminated water supplies or left piles of mine waste contaminated with arsenic behind.

Altering the planet's shape

Mining operations have also left thousands of square miles of land altered. In some cases, particularly mountaintop removal mining, entire land forms are permanently reshaped. For millennia the planet's surface was configured by the slow geologic processes of wind and rain. In contrast, mining alters the very geology, topography, hydrology and ecology of sites within years or decades.

These earth-moving activities represent the kind of effect that has led many environmental scientists to argue that our planet has entered a new geologic epoch — the Anthropocene — where human choices have a greater impact on the Earth than purely natural processes. Landscape evolution moves in very slow cycles, so these topographic and geologic impacts may last far longer than mining's effects on water quality. And because geologic processes are slow, scientists don't know how these landscapes will diverge or converge in their future evolution.

Essential and scarce

Like oil and gas producers, mining companies have to contend with the fact that the products they seek are scarce, and easily extractable pools have already been tapped, leading to decreases in ore quality. But demand for these metals continues to grow


Rapidly expanding green energy will require extracting vast quantities of rare earth metals to power wind turbines, electric vehicle batteries and solar panels. Cellphones, computers, camera lenses and other goods also contain these materials.

Economic imperatives lead companies to continue to push for new mines, either in the U.S. or abroad, where environmental controls may be weaker And new projects are likely to move more rock, consume more energy and have longer-lasting impacts than those that preceded them.

Ensuring that mining operations are subject to effective oversight and long-term monitoring, and that companies are held accountable for environmental damages, is a long-term challenge wherever mining takes place. The best way to completely avoid the complications that come from mining more minerals is to reduce consumption of them, make mining processes more efficient and make it more economic to recycle industrial materials and rare earth metals.

A New York City police officer killed by friendly fire during a struggle with an armed man was honored Friday at his funeral as a hero.

Officer Brian Mulkeen, who was hit Sunday by two police bullets while wrestling with the man in the Bronx, was the second New York City officer killed by friendly fire this year.

"We know we are laying to rest a hero," Mayor Bill de Blasio told mourners at the Mass

Officers in dress uniforms stood at attention as a hearse bearing Mulkeen's remains arrived at the church in Monroe, north of New York City.

Bagpipers marched silently to the beat of a somber drum; the white-gloved officers crisply saluted as Mulkeen's flagdraped casket was carried into the church

Mulkeen, who joined the department in January 2013, was working with a plainclothes anti-crime unit when he and his partners encountered the armed man.


The man fled on foot and officers chased him. Mulkeen and the man started to wrestle.

Police have described a chaotic confrontation in which 15 shots were fired in 10 seconds by six officers. Deputy Chief Kevin Maloney said five of those shots came from Mulkeen after the armed man reached toward his waistband.

The armed man was also killed in the gunfire.

Police Commissioner James O'Neill has called the situation "an absolute tragedy."

Mulkeen was a graduate of Fordham University's business school, and he worked as a financial adviser for Merrill Lynch from 2007 to 2009. He lived in suburban Yorktown Heights with his girlfriend, who is also a police officer.

Let's demand affordable housing for all

City shelters are not a longterm solution to the affordable housing crisis that has left many of our neighbors homeless. However, in New York City, homeless men, women and children have a legal right to shelter. The proposed shelter at 78-16 Cooper Avenue in Glendale, Queens has been a hotly debated issue. Opponents of the shelter that is set to provide 200 men with a place to lay their head at night, along with needed services and guidance on securing employment, have fervently organized against its opening at every step. And though there is a lot of opposition being led by the Glendale-Middle Village Coalition, with support from Councilmember Robert Holden, the fact is that too many of our neighbors are in need of housing.

This shelter will provide a temporary solution while we fight for and demand Mayor de Blasio and Governor Cuomo invest in permanent and truly affordable housing for all. All people, including those who are currently homeless, should have a right to safe and stable housing and placing our energies on blocking this shelter drives us further away from resolving the crisis we're in.

It's understandable that we all want to be safe where we live but at every instance, conversations around this proposed shelter have become so downright ugly and obscured by racist stereotypes of who we think the homeless are. In talking about this shelter, Holden has said we must "take care of our own" and that people living in the shelter "won't assimilate to our neighborhoods.'

what drives opponent's motivations to block the shelter from opening. The truth is, we have homeless neighbors who come from our district, including those who have been displaced from homes in Glendale, Middle Village, Maspeth and Ridgewood. With a median asking rent of \$2,300, this should be no sur-

This fear of the "other" is

prise. The racism on display from opponents is connected to a continuum of systemic racism that allows luxury developers free reign of our community, igniting gentrification that displaces people who have lived in the neighborhood for decades.

If we can all agree on one thing, it's that Governor Cuomo and Mayor de Blasio, along with other local elected officials, have failed us. They've failed by not committing to implementing real solutions to end homelessness. We know that the leading cause of homelessness, especially among families, is a lack of affordable housing. And with over 90,000 people homeless in New York State, we need to act now. It isn't too late but all of us need to be working together.

To address this problem, we need to tackle it at the root, in part by passing strong tenant protections like Good Cause legislation that will protect private tenants from baseless evictions that can lead to homelessness.

June, we won historic protections for tenants in New York State and we need to build on those wins by expanding rent protections to all tenants. We need our elected officials to be brave and stand up against the real estate industry by passing progressive tax solutions that will give us the resources to

create housing that is truly affordable for all. Homelessness is a societal failure and the solutions to the problem are not complicated. By creating much needed housing, we won't only be "taking care of our own," but ensuring housing for all.

LIC community board changes colors on '5Pointz' towers after library added

A Queens community board reversed its opposition to a new proposal for 5Pointz Towers — a luxury complex planned at the site of a famed former Long Island City street art mecca — thanks, in part, to a library.

The yes vote came just over two months after Community Board 2 wrote a letter to the City Planning Commission recommending denial of the application, alleging the developer had "sought every way to thwart community board review."

On Thursday night, the board made a surprise 180-degree turn - in the middle of its meeting. First, members voted 20-to-8 against the developer's application. Then they voted 23-to-5 in favor of the towers after a proposal to set aside 5,000 square feet for a library.

The space was viewed by board members as a possible replacement for the Court Square Library, which is in danger of losing its longtime home in the Citigroup Build-

The board's land use chair, Lisa Deller, said after the meeting the idea had not been previously discussed with the developers or the Queens Public Library.

The board's advisory vote marked the latest chapter in the saga of 5Pointz - the former warehouse complex that drew artists and art lovers from around the world until the owners whitewashed the walls before demolishing the buildings in 2013.

Developer David Wolkoff, who co-owns the property with his father, Jerry, filed an application with the City Planning Commission in May to build 1,100 apartments and to increase each of the complex's two towers by one floor, tweaking previous plans.

"I've been in the community over 47 years," Jerry Wolkoff told CB2 Thursday night. "The community never had a problem with me until I wanted to build this building.'

Time Warp

The presentation showed a revised apartment count with 254 studios, 595 one bedrooms, 261 two bedrooms and 12 three bearooms — a net increase of 10 apartments from the developer's initial June appearance before the board's land use committee.

Deller told THE CITY that the committee agreed to endorse the project because of certain provisions - including promises to build 220 affordable units under a 421-a tax abatement and to increase lery space by 7,000 square

The developers also agreed to pay the prevailing wage for the building's service employees, such as maintenance workers, after the complex's construction, Deller said.

"They further explained the details of the application," said Deller, addressing the board's change of heart. "A lot of our opposition was around the timing. We didn't really have time to hear it."

The Wolkoffs' application arrived in mid-June, while CB2 was in recess, leaving the full community board unable to vote on the proposal until it reconvened this month. Meanwhile, the board's review period expired on June 29.

A City Planning Commission spokesperson said the developer had requested that the commission postpone considering the application until after September.

A presentation of the proposed development on Thursday night showed numerous blank walls that would be designated for street art.

"We are trying to get street art," Wolkoff said. "Most people like it. "

Marie Cecile Flageul, a spokeswoman for 5Pointz artists, listed numerous concerns

ing for artist space or budgets for the art walls.

"History repeats itself again with CB2 voting yes under the guidance of a few 'vested members," she added.

David Wolkoff had told the land use committee at a June meeting he and his father were "pro-artist," and that they'd be open to inviting some of the 5Pointz artists to review a list of potential artists prepared by the community board.

Deller said Thursday that the board had not acted further as a liaison between the developers and artists.

"We are not involved in that dispute," Deller added.

But artist Jonathan Cohen, also known by his tag Meres One, said he had spoken to

Gerwig talks 'Little Women' for academy's women's initiative

With a new awards season underway, the Academy of Motion Pictures Arts and Sciences hosted a luncheon Wednesday supporting female filmmakers and celebrating the women behind Greta Gerwig's upcoming "Little Women"

The event, held at Rockefeller Center's Rainbow Room, drew much of New York's filmmaking elite and many of the faces likely to be seen throughout the coming season, including actors Constance Wu ("Hustlers"), Cynthia Erivo ("Harriet") and Meg Ryan; producers Christine Vachon ("Dark Waters") and Jane Rosenthal ("The Irishman"); documentarians Barbara Kopple and Laura Poitras; and "Honey Boy" director Alma Har'el.

Gerwig, actor Laura Dern and producer Amy Pascal — all collaborators on "Little Women" — discussed the hardships and joys of getting a female-led production made in an industry that has made improvements in gender parity but still lags woefully behind in equality.

Pascal, the former Sony Pictures chief, noted that today there are just as many women running studios (one, Universal's Donna Langley) as there were when she took over Sony two decades ago.

"Nothing's ever any different," said Pascal. "So how do you get a movie made like this? Everybody says no. You ask everyone else again and they say no. Then you just beg someone and make it impossible for them to say no because you have a script that is so spectacular and is so accessible and is so different and modern, and a director who just made the most amazing first film."

Gerwig's acclaimed first solo writing-directing effort, 2017's "Lady Bird," ultimately led to her becoming just the fifth woman ever nominated for best director at the Academy Awards. But none of that had happened when Gerwig first met with Pascal on "Little Women."

"Greta came to us and said, 'I'm the only one who can do this,'" recalled Pascal. "She said, 'It's all about money and women and freedom. That's it'

"I just imagine when I go meet with people who have the power to get things done, I say, 'What's the worst that can happen? They say no,'" said Gerwig. "So, I tell them I'm the

Wednesday's event, part of a women's initiative by the academy begun last year, was a moment, amid the sparkling heights of the Rainbow Room, for encouragement, inspiration and female solidarity.

"I look around and I think: We are unstoppable," said Dawn Hudson, chief executive of the academy.

Since 2015, the academy has grown its female membership from 25 percent to 32 percent. Earlier this year, its new class of inductees reached gender parity for the first time. In 10 of the 17 branches —including directing, writing and producing — more women were



invited than men.

But studies have also shown the industry isn't changing so much. Last year, just 8 percent of the top 250 films at the domestic box office were directed by women, a decrease of 3 percent from the year before, and below even the levels of 1998.

To help urge on a new generation of filmmakers, the academy has been giving fellowships to young women aspiring to Hollywood. On Wednesday, Hudson awarded the fourth such fellowship, which includes a \$35,000 grant, to Eliana Pipes, a Columbia University graduate currently studying theater at Boston University. In London on Friday, she will hand out a fifth fellowship.

Researching "Little Women," Gerwig said, made her realize that the difficulties of being a woman getting a film made today aren't so different than those Louisa May Alcott faced publishing her novel in 19th century New England.

"What was astonishing to me was how par-

allel Louisa May Alcott's experience was to the experience of trying to get a film about women off the ground today. Her publisher didn't know that it was any good. And she didn't really think it was any good," said Gerwig. "It took other women saying they were interested in it, and I think that happens today in all offices."

Dern was still buzzing from seeing "Little Women" (to be released Dec. 25) just the day before. She said the production was plainly different than most.

"As we're longing for change in all these areas, to show up on set, to show up in rehearsals and see that the space you created was not only incredibly embracing and collaborative and safe, but I saw women everywhere," said Dern, who plays Marmee March. "I saw the choices you were making each day to lift up and support other female artists, collaborators, crew."

Gerwig said those cast and crew decisions weren't based on anything but talent.

"Female filmmakers, female storytellers, female collaborators, you hire them because

they're the best ones," said Gerwig. "That's why you hire them."

The male perspective of the industry, they collectively agreed, has given rise to some absurd myths about women, among them the "difficult" actress, the "emotional" director or "infighting"-prone females.

"Have you ever been on a movie set with a bunch of men? They're fighting all the time," said Gerwig to laughter and applause. "But when women display any emotion at anything at all, they're like, 'She's crazy.' If women have an argument on the film set, it's no different than men having an argument on a film set."

The Oscar-winning filmmaker and journalist Sharmeen Obaid-Chinoy concluded the afternoon with rousing remarks drawing on her hard-fought experiences in her native Pakistan.

"I see every single day that young women are changing the way they see themselves," said Obaid-Chinoy. "And film is empowering them to do that."

PROPERTY OWNER'S MOTION TO AMEND COMES TOO LATE

Appellate Division, Second Department

Appealing a 2018 order from **Hon. Devin Cohen** of Kings County Supreme Court, Civil Term, that denied its motion for leave to amend its answer, 1829 Park Place LLC maintained that

it was not the owner of the premises where Joseph Adduci was allegedly injured when the ceiling of the building collapsed on him in June, 2014. Adduci filed a complaint against the alleged property owners on August 17, 2015. In response, 1829 Park Place admitted to being the owner at the time of the accident. Then, on Jan. 16, 2018, more than 27 months after answering the complaint and well after the expiration of the threeyear statute of limitations, 1829 Park Place moved for leave to amend its answer to deny that it was the owner of the property at the time of the incident. In support, it submitted a deed indicating that it did not

acquire ownership of the premises until March 5, 2015, eight months after the accident. Adduci opposed the motion on the grounds that he would be unfairly prejudiced by the building owner's delay. The Supreme Court denied the motion to amend. In the Appellate Division, Second Department, the justices found that 1829 Park Place did not offer any evidence as to how long it was aware of its erroneous admission, nor did it establish a reasonable excuse for its delay. Affirming the ruling of the Supreme Court, the justices determined that delay caused unfair prejudice to Adduci.

GRANDPARENTS' PETITION FOR CUSTODY DENIED

IN FAVOR OF ADOPTION

Appellate Divison, Second Department

The grandparents of a 7-month-old child placed into foster care following his mother's arrest for prostitution and child endangerment appealed an order of Hon. Diane Constanzo of Queens County Family Court that denied their petition for custody of the child. After the mother's arrest, the child was placed with a non-kinship foster family. The maternal grandparents, who lived in Maine and had previously adopted the child's older sibling, filed a petition for custody. Upon learning that the mother intended to execute a conditional surrender of the child to free him for adoption by the foster parents, the court dismissed the grandparents' custody petition without prejudice, thereby permitting them to intervene in a termination of parental rights proceeding should the mother decide not to execute the conditional surrender. The mother executed a surrender of the child on the condition that the foster parents adopt him. The justices of the Appellate Division, Second Department, determined that once the mother executed a conditional surrender of her parental rights, freeing the child for adoption by the foster parents, the Family Court properly dismissed the grandparents' custody petition as they sought only custody, not to adopt the child.

ERRORS BY TRIAL JUDGE HOLD UP APPEAL

Appellate Division, Second Department

In Queens County Supreme Court, Criminal Term, Shymeek Harris pleaded guilty to criminal possession of a forged instrument in the second degree. Appealing that judgment, Harris maintained that the Supreme Court improperly denied his motion to suppress certain physical evidence and statements he made to law enforcement officials. In their review of the record, the justices of the Appellate Division, Second Department, determined that Harris' purported waiver of his right to appeal was invalid, because when the Supreme Court attempted to explain the waiver to him, it improperly conflated the right to appeal with rights automatically forfeited by a plea of guilty. Additionally, the justices noted that although the record reflected that Harris had executed a written waiver, the court did not ascertain on the record whether he had read the waiver or discussed it with his counsel. Therefore, they concluded that Harris did not knowingly, voluntarily and intelligently waive his right to appeal. The justices also determined that they were unable to conduct an informed appellate review because the Supreme Court failed to "set forth on the record its findings of fact, its conclusions of law or the reasons for its determination" for its denial of the suppression of physical evidence and Harris's statements to police. For that reason, the matter was remitted to the Queens County Supreme Court.
