Deputy Mayor J. Phillip Thompson, NYC Census 2020 Director Julie Menin, and other city leaders urged New Yorkers to complete the 2020 Census, the first-ever census available online and by phone, on Friday.

"WITH THE CENSUS NOW ONLINE and translated in multiple languages, it's easier than ever before to stand up and be counted," said J. Phillip Thompson, the deputy mayor for strategic policy initiatives. "We urge all New Yorkers to take a few minutes to answer just 10 easy questions and help our City get the resources and representation we deserve - there's no better return on investment in our future."

"IT IS TIME TO CLOSE OUR PUBLIC schools for the safety and wellbeing of the students, teachers, and staff," he said. "This is not an easy decision, but we must take aggressive measures to stop the spread of coronavirus/COVID-19. Teaching and learning cannot take place under these circumstances. The City must immediately come up with a plan that includes childcare relief for families who need it so that our essential workers, especially healthcare workers, can continue with their duties. We must also ensure meals

and medical care are provided for students who rely on schools for these crucial services."

DUE TO THE CORONAVIRUS OUTbreak Flushing Town Hall will be closing its doors until March 29, and will be canceling or postponing all of its public events.

THE QUEENS CHAMBER OF COMmerce announced that in the wake of coronavirus, it would be pivoting from in-person events and networking opportunities to contact via phone and email. It is also looking to help businesses in extreme economic distress due to the coronavirus outbreak

bors and fellow business owners during these difficult times," Chamber CEO Thomas Grech said in a statement. "The business of doing business must continue. New Yorkers have to go to work, pay the rent, taxes, utility bills and take care of their families. CUNY and SUNY students grapple with coronavirus shutdown

On Thursday afternoon, Hunter College senior Aidan Sartori was frantically focusing lights, hanging speakers and getting a campus stage ready for a theater department show set to debut on March 25.

The day before, Gov. Andrew Cuomo announced that all CUNY and SUNY colleges more than 60 schools across the state would stop in-person classes, and use a "distance-learning," online format to help stop the spread of coronavirus. Sartori had no idea whether the show would actually go on, but no one had said anything different to him. And so, he said, he put on his "horse blinders" and continued to prep for opening night.

"Honestly I have a really hard time imagining that this is goingto go up, but we're just preceding as if we're going to go up," he told the Eagle Thursday.

That night, he learned the show had been can-

"At least I can sleep now," he said.

As the cases of coronavirus continue to rise in New York, nearly 1 million undergraduate and graduate students in the sprawling public university system are adjusting to the reality that the rest of their school year will be going much, much differently than they had expected.

State courts halt evictions, jury trials during coronavirus emergency

The state court system's chief administrative judge announced a one-week moratorium on evictions Friday and the postponement of civil jury trials and trial matters amid the growing coronavirus emergency.

In a memo to court personnel, Chief Administrative Judge Lawrence Marks suspended Civil Trial Assignment Parts, urged adjournments and remote appearances in preliminary conference parts, and prohibited non-essential travel by Unified Court System employees.

The decisions were motivated by "ongoing efforts to reduce courthouse traffic to combat spread of the coronavirus and protect the health and safety of our workforce," Marks wrote. The directive came from Chief Judge Janet DiFiore as well, he added, and is "consistent with recent action by Governor Cuomo to limit large public gatherings through the state."

The moratorium on evictions, which Marks said could end up lasting longer than the initial first week, comes as tenants' rights advocates have implored state leaders to prevent New

Yorkers from becoming homeless during the coronavirus outbreak.

The economic impact of major work slow-downs and venue closures across New York City and state will have a drastic impact on worker pay, advocates and economists say, jeopardizing rent payments for low-wage employees who live paycheck to paycheck.

Shortly after the court system announced the one-week stay on evictions, the Real Estate Board of New York and several major landlords released a joint statement vowing not to evict tenants for three months.

Richards urges city, state to delay Queens borough president special election

Councilmember Donovan Richards has asked Mayor Bill de Blasio and Gov. Andrew Cuomo to postpone the March 24 Queens borough president special election due to coronavirus concerns.

Early voting for the election was set to begin on March 14.

"We are a country that prides itself on its thriving democracy. We hold elections under the worst of circumstances, wars. and economic crisis. Never before has holding an election itself been a direct threat to the health of voters," Richards said in a statement.

In a press conference on Wednesday, de Blasio said that he was "hesitant" to change the date of the elec-

"I am really, really hesitant to change an election. Ever. For anything," de Blasio said in response to an Eagle question. "I think that's a very dangerous thing to do in a democra-

"So, we'll look at it, but I will say we'll give it a very careful look, talk to health care experts, we'll consider the dynamics,

but right now, it's not my intention to change an existing election," he added.

Two other candidates proposed alternative solutions to help people avoid large groups at their polling places.

Former Councilmember Elizabeth Crowley called for more early voting sites.

"These are trying and unprecedented times. We must be smart and vigi-

lant in making sure that our health, wellness, and democratic values are all protected," Crowley said. "I am calling on the BOE to expand the amount of early voting sites to give people the ability to access poll sites closer to their homes. I am also calling for all registered voters in Queens to be immediately mailed an absentee ballot to expand ballot access."

Constantinides called for election officials to institute a borough-wide absentee ballot program to allow all Queens residents to vote by mail during the

Councilmember Costa Constantinides said all voters should be supplied with absentee ballots and urged the city not to halt the elec-

"We can keep our residents safe and maintain our democracy at the same time." he tweeted. "There is no immediate evidence that the number of coronavirus cases will decrease any time soon. Indefinitely postponing elections would be a grave mistake."

Crowley and Constantinides both announced Thursday that they would suspend in-person cam-

Virus darkens stages, silences orchestras across the U.S.

The stage at the Fifth Avenue Theatre in Seattle is quiet. There is no music coming from the Boston Symphony Orchestra and the members of Pearl Jam won't tour. There is no one to admire the treasures at the Metropolitan Museum of Art in New York.

The ongoing fears surrounding the coronavirus have shuttered places where Americans — and foreign visitors — have long gathered to escape the world and also to engage with it. Almost everything that draws crowds has now sent them all

Wisconsin resident Ellen Moodie, 58, found herself in New York, twice rejected. She came for the Big East tournament at Madison Square Garden, but that was canceled. So, she tried to catch a Broadway show, but those too were canceled. She admitted to being a little disappointed.

"We would love to see a show but understand the situation," she said.

The list of venues where Americans can no longer find entertainment or diversion continues to climb so far scrapped or shuttered are everything from Coachella to Carnegie Hall, Major League Soccer, Disneyland and the John F. Kennedy Center for the Performing Arts.

Bob and Diane Erickson, of Cambridge, Minnesota, were taking no chances Thursday, hitting all of Nashville's major tourist destinations that were unaffected thus far.

"We're just kind of watching it," said Bob Erickson. "And frankly, it's going to get bigger.'

The closures of museums and theaters and concerts come even as families find their kids locked out of school with nothing to do and arts institutions worry about keeping the lights on without ticket sales.

"It's the people that are down here, trying to earn that dollar, that it's going to affect the most," said Mike Beliles, of Wilmington, North Carolina, who was visiting Nashville. "It's the people who are trying to make ends meet, and they aren't able to work."

For most people, the coronavirus causes only mild or moderate symptoms, such as fever and cough. For some, especially older adults and people with existing health problems, it can cause more severe illness, including pneumonia.

The vast majority of people recover from the new virus. According to the World Health Organization, people with mild illness recover in about two weeks, while those with more severe illness may take three to six weeks to recover.


Apprehension of the virus has claimed an astonishingly varied list of events stretching beyond the traditional arts, from the Houston Livestock Show and Rodeo to the New York International Auto Show. Big events in big venues like the NBA season and NCAA basketball tournaments were felled by coronavirus,

but smaller and less raucous get-togethers were also abandoned, too.

Around the country, bookstore appearances by James McBride, Louise Erdrich and many others were postponed or canceled during what is usually one of publishing's busiest seasons. The prize-winning author and illustrator Gene Luen Yang called off the tour for his graphic novel "Dragon Hoops."

The Brooklyn Public Library suspended or postponed all public programs until at least the end of the month. Jakab Orsós, the vice president of arts and culture, called the move the "only responsible action we could take." He said the virus is making those in the world of culture

"It's a bitter lesson, that we are not the rulers of the universe. We got very comfortable, thinking we could overcome everything. Sometimes we have to learn that there are stronger powers. It's larger than culture, it's universal," he said. "We have to change course. Whatever that is - we have to learn this message. This is a huge and important lesson, especially in the Western

Gov. Andrew Cuomo on Thursday banned gatherings of 500 or more in the city, effectively forcing the hand of Broadway producers who had previously said that Broadway would be "open for business" unless advised not to by the government. Shows are now slated to resume the week of April 13.

Would-be theater attendees were turned away in the theater district, some shaking their heads in disbe-

"I had been hoping to catch one but it's all canceled," said Quinn Heath, 24, who was visiting from

Closing all Broadway theaters for a month is unprecedented, said Laurence Maslon, an arts professor at New York University's Tisch School of the Arts. "Nothing comes close to this amount of time ever."

Other theaters far from Broadway have closed their doors, including the Wallis Annenberg Center for the Performing Arts in Southern California, which canceled or postponed all productions and programs through March 31. Coronavirus has altered the run of "Guys and Dolls" at the Ford's Theatre in the nation's capi-

The Fifth Avenue Theatre in Seattle closed the doors on "Sister Act," citing the state's mandated cancellation of public gatherings, and is now asking for donations to recover

\$1 million in losses. The 1.600-seat Curran Theater in San Francisco decided to scrap performances of "Harry Potter and the Cursed Child."

Actors' Equity Association, which represents more than 51,000 actors and stage managers nationwide, called the decision to shutter Broadway "important" and urged lawmakers to come to the aid of workers in the arts.

"Today's decision means tremendous uncertainty for thousands who work in the arts, including the prospect of lost income, health insurance and retirement savings," the group said. "For every middle-class actor you see onstage, there are dozens of other workers behind the scenes and in an administrative capacity.'

The virus' arrival came just as Americans shake off the winter blues and plan spring events - concerts, games and shows. But no more.

"This is one of the hearts of the season where we have really a lot going on," said New York Philharmonic President Deborah Borda. "It is going to be an enormous financial challenge, involving millions of dollars for all of these institutions.'

Coronavirus could hit homeless hard, and that could hit everyone hard

As the number of cases of COVID-19, the illness caused by the coronavirus, continues to grow, the nation is on edge. Doctors and scientists do not know what percentage of the general population has been infected and what percentage of the infected develops symptoms.

State and local governments and the federal public health system are deploying strategies to contain the spread of the virus and consider ways to mitigate the effects of the disease on vulnerable groups, the health care system and the economy.

But amid all the planning, and a growing sense of panic, the impact of the spread of COVID-19 among homeless people is not being widely discussed. It should, however, be of special concern to local officials.

I am a professor of preventive medicine and health policy at the Keck School of Medicine at the University of Southern California. USC is in Los Angeles, which has one of the largest homeless populations in the nation. I am concerned about how infectious disease could undermine our efforts to provide humane care to homeless people and assist them to get off the streets and into stable housing.

I am also deeply concerned about infection rates and mortality more generally among vulnerable populations.

A vulnerable group, even when the economy is humming

More than half a million people are homeless in the U.S. Their living conditions and poor health may place them at higher risk for contracting the disease and dying from it, although as of this writing, there have been no reported cases among homeless people.

High rates of infectious diseases among people experiencing homelessness is hardly new. Since those of us who work with the homeless have been keeping data, we know that homeless people have a higher risk of tuberculosis, hepatitis, HIV and pneumonia. This should give government officials and health providers cause for concern that the coronavirus may also spread among the homeless.

While it's too early for specific studies, the conditions of homelessness may increase the risk of transmitting the coronavirus to homeless people and ultimately its spread to others in the community.

COVID-19 is a respiratory illness. People get it when an infected person sneezes or coughs, spreading droplets in the air that could be transmitted to others. The Centers for Disease Control and Prevention has recommended staying away from others who are sick, avoiding crowds and proper hand-washing. The agency also suggests that since the virus lives on surfaces for at least several hours, people should avoid touching surfaces that others may have touched.

These practices, however, are nearly impossible for those living on the streets who have no way to bathe or wash hands. Few encampments have portable toilets or sinks. People eat, sleep and congregate close to each other.

Those in shelters may fare a little better, if the shelter does frequent cleaning or provides access to bathrooms and hot water and hand sanitizers, which many do not. Even so, in many shelters, people sleep, eat and participate in activities in groups, which increases the risk of an exposed person transmitting the virus to those nearby.

In addition, many shelters are large spaces with cots or beds placed in close proximity. In the winter months, homeless people are often transported by bus to winter shelters. Both the buses and mass shelters are almost designed to spread airborne droplets, putting guests and those who work there at risk for transmission.

Those working in shelters may have limited training in prevention, or a way to identify and isolate an individual showing signs and symptoms of COVID-19.

Many homeless people who do not stay in shelters may sleep in train or bus stations, ride subways or buses or go the waiting room of a hospital emergency department for the evening. These are places where an exposed person could contaminate doors and bathroom fixtures, chairs or other objects, providing

opportunities for spreading the infection to others.

Once exposed, homeless people may have mortality risk due to other health conditions they may already have, such as diabetes, hypertension, cardiovascular disease and increased age. Many people living on the street already have diminished health, have higher rates of chronic illnesses or have compromised immune systems, all of which are risk factors for developing a more serious manifestation of the coronavirus infection. Those who suffer from mental illness may have difficulty recognizing and responding to the threat of infection.

Homeless people have less access to health care providers who could otherwise order diagnostic testing and, if confirmed, isolate them from others in coordination with local health departments.

Without access, ill homeless people may be living on the streets and virtually unknown to the health care system and possibly exposing others to the virus. Homeless persons showing symptoms of COVID-19 may go to a crowded hospital emergency department, which even before the coronavirus is where many homeless people go to for health care services. But if the epidemic continues to spread, these facilities will become even more crowded, and wait times will increase potentially exposing more people to an infected individual who has come seeking care.

Too important to be ignored

Prudent action to contain the virus that targets this population makes sense, given the risk that this population pos-

es for the spread of the virus and the impact on the health care system.

A few communities are just beginning to put in place efforts to help prevent the spread of the coronavirus among the homeless population. In Seattle, officials are distributing hygiene kits and provide tips and checklists on prevention to shelter operators. Many of these activities are core public health functions that any local and state government agencies should be doing routinely as a part of their core surveillance and health assurance efforts.

But most localities do not have the resources available for new and widespread screening among homeless people or ways to locate and respond to an outbreak unless patients present in the hospital emergency department.

Public health agencies at all levels of government have a role to play in mitigating the effects of the coronavirus. If public health agencies from local governments to the CDC do not have capacity because of budget cuts or a lack of commitment, local jurisdictions will not have the tools necessary to reach out to those at risk that will be necessary to contain the virus and mitigate its effects on our most vulnerable groups.

Late-night comics adjust to shows without an audience

Due to the new coronavirus, late-night comedians — Stephen Colbert, Jimmy Fallon, Pete Buttigieg — are taking to the stage without the affirmation of adoring audiences.

Wait a second. Pete Buttigieg?

The former presidential candidate filled in for Jimmy Kimmel on Thursday night on ABC. It was prearranged, since Kimmel was taping episodes of "Who Wants to Be a Millionaire," but the timing was unfortunate. Each of the three shows decided only hours before taping on Thursday to go without an audience, save for handfuls of staff members.

"Everyone is spread apart at the CDC-recommended distance," said Buttigieg, whose husband was sitting among the empty seats.

Buttigieg, a Democrat who sought the presidency, had the chief job qualification of a latenight host, circa 2020. He was more than willing to tell biting jokes about President Donald

"When you don't have a real audience, you have to fake one," he said. "Just like Trump's inauguration.'

During his monologue, producers cut to film clips of enthusiastic audiences, from awards shows or the State of the Union address.

As an amateur, Buttigieg was more than willing to blame lame jokes on the writers. Colbert noted when a punchline got a response from his meager audience that he was paying most of them. Questlove of the Roots was the chief arbiter of Fallon's jokes that landed or were fed to a paper shredder.

Going without an audience "might be a good thing," said Colbert, who was out of breath after a brief run through the empty seats. "In my mind, all of my jokes are perfect. The only person that ever disagrees with me right now is the audience."

They were not the only television shows to dispatch with audiences. On "The View," a meager crew of staff members tried vainly on Thursday to replicate the noise that would normally come from a full crowd of

Goldberg said.

"All three of you," Joy Behar tartly said.

Fallon took a serious turn to start his "Tonight" show monologue which, like Colbert's, was performed seated behind his desk.

"Like you, I'm watching the news and I'm just as confused and freaked out as you are right now," he said. "I know the [Trump] speech last night didn't help. But I know that when we're here for each other, we're at our best, and I'm here for you."

Both Fallon and Colbert brought on television doctors - Mehmet Oz and Sanjay Gupta - for sharp and informative segments, asking basic questions about the virus and preparedness that often go overlooked on news programs. Both doctors used hand sanitizer to instruct viewers on the thorough, most effective way to wash hands, reminding people not to forget their thumbs.

The doctors were also blunt in discussing their disappointment that the United States seemed unprepared to test all who want to

"Should we have been preparing for the last six weeks?" CNN's Gupta said on Colbert's "Late Show." "For sure. Did we? It doesn't seem that way."

Fallon and Colbert also picked the exact same segments of Trump's speech to mock: the "hot mic" moment when the president appeared to relax after the speech was done, and when he stumbled on the word "counting."

While the Dixie Chicks' scheduled appear-

ance with Colbert was postponed, Mandy Moore performed to empty seats on the "Tonight" show, and Jhene Aiko and Miguel were introduced by Buttigieg. Moore, gamely, called it a "slightly elevated rehearsal."

Actor Dane DeHaan, on "Tonight," also took the empty studio in stride.

All of the hosts were self-conscious about the different circumstances. Fallon took an artsy approach by ending the show with a short segment that showed the on-air talent winding down amid the quiet vibe, as he put his feet up on the couch next to him. His show is going on hiatus until March 23.

Colbert — whose show is on hiatus until March 30 — occasionally took sips from a glass half-filled with a brown liquid he said was bourbon. Whether or not that was true, it appeared to relax him.

"Right now," he said to the camera, "I'm imagining your laughter."

Madoff seeks to make 'dying, personal plea' for release

Ponzi schemer Bernard Madoff wants to make a "dying, personal plea" by telephone to a judge to request early release from his 150-year prison sentence, his lawyer said Thursday.

Attorney Brandon Sample told Judge Denny Chin that Madoff, 81, and confined to a wheelchair, should be allowed to contest claims by prosecutors that he has failed to show remorse for his decades-long scheme to cheat thousands of investors out of billions of dollars.

Prosecutors filed papers last month in Manhattan Federal Court, opposing the request by Madoff for compassionate release. They noted that 500 victims opposed early release for a man suffering from kidney disease. Only 20 letters were written by victims in support of release, prosecutors said.

The federal Bureau of Prisons has agreed that less than 18 months to live but has denied early release on the grounds that it would minimize the severity of his crime.

Chin, who still presides over the Madoff case even though he is now a Federal Appeals Court judge, sentenced Madoff in 2009 after the once highly-respected financier admitted to squandering \$17.5 billion entrusted to him by investors worldwide. A trustee has recovered nearly \$14 billion for

Sample said the judge would benefit from "hearing directly from Mr. Madoff about his acceptance of responsibility.

"Allowing Mr. Madoff to give what is, in effect, a final dying, personal plea is imminently [sic] reasonable," Sample

Mayor can order marshals to halt evictions: oversight committee

Only state legislative action can officially halt evictions in New York City, but members of a committee that oversees city marshals say Mayor Bill de Blasio can keep people in their homes by simply ordering the marshals to stand down.

State lawmakers are now considering a bill that would establish a moratorium on evictions as major coronavirus-related work slowdowns lead to lost wages for low- and middle- income workers. Though de Blasio has discussed indirect methods for preventing eviction, members of the Mayor's Committee on City Marshals say he can effectively stop evictions in New York City by directing city marshals not to eject people from their homes. The 14-member committee develops qualifying criteria for appointees and makes nominations to the marshal service, which is regulated by the Department of Investigation.

"It's such an easy fix," said Legal Aid Staff Attorney Sateesh Nori, a committee member who leads a team of lawyers in Queens Housing Court. "The Department of Investigation is under the mayor, the Department of Investigation oversees the appointment and maintaining good standing of marshals, so why can't they say, 'Everyone stop for two weeks, three weeks or a month.""

The Mayor's Office did not respond to direct questions about whether de Blasio would order marshals to halt evictions. A spokesperson pointed to comments de Blasio and Deputy Mayor Vicki Been made at a press conference Thursday.

"We want to do everything we can do, but we have to make sure we're on firm legal ground," said de Blasio, shortly after announcing a state of emergency.

The city has halted evictions for most NY-CHA public housing tenants, but de Blasio and Been hedged on what the city could do to help people who are getting kicked out of private-sector housing. They said the city will continue providing legal assistance — a resource that is already available to certain low-income tenants through the right-to-counsel program.

"We are clearly, for anyone that needs the legal help, we're going to do that for some people — we can't necessarily do it for everyone," de Blasio said.

"For some people who need the financial help, we can help," he added. The city currently

provides emergency cash assistance for people at risk of becoming homeless through the One-Shot Deal grant program, which can help cover back rent or unforeseen expenses that could jeopardize an individual's ability to pay rent. Those grants can take 30-45 days to come through, however.

Nori, from Legal Aid, said he was aware of two people who had already received eviction judgements in Queens Housing Court Friday morning. "What will they do? Do they go to a crowded shelter?" he said.

Another member of the Mayor's Committee on City Marshals, Celina Cabán Gandhi, said she, too, supports the idea of ordering marshals to halt evictions. Cabán Gandhi is a staff attorney at a New York-based legal service organization.

She told the Eagle that halting evictions would also benefit "the employees of the Marshals' offices who may be putting themselves at risk to virus exposure with their field work."

"It's a public health issue. The marshals are at risk," Nori added. "They're going from house to house evicting people."

Committee Chair Charles DeStefano did not respond to an email seeking comment for this story. In an email exchange shared with the Eagle, DeStefano suggested that such a recommendation seemed to be outside the purview of the committee.

DOI, which oversees the marshals, did not re-

spond to an email seeking comment.

State lawmakers introduced legislation to halt evictions on Thursday, following advocacy by the Housing Justice for All coalition, a statewide network of tenants' rights groups. The legislation was introduced by State Sens. Brad Hoylman and Brian Kavanagh.

Hoylman said he also supports the effort to order marshals to halt evictions.

"We need to take every step possible to keep New Yorkers in their homes," he told the Eagle. "Evictions and foreclosures aren't just cruel during this emergency they are a threat to public health."

State Sen. Julia Salazar and 23 other senators sent a letter Thursday to Chief Judge Janet DiFiore urging the state court system to "issue a moratorium on evictions immediately."

She said she supports the proposal for the mayor to order marshals to stop evicting tenants.

"Housing security is a public health issue, and one that will be exacerbated during this crisis if we don't take necessary steps to mitigate it," she said.

The head of a major landlord group said he supports the moratorium, as well. Community Housing Improvement Program President Jay Martin told THE CITY that "members are willing to do whatever is asked of them by the government"

Martin said members of CHIP, which primarily represents landlords of rent-stabilized apartments, are "extremely sympathetic to the health concerns" of coronavirus. He also urged state law-makers to include landlords in eviction moratorium discussions.

First COVID-19 death in New Jersey was veteran horseman

The first person to die in New Jersey from the new coronavirus disease was a longtime fixture in the harness racing industry, and his death has prompted the closure of a track outside New York City.

John Brennan died Tuesday at Hackensack University Medical Center, about a week after he had reported to his primary care doctor with a fever and cough. Brennan, 69, lived in Little Ferry, a New Jersey suburb just north of the Meadowlands sports complex, about 5 miles west of New York City.

He worked at Yonkers Raceway, a harness racing track that is just 4 miles from the center of one of the largest pockets of the virus in the U.S., in the New York suburb of New Rochelle.

Brennan worked for many years as a harness racing trainer before becoming a field representative for the Standardbred Owners Association of New York, a job in which he represented drivers in disputes with track management.

Officials in Bergen County, New Jersey, didn't identify Brennan when announcing his death Tuesday. A close friend of Brennan's confirmed his death to The New York Times.

COVID-19 usually presents only mild or moderate symptoms, such as fever and cough, and the vast majority of people recover. But for older adults and people with other health problems, it can be worse. New Jersey health officials said Brennan had underlying medical conditions, including diabetes and high blood pressure.

In a statement Tuesday, MGM Resorts International, which owns the track and adjacent casino, said the track would be shut down, and it

urged employees to self-quarantine. Brennan was believed to have last visited the track March 2, according to the statement.

"We will continue to coordinate with and follow the guidance of health officials and support them in their response and prevention efforts," the company said.

Associates of Brennan remembered a larger-than-life figure who hailed from Queens and brought some big-city attitude with him.

"He was just a fun-loving guy who had a great sense of humor," said John Campbell, the highest-earning driver in harness racing history, who drove horses trained by Brennan at New Jersey's Meadowlands Racetrack. "As a trainer, he was a good horseman; he really understood the game."

Brennan's job as field representative would require him to attend races almost every night, Campbell said.

Retired driver Bill O'Donnell, the head of the Central Ontario Standardbred Association, was friends with Brennan since the late 1970s, when they met at the track in Saratoga, New York. O'Donnell said that he drove Brennan-trained horses through the 1980s and '90s and that the two men developed a close friendship.

"He was a big, gruff guy, but he had a heart as big as the sky," O'Donnell said. "In other words, a typical New Yorker."

Brennan's neighbors in Little Ferry said they were surprised and alarmed by news of his death.

"It's a little nerve-wracking," said Christine Voto, who said Brennan had been sick for about two weeks and "did not look well."

"Yes, people die from the flu, but this is something altogether different," she said.





CUNY and SUNY students grapple with coronavirus shutdown

With classes cancelled until March 18, and most classes moving long-distance and online by March 19, some students say they're scrambling to deal with cancelled plans and struggling to come to terms with what could have been.

Noah Fleischman, a junior at Baruch College and an Astoria resident, had mixed feelings about classes being moved online.

"I'm not thrilled. You know, I suppose, it's days off, it makes school much easier," he said, adding that he thought officials waited too long to make the decision.

In the days before Gov. Andrew Cuomo announced the move to online learning, thousands of people signed a petition to close CUNY schools. The chairperson of the University Student Senate, Timothy Hunter, released a statement calling on Cuomo to close campuses and move classes online on March 10.

A John Jay College of Criminal Justice student tested positive for the coronavirus on Tuesday, the day before the announcement, and a Brooklyn College student tested positive on Thursday.


"I do not think I can go upstate to visit my parents," Fleischman said. His family lives in an isolated area and he worries about accidentally carrying the virus with him, he said.

If classes had moved online earlier, he said, he may have made the decision to leave the city to be with his family.

A member of Baruch's student newspaper and an active participant of student life on campus, Fleischman worried what would happen to end-of-year events, including graduation. He also wondered what would happen to next year's club budgets, which are voted on by the student government at the end of the spring semester.

The student newspaper, usually printed weekly, will go strictly online for now, Fleischman said, though its members are concerned about the future.

"It was surreal yesterday," he said, after Cuomo announced

the distance-learning model. "In [our] Facebook chat, the whole paper was in shock."

Although classes will continue and students will be able to meet graduation requirements, many say they are still in the dark about commencement. Seniors, in particular, are left to lament another lost experience.

Some, like SUNY Oswego education major Venise Valcarcel, have to compartmentalize their worries and stay focused on lingering school commitments. She needs to continue her student teaching responsibilities.

"I get that there's a large number of homeless students and that makes it hard for [grade schools] to close," Valcarcel said. "I'm sad about possibly not having a graduation."

In addition to the plan to halt in-person classes, Cuomo on Thursday announced new restrictions barring gatherings of more than 500 people — an emergency measure that threatens to cancel graduation ceremonies if it continues into May and June

Mayor Bill de Blasio declared a state of emergency on the same day, predicting New York City could have 1,000 coronavirus cases by next week and that the virus and its impact could linger for the next six months.

Despite the uncertainty and disruptions, Joy Ling, a senior at Baruch and a Queens resident, said that her classes will have better discussions online and students will be more active in their learning.

Though she is sad that she will miss out on the end of her senior year, she said she is trying to reframe her expectations for her final year in school. She said she is also trying to maintain the close friendships she made throughout her time at Baruch.

"I actually think that I might be able to make closer friendships with people because it will be that much more precious when we have the chance to meet," Ling said. "It's almost like we have to think of ourselves as alumni already."

Queens **Borough** president will be an advocate and financier, not a lawmaker

The six candidates for borough president -Costa Costandinides, Elizabeth Crowley, Anthony Miranda, Jim Quinn, Donovan Richards and Dao Yin — have spent much of their campaigns discussing their lofty visions for Queens. They've spent a lot less time discussing their actual power to affect policy.

Two, Quinn and Miranda, have even called the position "ceremonial."

But ahead of the March 24 special election for Queens borough president election, the NYC Votes has worked educate voters about the real function of the office. The agency released a video explaining the responsibilities of the role Thurs-

"What can borough presidents do?" is a twoand-a-half minute video that sums up the role that one of the candidates will fill for the next nine months. Yes, just nine months — Queens residents vote again in the June primary and a third time in the November general election, meaning whoever wins the special may only remain in office until Dec. 31.

The borough president has a few nuts-andbolts responsibilities in addition to their function as an advocate and cheerleader for community

They can allocate funding to projects through their roughly \$70 million capital budget and to or-

ganizations and initiatives through a discretionary account. They appoint members of the city planning commission and Queens' local community boards. They also make advisory recommendations on land use issues.

What they can't do is pass or create laws. Each candidate has oriented their campaign on specific issues, however. And they say they can pressure state and city lawmakers to enact their goals. That's to be determined.

Costandinides has focused on a "Green New Queens" and has championed the implementation of sustainability-focused school programs, like a boroughwide rollout of the hydroponics labs installed in schools in his district and solar panels on city-owned buildings. The ability to appoint members to the city planning commision could influence the establishment

of a "Renewable Rikers" — turning the island into a clean energy powerhouse after the jails are eliminated.

Crowley has fought adamantly for better transit, touting a plan to increase rail access by 30 percent. If elected, she will be able to keep her transit vision front and center. She has urged the state to reactivate a passenger railway that travels from Long Island City to Jamaica to service transit deserts like Glendale.

Miranda, who opposes luxury development, will be able to influence the city planning commision through representative appointments. He can monitor proposed developments that come through land use planning meetings and require the borough president's advisory recommenda-

Though the borough president can recom-

mend the rejection of proposals, the applications still move forward to the city planning commission and city council regardless

Quinn has remained steadfast in his opposition to criminal justice reforms. He has vocally opposed the borough-based jails plan and has pushed for stricter policies on bail. Yet, as borough president he can at most influence the city planning commission or organize the community for town hall meetings to address concerns and raise awareness

Richards, a councilmember representing much of the Rockaway peninsula, has prioritized affordable housing. Through the capital budget, he could fund organizations that build or provide services in affordable housing. He could also establish sections ins his office to conduct outreach and support tenants facing eviction.



Contractor allegedly cheated employees out of \$1.5 million

A Queens grand jury indicted the owner of an electrical contracting company on grand larceny charges after he allegedly failed to pay prevailing wages and underpaid employees.

From 2014 through 2018, Laser Electrical Contracting Inc. and its owner, Jagdeep Deol, engaged in contracts with the New York City School Construction Authority and the New York City Department of Education to do millions of dollars of electrical work in city schools.

According to the charges, during that time period the company underpaid 11 employees, allegedly cheating them out of nearly \$1.5 million

Deol and the company also allegedly falsified and submitted hundreds of payment requisitions.

"This business owner allegedly bilked his hard-working employees out of more than \$1.5 million in wages," said Queens District Attorney Melinda Katz. "Thanks to a number of employees coming forward to report the alleged wrong-doing, the matter was investigated and 11 workers in all were allegedly cheated. The defendant will be held accountable for this alleged malfeasance."

If convicted, Deol faces up to 15 years in pris-

Upon the appeal by U. S. Bank, the appellate justices modified the judgment of the Supreme Court. First, the justices concluded that, contrary to the bank's contention, the Supreme Court was empowered to vacate the order of reference and the judgment of foreclosure and sale, on the ground of lack of jurisdiction. They agreed with the Supreme Court's determination erence and the judgment of foreclosure and sale. The justices explained that when a property owner dies intestate, the title to property is automatically vested in his or her heirs and that, against the heirs. In this case, only one heir, Sylvanie, was named as a defendant. The justices determined that the record the only heir. Additionally, the justices noted that the bank ged a default in payment of the mortgage loan after of Joseph Gedeon. Under those circumstances, the justices concluded that the estate of Joseph Gedeon was a necessary party to the mortgage foreclosure and agreed with the Supreme Court's determination to grant Sylvanie's motion to vacate the order of reference and judgment of foreclosure and sale. However, the justices found that the Supreme Court should have denied Sylvanie's motion to dismiss the complaint against her. Instead, the matter was remitted to the Supreme Court to add the administrator of the estate and for further proceedings.

CLAIMS OF FRAUD UNPROVEN IN MORTGAGE FORECLOSURE

Appellate Division, Second Department

In the Appellate Division, Second Department, defendant Michael Knott appealed an order by Hon. Cheree Buggs of Queens County Supreme Court, Civil Term. The order denied Knott's motion to vacate an order of reference and for leave to serve a late answer. In 2008, U. S. Bank National Association commenced a foreclosure proceeding against Knott, among others, to foreclose a mortgage on property in Rosedale. Knott failed to appear or answer the complaint in a timely fashion. Thereafter, the Supreme Court granted the bank's unopposed motion for an order of reference. In April 2016, Knott moved

to vacate the order of reference and for leave to serve a late answer. In response, the Supreme Court denied his motion. Upon Knott's appeal, the justices of the Second Department affirmed the determination of the lower court. They explained that a party may be relieved from an order or judgment on the ground of "fraud, misrepresentation or other misconduct" by an adverse party. In his appeal, Knott contended that U.S. Bank obtained the order of reference through the submission of fraudulent documents, which amounted to an allegation of intrinsic fraud. In their review of the record, the justices concluded that Knott failed to offer any excuse for his default in answering the complaint or his default in opposing the bank's motion for an order of reference. Additionally, the justices found that Knott failed to meet his burden of establishing fraud, misrepresentation or other misconduct on the part of the bank that would warrant vacating the order of reference. Due to that, the justices determined it was unnecessarv for them to consider whether Knott had a potentially meritorious defense to the complaint.

FORECLOSURE AND SALE VACATED

Appellate Division, Second Department

The justices of the Appellate Division, Second Department, modified an order of the Kings County Supreme Court, Civil Term, upon an appeal by the plaintiff, U. S. Bank National Association. In June 2013, U.S. Bank commenced a mortgage foreclosure proceeding on property owned by Joseph Gedeon, who had died intestate, or without a will, on Mar. 28, 2010. The complaint named as a defendant, among others, Joseph's daughter, "Sylvanie Gedeon, Individually and as Voluntary Administratrix of the Estate of Joseph E. Gedeon." In response to the complaint, Sylvanie interposed an answer but she did not oppose the bank's subsequent motions for an order of reference and for a judgment of foreclosure and sale, which the Supreme Court subsequently granted. Sylvanie thereafter moved to vacate the order of reference and the judgment of foreclosure and sale and to dismiss the complaint asserted against her for failure to join a necessary party. In the order that was appealed, the Supreme Court granted the motion.

Acting Queens BP rejects Flushing Creek rezoning in advisory role

Acting Queens Borough President Sharon Lee has rejected a land use application to rezone a piece of the Flushing Creek waterfront for residential use, a proposal that would facilitate a large mixed-use development in Downtown Flushing. Queens Community Board 7 had voted to recommend the rezoning proposal last month, despite fervent opposition from many community members.

Lee issued her advisory recommendation on March 12 as part of the city's Universal Land Use Review Procedure, or ULURP, citing the risk of displacement for long-time residents of Flushing, particularly older adults and individuals on fixed-incomes

"The scale and scope of the plan will significantly change the landscape of Downtown Flushing with long lasting impacts on the area within and surrounding the [Special Flushing Waterfront District]," Lee wrote in her recommendation. "Downtown Flushing, however, is not immune to the consequences of transformative large-scale new development that inadvertently leaves many behind, such as displacement of long-time residents and families."

Residents living closest to the site would also "bear the brunt of the noise, dust, traffic and other construction-related inconveniences," she con-

tinue

The rezoning proposal would extend a larger project championed by a trio of developers who own much of the adjacent land. The coalition, known as FWRA LLC, say they will build a mixed-use residential and commercial development as-of-right on the property around the site that they have applied to rezone, regardless of whether the city council ultimately approves the land use application for the strip along the waterfront. Because that project could be built as-of-right, there are no minimum standards for developing affordable housing units. A rezoning would mandate that the developers set-aside 20 percent of space for affordable units under the city's Mandatory Inclusionary Housing land-use policy.

Lee's decision to recommend disapproval of the application came with four conditions that FWRA and the city could address to make the project tenable, however.

Lee called on FWRA to pay "the prevailing rate of wages and supplements" to its workers; employ union labor for construction and in permanent jobs at the residential buildings, hotels and retails spaces; and build additional units of affordable housing, especially for seniors.

She also urged the School Construction Authority to build a new school in Downtown Flushing with space for a "significant portion" of the more than 3,000 seats funded in the last Depart-

ment of Education budget.

FWRA said the developers were "stunned by the unusual manner in which the interim Borough President would go against the wishes of the community" following the vote by CB7.

"This project will create jobs, stimulate the Flushing economy which is suffering and bring activity and much-needed environmental cleanup to a vacant, blighted parcel of land," FWRA said. "These factors are why there is broad range of community support from local businesses and residents, but were unfortunately overlooked by someone who is not familiar with our community. The merits of our project stand true and strong and the resolution reiterated its numerous positive benefits to Flushing throughout the recommendation. We look forward to continue working with Councilmember Peter Koo in presenting our vision for the Flushing waterfront to the City Planning Commission and City Council."

ICE continues enforcement during coronavirus outbreak

A Brooklyn politician representing one of the most diverse districts in New York City is calling on ICE to immediately stop all immigration enforcement to further prevent the spread of the novel coronavirus among officers and the immigrant community.

In a letter to ICE New York Field Office Director Thomas Decker, Councilmember Carlos Menchaca said a moratorium on enforcement would not only prevent the spread of the disease, but it would also allow immigrants to seek medical attention if necessary without fear of being apprehended.

As of Thursday afternoon, there were 95 confirmed cases of the coronavirus in New York City and 328 across the state. Mayor Bill de Blasio declared a state of emergency; Gov. Andrew Cuomo banned most gatherings of more than 500 people starting 5 p.m. Friday; and Broadway theaters were shut down.

Menchaca, who chairs the Committee on Immigration, said in his letter that a public health emergency "clearly justifies" ceasing immigrant enforcement.

"While states and localities are moving quick-

ly to contain the spread of the virus, aggressive enforcement operations by ICE proceeds as usual," Menchaca wrote. "This ultimately inhibits efforts to effectively respond and prevent more COVID-19 outbreaks, including among ICE agents themselves.

"Indeed, as 450 experts in public health, law and human rights wrote in an open letter on March 2, 2020, the government must declare all health care facilities as 'immigration enforcement-free zones.' This underscores the need to restrict immigration enforcement so that immigrants do not fear seeking treatment."

Menchaca, citing three previous emergencies — Hurricane Harvey, the northern California wildfires and the Flint water crises — when the Trump administration modified or suspended enforcement, said this pandemic warranted similar treatment.

In Brooklyn Community District 7, encompassing both Sunset Park and Windsor Terrace, more than 47 percent of residents are foreign-born, and 48 percent identify as having limited English proficiency. Seventy-three percent identified as Asian or Hispanic, according to data from the New York City Planning Department.

"We must have the foresight and courage to make such a bold and life saving decision," Menchaca concluded. "I urge you to exercise that leadership and use your power to protect the public's health and safety."

ICE did not immediately respond to a request for comment.

Courts offer chance to delay eviction and other cases over illness

Bright red warning posters set to appear at all state courts starting Friday will direct people not to enter if they have "flu-like symptoms" — and offer them a chance to delay court dates by phone.

Also eligible for a legal rain check will be anyone who recently traveled to "hot zone" countries, was exposed to infected people or "directed to quarantine, isolate or self-monitor at home for the coronavirus by any doctor, hospital or health

"If you have a scheduled appearance or were otherwise directed to attend court today, you will not be penalized for your absence," reads the flyer, which was obtained by THE CITY.

The state court system, which includes Housing Court, is also taking "a series of additional steps to limit traffic in the courts during this medical emergency," according to a Thursday memo from Chief Administrative Judge Lawrence K. Marks to court personnel.

Marks wrote that judges have been advised to adopt a lenient attitude toward postponements, and to consider using video and phone conferencing where possible.

But the courts stopped short of encouraging delays for people who are merely in a high risk category for acquiring infection — such as the elderly and those with underlying health conditions.

Eviction Risk Weighed

In Housing Court, many such people are tenants who must appear to defend themselves against eviction — the risk of which is heightened by the economic disruptions brought by coronavirus-prevention measures.

"People showed up 'cause they have to," one tenant attorney at Bronx Housing Court told THE CITY. "We work with a number of elderly people who have visible physical disabilities — walkers, canes."

Others came to the court — the city's busiest with babies and other youngsters.

On Thursday — the same day a Manhattan Family Court court worker was revealed to be infected with coronavirus — officers at the Bronx court donned blue rubber gloves.

A legal organization doing intake on the busy third floor arrived with an industrial-size container of hand sanitizer and a box of tissues.

Despite the caution on display, hearings and eviction orders — were still taking place. "It's business as usual," the tenant attorney noted.

'Do Better Than That'

Other U.S. cities, many with few confirmed COVID-19 cases, have put moratoriums on evictions because of the virus. Police in Miami an-

He sees a health-threatening double standard at work in the gears of the justice system still grinding while other institutions come to a halt. "If preventing mass gatherings is good enough for college students and everyone else, it should be good enough for low-income mostly black and brown folks," Trujillo said.

Housing Justice for All, a group that lobbied successfully for pro-tenant rent-law reforms in Albany last year, is circulating a petition demanding that state Chief Judge Janet DiFiore and Gov. Andrew Cuomo immediately "freeze rents" and halt evictions and utility shut-offs.

As of Thursday evening, the petition had more than 7,700 signatures. On the same day, State Sen. Brad Hoylman (D-Manhattan) introduced a bill that would suspend evictions and foreclosures during an emergency.

Cuomo's office did not respond to a request

our public housing," she said. "It's really hard for your body, especially if you're immune-compromised, to adequately fight disease if you're living in unsafe housing.'

In New York City, Mayor Bill de Blasio could implement a moratorium by directing the city's Department of Investigation to tell city marshals to stop executing warrants of eviction indefinitely, advocates contend, or by closing court buildings run by the city.

On Thursday, Deputy Mayor Vicki Been announced that the New York City Housing Authority had ceased most evictions.

At the same press briefing, she said "we are in discussions with the court system about what we could do" for tenants with private landlords.

'We can't wait," said Susanna Blankley, coalition coordinator at the city's Right to Counsel Coalition. "We need the New York City mayor to act. He has a lot of control over evictions.'

Landlord's Take

Jay Martin, the group's president, told THE CITY that CHIP members are "extremely sympathetic to the health concerns" and would not be affected much by a temporary stoppage of evic-

That's because the group's members — who represent about 400,000 apartments in the New York City area, 90% of which are rent-stabilized don't rely on evictions to make money.

"It's really only done in rare cases," he said. "The financial implications it would have on the buildings themselves is minimal."

But, the group advised that political leaders exercise caution on calls to freeze rents. CHIP hopes to be "part of the conversation" if state leaders are considering such a measure

"Otherwise, we're going to have bigger problems down the road once this disease starts working its way out of our collective culture," Martin said.

Court Worker Sick

Meanwhile, a legal intern who worked in Manhattan Family Court was diagnosed with the coronavirus, state officials announced Thursday.

Court officials are in the process of reaching out to all lawyers who may have come in contact with the unidentified woman, who was assigned to Parts 45 and 46 on the ninth floor, according to a message Family Court Judge Karen Lupuloff sent to lawyers.

"We will also ask those attorneys to notify their clients who appeared in court so they too can take any steps they believe are warranted," Lupu-

Denis Quirk, president of the Court Officers' Association, said about 20 of his members who came in contact with the intern and other possible coronavirus cases have been quarantined. "A lot of my people were sent home to see doctors," said Quirk.

"At this stage they are not closing the courts," he added. "You can't shut down the government."

One attorney who came in contact with the infected intern was furious court officials didn't contact him sooner.

Seth Schraier, 39, said the courtroom was first briefly closed on Monday afternoon, when "the judge said the intern was admitted to the hospital with "pneumonia."

"Nobody actually came out and said anything official," he recalled.

The courtroom reopened on Tuesday, according to Schraier.

"You'd figure they'd be at least some sort of communication system put in place," he said. "None of that happened."

He finally got a call Thursday around 6 p.m. from a court staffer telling him the intern had tested positive for coronavirus.

"Right now, I need to decide whether I'm going to show up to cases I have tomorrow," he said, "or whether I should self quarantine instead of
