Food and Beverage Vendor will:

- Provide a quality food/beverage product that is staffed by clean, professional, and courteous personnel
- Vendors must provide permit number and license for such events
- License # _____ Permit # _____
- Vendors must bring their driver's license as proof of identification
- Comply with all health and fire permits, where applicable, at own expense
- Vendorand their employees shall use every measure to protect festival site from all damages
- Vendorshall be responsible for damage caused by him or her to buildings and grounds
- Responsible for keeping food/beverage area attractive before, during and after the festival
- Responsible for collecting and reporting all North Carolina sales tax
- Ensure that grease and abrasives will not be disposed of on event property
- Ensure that food and beverage vendors will be staffed and open the entire festival, unless otherwise negotiated
- Vendor will remove all trash in immediate food area during set up and breakdown
- Trash receptacles in food area cannot be used for discarding food, grease, or other wastematerials
- No trash can be left in food area after breakdown
- Set up begins at 9:30 a.m. on Saturday May 13th, Food items MUST be available by 11:00AM
- Breakdown and removal of food/beverage vendor must be completed immediately after festival, no earlier than 4:00pm unless otherwise arranged

CANCELLATIONS

Sedgefest festival will be held, rain or shine. If a vendor chooses not to participate in the event, cancellation must be communicated by Friday April 22nd 2023. Failure to do so will result in a \$300 cancellation fee.

Food and Beverage Vendor Agreement Contract continued,

THE VENDOR FURTHER AGREES TO ABIDE BY ALL TERMS OF THE VENDOR PERMIT FOR THIS EVENT AND TO HOLD HARMLESS AND INDEMNIFY THE SEDGEFIELD NEIGHBORHOOD ASSOCIATION ANY CLAIMS ARISING BY VIRTUE OF THEIR OCCUPANCY OF VENDOR SPACE AND PARTICIPATION IN THIS EVENT.
