UDR Professional Mediation Roster

Utah Dispute Resolution (UDR) offers mediation participants the option of selecting a specific mediator from members of the organization's Professional Roster.

To qualify for UDR's Professional Roster, mediators must be Master Mediators on the Utah Court Domestic Mediation Roster, meet UDR's Professional Roster requirements, and have completed a considerable number of domestic mediations.

Mediation Fees

The fee for mediation will be assessed at a base rate of \$160 per hour, split equally between the parties, regardless of the parties' incomes.



Reduced Fee Program

UDR continues to offer mediation at reduced fees for clients with financial need. To be considered in this program, clients must complete an income declaration, qualify for reduced fees based on UDR's sliding scale, and accept the mediator who is randomly assigned from UDR's Pro Bono and Practicum Mediation Rosters. To be considered for reduced fees, clients may not select their mediators.

Background and Philosophy

UDR is one of the longest-running mediation providers in Utah. Established in 1991, the organization has been providing mediation services and training for twenty years.

UDR mediators practice a facilitative model of mediation that honors the self-determination of parties in making decisions that they can support. The mediator assumes the role of an impartial third party to the dispute, who helps the disputants voice their needs and interests, overcome communication barriers, identify options for resolution, and assess their alternatives.

Scheduling Mediation

To initiate mediation, contact UDR to speak with a case manager. Clients must complete and submit an intake questionnaire to UDR before a mediation date can be scheduled.


