Vital Community Development Progams Fully Funded

On behalf of the Town of Chesterfield. Hilltown CDC will administer a grant from the US Department of Housing and Urban Development (HUD) to continue our most popular community development programs. This competitive funding is made available each year through a federal program known as Community Development Block Grants (CDBG). Passed by Congress under President Ford in 1975, the program's purpose is to redistribute influence from the federal bureaucracies to local governments. Communities across the nation have used the funding to improve public infrastructure, build and rehabilitate housing stock, support economic development initiatives, and fund public services.

Since 1987 Hilltown CDC has administered CDBG funds on behalf

of several local towns for projects to improve the accessibility of public facilities, plan and build affordable housing units, construct a town public safety complex, run a small busines loan proram, support our local Hilltown food pantry, and provide in-home medical and chore services to seniors. This year's funding will support the Housing Rehab Program, Hilltown Elder Network (HEN), Health Outreach Program for Elders (HOPE), the Goshen Food Pantry, and Childcare Subsidies for residents in seven towns: Chesterfield. Cummington, Goshen, Peru, Plainfield, Williamsburg, and Worthington.

Paula Bilodeau has led our Housing Rehab program for the past six years, adminstering 98 zero-interest, deferred, forgivable loans to local homeowners to make necessary repairs to

their houses in that time. "Increasing the number of code-compliant homes in our region is a key component to ensure resident safety, improve energy efficiency, and contribute positively to local economic development," says Paula. "From leaky roofs, failed septic systems, no water, no heat, and toxic exposure to lead or asbestos, this one program can make all the difference in

From the Executive Director



Greetings Hilltown Neighbors!

As summer turns to fall, we are feeling grateful for all the people in our communities who work so hard to enhance our quality of life here in the Hilltowns. We are committed to supporting this work and developing creative partnerships

that benefit our rural families, businesses and towns.

Recently, on behalf of the Town of Chesterfield, we were awarded a Community Development Block Grant (CDBG), a federal grant that will fund our housing rehabilitation program and provide vital social services to Hilltown residents in seven towns: Chesterfield, Cummington, Goshen, Peru, Plainfield, Williamsburg and Worthington.

My view of this work includes a strategy to get our money back to our community from the government. We have all paid our taxes and our hard-earned income should come back to us in the form of government investments. That is what the CDC does when we apply for funding for the region. We have applied for CDBG funds for the Hilltown region for over 25 years. As a result, we have secured over \$25 million in federal funds for our community. This has resulted in over 700 homes being rehabilitated, including repaired wells, septic systems and lead removal. It also has allowed us to develop a social service safety net for underserved Hilltown residents.

Rural America has suffered from years of disinvestment and we are not immune to this in the Hilltowns. Our sparse populations do not offer much of a profit motive to the business community and our government doesn't pressure public utilities enough to invest in rural technology or infrastructure. Our goal is to continue to compete for resources on behalf of Hilltown residents and to help government better understand our rural economic conditions. We will continue to advocate for ways to return money to our region and to invest in the preservation of our rural communities and lifestyle.

I also want to recognize the staff at the CDC without whom we could not leverage these vital funds. Our CDBG administrator is Bea von Hagke. Bea coordinates the annual submission of CDBG proposals on behalf of the region. She may be the best in the state at what she does.

Our Housing staff includes rehab manager Paula Bilodeau, housing specialist Doug Desmarais, social services manager Charlie Hayes, and all our caregivers who provide services to Hilltown seniors. These employees are all the best at what they do.

We are so lucky to have a strong team and honored to have the opportunity to advocate on behalf of the Hilltowns at the local, state, and federal level. As always, we welcome your ideas and look to you to guide our advocacy work and direct our staff and financial resources. Our Hilltowns wouldn't be so vibrant without each and every one of you.

Also funded in this year's CDBG grant are our social services programs, administered for the last 24 years by Charlie Hayes. One of these is the Hilltown Elder Network, better known as HEN, which provides a variety of in-home chore services to nearly 100 elder households, allowing eligible seniors continued independent living and safety in their own homes for longer than might otherwise be possible. "Keeping our elders here in the communities where many have lived for decades enriches the whole fabric of the Hilltowns," says Charlie. "By tapping into the strong network of neighbors working to help neighbors, we create more connected and caring communities".

Hilltown Community Development is committed to supporting progressive programs that respond to the changing needs of our communities and seek creative solutions. We help ensure that federal funding is directed towards those who need it most in ways that uplift all who live here in our rural community.

Commission releases first MA Rural Policy Plan

Hilltown Mobile Market a success!



The Massachusetts Rural Policy Advisory Commission has released its first comprehensive Rural Policy Plan to guide legislators in developing robust policies that champion the state's most rural communities in Berkshire, Franklin, Hampshire, Hampden, Worcester, and Barnstable Counties. The Plan is intended to guide legislation and statewide policy to help enhance the economic, social and environemntal vitality of rural Massachusetts. It was developed over the course of the past year through statewide meetings with hundreds of rural

local Hilltown families, including 12 HIP-reimbursable shares for those eligible for SNAP (food stamps). The Hilltown Easy Ride is a rural transportation program offered in partnership with the Franklin Regional Transportation Authority Demand Response service. Seniors 60+ and veterans in Chesterfield, Cummington, Goshen, Plainfield and Worthington who pre-register can book rides on the bus by calling Ed, our dispatcher, at least 48 hours in advance at 413-296-4232.
