#2 — RELEASE AND WAIVER OF LIABILITY AGREEMENT

WHEREAS, French Federation of Double Dutch (FFDD) and the International Jump Rope Union ("IJRU") is the owner/operator/sponsor of the Paris 2024 Jump Rope Engagement (the "**Activity**") and is willing to permit the individual (the "**Participant**", "**I**", "**me**", or "**myself**") signing this Agreement to participate in the Activity, upon the terms and conditions of this Agreement. IJRU and Participant may be collectively referred to as the "parties".

In consideration for being provided the ability to participate in the Activity, each person signing below hereby stipulates and agrees:

Assumption of Risk. I understand and acknowledge that the Activity I want to participate in may be dangerous and may involve the risk that I will sustain serious injury, temporary or permanent disability, death, and/or property damage. For any Activity that is a virtual competition that involves my submission of an audiovisual recording of my performance for judging ("**Virtual Activity**"), I understand that the Virtual Activity may not be supervised. For any Activity that I attend in person ("**In-Person Activity**"), I understand that I may use the premises where the In-Person Activity is taking place ("**Premises**") to participate in the In-Person Activity and for no other purpose. I further acknowledge and agree that IJRU does not provide medical services and is not responsible for contacting any medical service provider in connection with any Activity. I VOLUNTARILY AND FREELY ASSUME ALL RISKS AND DANGERS THAT MAY OCCUR PURSUANT TO MY PARTICIPATION IN THE ACTIVITY, BE IT A VIRTUAL ACTIVITY OR IN-PERSON ACTIVITY, INCLUDING THE RISK OF INJURY, DEATH, OR PROPERTY DAMAGE, EVEN IF CAUSED BY NEGLIGENCE OF IJRU.

Release from Liability. I hereby agree, on behalf of myself, my heirs and my personal representatives, to fully and forever discharge and release IJRU and its affiliates, and their respective partners, agents, operators, managers, employees, and representatives ("**Released Parties**") from any and all claims I may have or hereinafter have for any injury, temporary or permanent disability, death, damages, liabilities, expenses and/or causes of action, now known or hereinafter known in any jurisdiction in the world, attributable or relating in any manner to my use of the Premises (if applicable) and my participation in the Activity, whether caused by the negligence of IJRU or any of the Released Parties or by any other reason. I acknowledge and agree that this Release and Waiver of Liability is intended to be, and is, a complete release and waiver, as much as allowed by law, of any responsibility of the Released Parties for all personal injuries, temporary or permanent disability, death, and/or property damage sustained by me while using the Premises and/or participating in the Activity.

Covenant Not to Sue. I agree, for myself and all my heirs, not to sue the Released Parties or initiate or assist in the prosecution of any claim for damages or cause of action against the Released Parties which I or my heirs may have as a result of any personal injury, death or property damage I may sustain while using of the Premises (if applicable) and participating in the Activity.

Indemnification. I hereby agree to defend, indemnify and hold harmless FFDD and IJRU and the Released Parties from and against any third-party losses, damages, actions, suits, claims, judgments, settlements, awards, interest, penalties, expenses (including reasonable attorneys' fees) and costs of any kind for any personal injury, loss of life or damage to property sustained by reason of or arising out of my use of the Premises and/or participation in the Activity.

Medical Treatment Release. I hereby authorize FFDD and IJRU to secure, and I consent to, any medical treatment that may be given to me should IJRU determine, in its sole discretion, that I need medical care, as a result of my being on the Premises and/or from participating in the Activity. I accept full responsibility for all costs related to my medical treatment, including any transport costs, and I release all parties involved from any type of liability for anything that may happen during my treatment or transport.

Responsibility for Personal Property. I acknowledge and agree that I am fully and solely responsible for any of my property and personal belongings that I bring onto the Premises and/or that I use during the Activity, and that FFDD nor IJRU will not be responsible for or provide any security for my property and personal belongings.

No Representations by FFDD nor IJRU. I acknowledge that FFDD nor IJRU makes no representation as to the safety of the Activity, the condition of the Premises or any equipment in the Premises or used in the Activity. I accept and shall use the Premises and/or any equipment, in its "AS IS" condition. I acknowledge and agree that I am not

relying upon any representation or statement by IJRU or IJRU's employees, agents, sponsors, or representatives regarding this agreement, the Premises, or the Activity, except to the extent such representations are expressly set forth in this agreement.

Governing Law and Venue. This Release and Waiver of Liability agreement will be governed by and interpreted in accordance with the laws of the State of Ohio, United States of America, without giving effect to the principles of conflicts of law of such state. I agree that any action arising out of this Release and Waiver of Liability agreement must be brought exclusively in any state or federal court located in Montgomery County, Ohio.

Waiver. No waiver of any term or right in this Release and Waiver of Liability agreement shall be effective unless in writing, signed by an authorized representative of the waiving party. The failure of any party to enforce any provision of this agreement shall not be construed as a waiver or modification of such provision, or impairment of its right to enforce such provision or any other provision of this agreement thereafter.

Severability. If any provision or portion of this Release and Waiver of Liability agreement shall be held by a court of competent jurisdiction to be illegal, invalid, or unenforceable, the remaining provisions or portions shall remain in full force and effect.

Entire Agreement; Modification; Binding Effect. This Agreement is the entire agreement between the parties with respect to the subject matter hereof and supersedes any prior agreement or communications between the parties, whether written, oral, electronic, or otherwise. No change, modification, amendment, or addition of or to this agreement shall be valid unless in writing and signed by authorized representatives of the parties. This agreement shall be binding upon and inure to the benefit of the successors, assigns, and legal representatives of the parties.

I HEREBY ACKNOWLEDGE THAT I HAVE FULLY READ AND UNDERSTAND EACH OF THE ABOVE PROVISIONS AND THAT I UNDERSTAND I AM GIVING UP SIGNIFICANT LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE IJRU. I ACKNOWLEDGE THAT PRIOR TO SIGNING THIS AGREEMENT I HAD THE OPPORTUNITY TO CONSULT WITH AN ATTORNEY TO REVIEW THIS AGREEMENT. I EXECUTE THIS AGREEMENT VOLUNTARILY AND FOR ADEQUATE CONSIDERATION INTENDING TO BE FULLY BOUND.

#3 — VIDEO AND INTERVIEW RELEASE

In consideration of the French Federation of Double Dutch (FFDD) and International Jump Rope Union ("**IJRU**") allowing me to participate in the Paris 2024 Jump Rope Engagement

("Activity") I, _____, the releasing party, as of the date I sign this Video and Interview Release (the "**Effective Date**"), hereby grant to FFDD and IJRU and IJRU's successors, licensees and assigns, subject to the terms hereof, the irrevocable right and license to film, tape and/or photograph or otherwise record me, and to edit, exhibit, reproduce, and otherwise use my image, performance, voice, conversation, sounds and/or physical likeness, as well as my personal information, including but not limited to my name, biographical information, statistics related to my athletic performance, height, weight, and other personal information (individually and collectively, my "**Likeness**"), in whole or in part, and on a perpetual and worldwide basis in connection with the Production. "**Production**" means FFDD and IJRU's production, display, broadcast, distribution, advertising, and other exploitation of the Activity, as well FFDD and IJRU's production, display, broadcast, distribution, advertising, and other exploitation of any interview conducted with me concerning my participation in the Activity.

I agree that all rights in the video(s), recording(s) and/or picture(s) taken of me by me, FFDD and IJRU, or on behalf of FFDD and IJRU, in connection with the Activity (the "**Materials**"), including all copyrights therein, shall be the sole and exclusive property of IJRU upon creation as a work-made-for-hire (as such term is commonly understood pursuant to the U.S. Copyright Act (17 U.S.C. § 101 et seq.)). As such, and subject to the terms hereof, IJRU will have the exclusive right to use, and license or otherwise authorize others to use, the Materials, in any manner IJRU wishes and in any and all media now known or hereafter discovered or developed, in perpetuity and throughout the universe. In the event that any part of the Materials is found not to be a work-made-for-hire, then I agree to, and do hereby, assign and transfer all right, title, and interest in and to the Materials to IJRU for good and valuable consideration, the receipt of which I hereby acknowledge. To the maximum extent allowable under applicable law, I hereby waives the exercise of any "moral rights", or "droit moral", and any analogous rights however denominated now or hereafter recognized, that I may have related to the Materials. Notwithstanding the foregoing, I shall, at all times, retain any and all ownership (and other intellectual property) rights in and to: (1) my name, biographical material, voice, and any and all other pre-existing personal information of any kind; and (2) photographs, images, sound recordings, videos, and/or other works of authorship not taken by me, FFDD and IJRU, or on behalf of FFDD or IJRU, specifically in connection with the Activity ("**Participant Materials**").

If the Materials I submit contain any photographs, images, sound records, videos, and or other works of authorship covered by intellectual property owned by a third party ("**Third Party Materials**"), I agree to obtain sufficient rights from such third parties to allow IJRU to make full use of such Third Party Materials pursuant to the terms of this Video and Interview Release.

To the extent that any and all Participant Materials or Third Party Materials are incorporated into the Materials, I hereby grant to FFDD and IJRU, and any FFDD and IJRU affiliates and services providers, the perpetual right to exploit any and all such Participant Materials or Third Party Materials in any manner IJRU wishes, and in any and all media now known or hereafter discovered or developed, in perpetuity and throughout the universe.

For any Activity that is a virtual competition where I am required to submit an audiovisual recording of my performance ("**Virtual Activity**"), I acknowledge and agree that duplicating, distributing, or displaying any Materials associated with the Virtual Activity prior to completion of the judging process may result in sanctions from the IJRU.

I acknowledge and agree that with respect to the Materials, my Likeness, the Activity and any recordings or other reproductions thereof, IJRU shall have the right to create unlimited versions of varying lengths and in various languages, as well as the right to create an unrestricted number of edits, cut-downs, versions, variations, lifts, revisions and derivatives thereof, regardless of whether or not I am recognizable, in any and all media now known or hereafter devised, worldwide in perpetuity, and throughout the universe .

I understand and agree not to use or authorize use of the Materials for the purpose of trade without the consent of FFDD and IJRU or the Released Parties, which consent shall not be unreasonably withheld. I agree not to use for the purpose of trade, the medals, trophies or photos, portraits, or films of myself with any medals and/or trophies which I receive for my performance in the Activity.

I acknowledge and agree that any Contributions are non-confidential and non-proprietary in nature. I hereby grant to IJRU and their respective licensees, successors and assigns, a perpetual, irrevocable, fully transferable, fully sublicensable right and license to use, reproduce, modify, perform, display, distribute and otherwise disclose any Contributions for any purpose whatsoever.

I acknowledge and agree that I may have access to Confidential Information of IJRU. "Confidential Information" means and any all information provided to me in connection with the Activity, including without limitation any personal information associated with FFDDs or IJRU's employees, agents, or contractors, or any personal information associated with fellow participants in the Activity, business information, videos, photos, scores, data, and the terms of this Video and Interview Release. Confidential Information shall not include: (1) information previously known and/or publicly disseminated prior to the Effective Date; (2) information independently discoverable without breach of any duty hereunder or otherwise; and/or (3) information required to be disclosed by law and/or pursuant to a subpoena or other similar discovery request. I acknowledge and agree that I will only use the Confidential Information for the purpose it was provided and that any disclosure of such Confidential Information by me shall constitute a material breach of this release and shall cause IJRU irreparable injury. I further agree that in the event of any improper disclosure by me, I shall be liable to IJRU, and I agree that IJRU shall have the right to utilize all available remedies under the law, including both financial and injunctive relief, to seek retribution for any such breach.

Nothing herein will constitute any obligation on IJRU to make any use of any of the rights set forth herein.

I hereby irrevocably and unconditionally release, waive and forever discharge FFDD and IJRU and its past, present and future parents, subsidiaries (whether or not wholly-owned), affiliates, divisions, agents, representatives, employees, successors and assigns, jointly and individually (hereinafter collectively referred to as "Releasees"), from any and all manner of liabilities, claims and demands of any kind or nature, whatsoever, in law or equity, whether known or unknown, which I (or my assigns, agents and/or representatives) ever had, now have, or in the future may have, against the Releasees, including, but not limited to, claims arising out of or related to IJRU's authorized exploitation of its rights hereunder, including without limitation, claims in the nature of copyright infringement, defamation, disparagement, slander, false light, violation of the right of privacy or publicity, or the like.

I represent and warrant that: (1) all information I am, and will be, providing to FFDD and IJRU in connection with this Video and Interview Release and/or my participation in the Activity is valid, true and accurate; (2) any statement made by me during my participation in the Activity or any related interviews will not violate or infringe upon any third party's rights; and (3) I am not a party to any agreement that would in any way hinder my ability to provide the consents and grant of rights contained herein.

I agree not to enjoin FFDD nor IJRU's exploitation of the Materials, Contributions and/or the Production in general, and in the event of any breach hereunder by FFDD or IJRU, I shall be restricted to an action at law for monetary damages.

This release sets forth the entire agreement of the parties with respect to the subject matter hereof and supersedes any and all prior or contemporaneous communications, representations, discussions, negotiations, understandings, and/or agreements relating to the subject matter, whether oral, written, electronic, or otherwise. This release may not be modified except by an instrument in writing signed by both parties. If any provision of this release is determined to be invalid by a court of competent jurisdiction, such determination shall in no way affect the validity or enforceability of any other provision herein.

I certify that I have read this consent and release, fully understand its contents and intend to be legally bound to it. This release shall be governed by the laws of the State of Ohio, without regard to its conflict of laws principles.
