



**HUNTING AGREEMENT**

This agreement shall commence upon the date of written confirmation by CORLISS OUTFITTING and shall continue in force until the conclusion of the hunt. HUNTER shall reserve the right to cancel this AGREEMENT in writing, at any time. CORLISS OUTFITTING may cancel this AGREEMENT at any time as the result of the HUNTERS failure to abide by the rules and regulations of CORLISS OUTFITTING and NM Game and Fish. In the event of the HUNTER being unable to make the HUNT, as the result of a personal emergency, then the HUNTER shall have the option to reschedule at a convenient time for both parties. **ALL DEPOSITS AND PAYMENTS ARE NON-REFUNDABLE, EXCEPT AT THE SOLE DISCRETION OF CORLISS OUTFITTING.** All hunts are subject to NM State tax (6.375%). A 50% deposit is required to book all landowner tags and private land tags. A 50% deposit is required when you draw a tag. All deposits are non-refundable. Final payments are due 30 days prior to the start of the hunt. Please make all deposits, license fees, and final payments payable to CORLISS OUTFITTING. Corliss Outfitting enforces a wounded animal policy that states; If a hunter wounds an animal they must work to retrieve that animal for no less than 24 hours. If the hunter does not recover that animal and wishes to continue to hunt a fee of 50% of the hunt cost will be charged.

HUNTER understands and agrees that HUNTER, at HUNTER'S sole expense, shall be responsible for obtaining and paying for all necessary game licenses and permits. Hunters shall provide their own transportation to and from the hunt. Corliss Outfitting reserves the right to end any hunt due to the hunter mortally wounding an animal. This will be at the sole discretion of the guide.

HUNTER warrants and represents to CORLISS OUTFITTING that HUNTER possesses the hunting skill and physical condition to participate in the HUNT in rugged mountain terrain at altitudes at or above 6500 feet. HUNTER further acknowledges that the remoteness and location of the HUNT significantly limits the availability of trained medical care or facilities. CORLISS OUTFITTING has no responsibility to provide anything more than the simplest form of first aid. Due to the remoteness of the hunting area, HUNTER acknowledges that it could take several hours for HUNTER to obtain medical services or facilities. HUNTER agrees and warrants that HUNTER shall take full responsibility for providing and taking all prescribed medications.

HUNTER understands and agrees the CORLISS OUTFITTING has no responsibility for or control over the weather, game availability, or the physical conditions that may be encountered during the term of this AGREEMENT. CORLISS OUTFITTING agrees to use CORLISS OUTFITTING reasonable efforts and knowledge, in light of the conditions, to make the HUNT a memorable and enjoyable experience. CORLISS OUTFITTING will provide professional guides (1 on 1 or 2 on 1 depending on the hunt). Meals, lodging, and transportation during the hunt and field care of the trophy are included. CORLISS OUTFITTING reserves all rights to any photos or video that is taken during the hunt.

By the execution of this AGREEMENT, HUNTER warrants and acknowledges that the activities contemplated herein involve substantial risk and danger of injury to HUNTER, HUNTER'S property and to others. The HUNTER hereby assumes all responsibility, risk and liability for bodily injury, death and loss of personal property of HUNTER. Including any and all expenses any way connected with the performance and operations to be carried out under the terms of this AGREEMENT. **HUNTER COVENANTS THAT HE OF SHE HAS FULLY READ AND UNDERSTANDS THE TERMS AND CONDITIONS OF THIS AGREEMENT.**
