Eligibility

The Ultimate Italian Getaway (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of The Table Less Traveled LLC and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

Sponsor

Agreement to Official Rules

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Contest Period

The Contest begins on August 2, 2023 at 12:00 PM Pacific Time and ends on August 12, 2023 at 5:00 PM Pacific Time (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest through The Table Less Traveled website only.

Sponsor reserves the right to cancel the Contest at any point and for any reason.

How to Enter

Online: This method of entry will be available by visiting our website (www.thetablelesstraveled.com) and following the directions provided to fill out the entry information, and submit.

Limit one (1) entry per person, per email address for the duration of the Contest Period, regardless of method of entry. Entries received from any person or e-mail address in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

Prize Drawing

On or about August 14, 2023, the Sponsor will select potential winners. The selection process is not random and will be based at the sole discretion of the Sponsor. The Sponsor will attempt to notify the potential winner via telephone or email on or about August 15, 2023. If the potential winner cannot be contacted for whatever reason, the Sponsor may select an alternate potential winner from the remaining non-winning, eligible entries.

Winner Notification

The potential winners will be notified by email or phone. Each potential winner will be required to complete, electronically sign and submit a Declaration of Compliance in order to claim the prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period specified by Sponsor the potential winner forfeits the prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration of Compliance on the potential winners' behalf and fulfill any other requirements imposed on winner set forth herein. The Sponsor reserves the right in its sole discretion to disqualify any individual. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

Release and Limitations of Liability

By participating in the Contest, entrants agree to release and hold harmless the Sponsor, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Contest, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Contest, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Contest; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) application downloads, (e) any other errors or problems in connection with the Contest, including, without limitation, errors that may occur in the administration of the Contest, the announcement of the winner, the cancellation or postponement of the event and/or the flyover, if applicable, the incorrect downloading of the application, the processing of entries application downloads or in any Contest-related materials; (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Contest or acceptance, receipt or misuse of the prize (including any travel or activity related thereto), or (g) any personal tax liability associated with the Contest.
